SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We performed audits of the accompanying financial statements of the Breakthru Beverage Group 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

NOTE 1 DESCRIPTION OF PLAN

The following brief description of the Breakthru Beverage Group 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

General

The Plan was established on November 10, 1988 for eligible employees, as defined in the Plan, of the affiliated companies of Sunbelt Holding Inc., the parent company of Sunbelt Beverage Company, LLC, d/b/a Breakthru Beverage Group, LLC (Plan Sponsor). The Plan was formerly known as the Sunbelt Beverage Company, LLC Profit Sharing Plan. Effective December 31, 2017, the Alliance Beverage Distributing Co., LLC 401(k) Plan, Breakthru Wirtz, LLC 401(k) Profit Sharing Plan, and Breakthru Beverage Illinois Belleville, LLC 401(k) Profit Sharing Plan were merged into the Plan.

Effective January 1, 2021, the Plan was restated to be under unified provisions. As part of the restatement, the employees of Breakthru Beverage Illinois Belleville, LLC ceased participation in this Plan. The assets of these employees were transferred to a newly established plan.

Effective in December 2023, the Bacchus Importers, LLC Employees' 401(k) Profit Sharing Plan, and Major Brands, Inc. Employees' 401(k) Plan were merged into the Plan. Assets from this merger arrived in December 2023 and January 2024.

Effective in December 2024, the Breakthru Beverage California 401(k) Plan was merged into the Plan. Some assets from this merger arrived in the Plan on December 31, 2024, and the remainder are reflected as receivables in these financial statements.

Eligibility and Participation

Eligible employees include all employees who are at least 21 years old and who are expected to earn 1,000 hours of service in a 12-month period, excluding employees under collective bargaining agreements that do not provide for coverage under the Plan, a leased or contracted associate, or a non-resident alien. Eligible employees enter the Plan on their date of hire.

Contributions

Each year, participants may contribute up to 100% of their pre-tax annual compensation, as defined in the Plan. Participants who turn 50 years old before the end of the Plan year are eligible to make catch-up contributions.

(See Independent Auditors' Report)

The Plan Sponsor, at its discretion, may make matching and non-elective employer contributions. There are specific matching and elective contribution provisions for union employees of a certain affiliate.

Participant Accounts

An individual account is established for each participant and provides benefits that are based on (a) amounts the participant and Plan Sponsor contributed to a participant's account, (b) investment earnings (losses), and (c) any forfeiture allocated to the account, less any administrative expenses charged to the Plan. Investment income is allocated to each participant's account based on a pro rata share of the participant's investment allocation. Terminated participants, who are not fully vested, forfeit the non-vested portion of the Plan Sponsor's contributions made to their accounts and any investment earnings on those contributions.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the remainder of their accounts is based on years of service. For Plan years after December 31, 2020, participants become fully vested after three years of service for matching contribution, non-elective contributions, and any earnings thereon.

Forfeited Accounts

Forfeited non-vested accounts totaled approximately \$11,000 and \$43,000 as of December 31, 2024 and 2023, respectively. These accounts will be used in accordance with the Plan Agreement.

Investment Options

Plan assets are invested in plan offerings as designated by participants.

Notes Receivable From Participants

Loans to participants are made at the sole discretion of the Plan Sponsor. As provided by the Plan Agreement, loans are available to all participants at a reasonable interest rate, with periodic repayment through payroll deductions over a reasonable period of time. Loans must be at least \$1,000 and are limited to the lesser of \$50,000 or 50% of the participant's vested account balance.

Payment of Benefits

Generally, benefits are payable upon termination, death, turning 59½ years old, or earlier in the case of financial hardship, as defined by the Plan. Benefits are paid in a lump sum within 60 days after the end of the Plan year in which the benefit becomes payable. Benefits from

the Plan for terminated participants whose vested account balance is \$1,000 or less and who do not make payment elections shall be payable in a lump sum. Benefits from the Plan for terminated participants whose vested account balance is greater than \$1,000 but not more than \$5,000 and who do not make payment elections shall be rolled over to an individual retirement account designated by the Plan Administrator.

NOTE 2 **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Accounting Standards Codification

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Risk and Uncertainties

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Certain Plan expenses are paid by the Plan Sponsor.

Valuation of Investments

Investments are stated at fair value. See Note 4 for a discussion of fair value measurements.

(See Independent Auditors' Report)

Notes Receivable From Participants

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Agreement.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor can terminate the Plan at any time. Upon termination of the Plan, all interests of the participants not previously vested would become vested and nonforfeitable and the net assets available for benefits would be distributed to participants based upon their individual share of total net assets available for benefits.

Subsequent Events

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 13, 2025, the date the financial statements were available to be issued.

NOTE 3 INFORMATION CERTIFIED BY THE TRUSTEE

The Plan's investments were held by the Trustee, Fidelity Management Trust Company, at December 31, 2024 and 2023. Financial information related to Plan investments is included in the accompanying financial statements based on information certified as complete and accurate by the Trustee. That information, which was not audited by independent auditors, is summarized below:

NOTE 4 VALUATION OF INVESTMENTS

The Fair Value Measurements and Disclosures Topic of the Codification establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below are descriptions of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

Money Market and Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

Collective Trusts and Pooled Separate Account: Valued using NAV per unit. NAV is based on the value of the underlying investments owned by each fund, minus its liabilities, and then divided by the number of units outstanding. Participant-initiated transactions may occur daily at NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 TAX STATUS

The Plan obtained its latest determination letter in which the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been restated and amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of December 31, 2024.

NOTE 6 **RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions. The Plan pays investment management, administrative, and recordkeeping fees to parties in interest. The Plan paid approximately \$788,000 to parties in interest for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

In addition, administrative fees were paid indirectly through revenue sharing and are included in the net appreciation in fair value of investments.

SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We performed audits of the accompanying financial statements of the Breakthru Beverage Group 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTE 1 DESCRIPTION OF PLAN

The following brief description of the Breakthru Beverage Group 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

General

The Plan was established on November 10, 1988 for eligible employees, as defined in the Plan, of the affiliated companies of Sunbelt Holding Inc., the parent company of Sunbelt Beverage Company, LLC, d/b/a Breakthru Beverage Group, LLC (Plan Sponsor). The Plan was formerly known as the Sunbelt Beverage Company, LLC Profit Sharing Plan. Effective December 31, 2017, the Alliance Beverage Distributing Co., LLC 401(k) Plan, Breakthru Wirtz, LLC 401(k) Profit Sharing Plan, and Breakthru Beverage Illinois Belleville, LLC 401(k) Profit Sharing Plan were merged into the Plan.

Effective January 1, 2021, the Plan was restated to be under unified provisions. As part of the restatement, the employees of Breakthru Beverage Illinois Belleville, LLC ceased participation in this Plan. The assets of these employees were transferred to a newly established plan.

Effective in December 2023, the Bacchus Importers, LLC Employees' 401(k) Profit Sharing Plan, and Major Brands, Inc. Employees' 401(k) Plan were merged into the Plan. Assets from this merger arrived in December 2023 and January 2024.

Effective in December 2024, the Breakthru Beverage California 401(k) Plan was merged into the Plan. Some assets from this merger arrived in the Plan on December 31, 2024, and the remainder are reflected as receivables in these financial statements.

Eligibility and Participation

Eligible employees include all employees who are at least 21 years old and who are expected to earn 1,000 hours of service in a 12-month period, excluding employees under collective bargaining agreements that do not provide for coverage under the Plan, a leased or contracted associate, or a non-resident alien. Eligible employees enter the Plan on their date of hire.

Contributions

Each year, participants may contribute up to 100% of their pre-tax annual compensation, as defined in the Plan. Participants who turn 50 years old before the end of the Plan year are eligible to make catch-up contributions.

(See Independent Auditors' Report)

The Plan Sponsor, at its discretion, may make matching and non-elective employer contributions. There are specific matching and elective contribution provisions for union employees of a certain affiliate.

Participant Accounts

An individual account is established for each participant and provides benefits that are based on (a) amounts the participant and Plan Sponsor contributed to a participant's account, (b) investment earnings (losses), and (c) any forfeiture allocated to the account, less any administrative expenses charged to the Plan. Investment income is allocated to each participant's account based on a pro rata share of the participant's investment allocation. Terminated participants, who are not fully vested, forfeit the non-vested portion of the Plan Sponsor's contributions made to their accounts and any investment earnings on those contributions.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the remainder of their accounts is based on years of service. For Plan years after December 31, 2020, participants become fully vested after three years of service for matching contribution, non-elective contributions, and any earnings thereon.

Forfeited Accounts

Forfeited non-vested accounts totaled approximately \$11,000 and \$43,000 as of December 31, 2024 and 2023, respectively. These accounts will be used in accordance with the Plan Agreement.

Investment Options

Plan assets are invested in plan offerings as designated by participants.

Notes Receivable From Participants

Loans to participants are made at the sole discretion of the Plan Sponsor. As provided by the Plan Agreement, loans are available to all participants at a reasonable interest rate, with periodic repayment through payroll deductions over a reasonable period of time. Loans must be at least \$1,000 and are limited to the lesser of \$50,000 or 50% of the participant's vested account balance.

Payment of Benefits

Generally, benefits are payable upon termination, death, turning 59½ years old, or earlier in the case of financial hardship, as defined by the Plan. Benefits are paid in a lump sum within 60 days after the end of the Plan year in which the benefit becomes payable. Benefits from

the Plan for terminated participants whose vested account balance is \$1,000 or less and who do not make payment elections shall be payable in a lump sum. Benefits from the Plan for terminated participants whose vested account balance is greater than \$1,000 but not more than \$5,000 and who do not make payment elections shall be rolled over to an individual retirement account designated by the Plan Administrator.

NOTE 2 **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Accounting Standards Codification

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Risk and Uncertainties

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Certain Plan expenses are paid by the Plan Sponsor.

Valuation of Investments

Investments are stated at fair value. See Note 4 for a discussion of fair value measurements.

Notes Receivable From Participants

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Agreement.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor can terminate the Plan at any time. Upon termination of the Plan, all interests of the participants not previously vested would become vested and nonforfeitable and the net assets available for benefits would be distributed to participants based upon their individual share of total net assets available for benefits.

Subsequent Events

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 13, 2025, the date the financial statements were available to be issued.

NOTE 3 INFORMATION CERTIFIED BY THE TRUSTEE

The Plan's investments were held by the Trustee, Fidelity Management Trust Company, at December 31, 2024 and 2023. Financial information related to Plan investments is included in the accompanying financial statements based on information certified as complete and accurate by the Trustee. Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below are descriptions of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

Money Market and Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

Collective Trusts and Pooled Separate Account: Valued using NAV per unit. NAV is based on the value of the underlying investments owned by each fund, minus its liabilities, and then divided by the number of units outstanding. Participant-initiated transactions may occur daily at NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 TAX STATUS

The Plan obtained its latest determination letter in which the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been restated and amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of December 31, 2024.

NOTE 6 **RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions. The Plan pays investment management, administrative, and recordkeeping fees to parties in interest. The Plan paid approximately \$788,000 to parties in interest for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

In addition, administrative fees were paid indirectly through revenue sharing and are included in the net appreciation in fair value of investments.
