## Independent Auditor's Report

Ancora MEP 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of Ancora MEP 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### ***Opinion***

### ***Basis for Opinion***

#### Note 1. Description of Plan

The following description of the Ancora MEP 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General:** The Plan is a defined contribution 401(k) plan sponsored and administered by Ancora Holdings Group, LLC (the “Plan Administrator”). The Plan operates as a multiple-employer plan (“MEP”) under ERISA, permitting other adopting employers to participate. Ancora Holdings Group, LLC serves as the lead employer of the MEP, and also includes members of Terza Partners LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan’s Investment Review Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

**Plan Year:** The Plan year is the 12-month period beginning January 1 and ending December 31.

**Eligibility and Entry:** Each employee, with the exception of excluded employees as defined in the Plan summary, are eligible to participate upon attainment of age 21 and completion of three months of service. Entry is the first day of the month coinciding with or next following the date you satisfy the eligibility requirements. Long-Term Part-Time (LTPT) employees who complete at least 500 hours of service in three consecutive years beginning after December 31, 2020, and have attained the Plan’s eligibility age, may make salary deferrals; LTPT participants are credited with a Year of Service for each year with more than 500 hours of service.

**Contributions:** Participants may contribute to the Plan each year up to the maximum percentage of their compensation allowable on a pre-tax and post-tax (roth) basis not to exceed the limits imposed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to contribute additional catch-up contributions, as allowed under the IRC. Participants may increase or decrease their contribution amount at any time. The Plan accepts eligible rollover contributions. The Plan provides a 3% safe harbor nonelective contribution that is 100% vested. The Plan Administrator may also make a flexible discretionary matching contribution at its discretion. No such match was authorized for the year ended December 31, 2024. Contributions are subject to certain IRS limitations. All contributions are invested in the investment options at the direction of the participant. Contributions are subject to certain limitations. Forfeitures, if any, may be used first to pay allowable Plan expenses and any remaining amounts may be applied to reduce employer contributions.

**Forfeited Accounts:** Any accumulated benefits forfeited during a Plan year due to participant withdrawal prior to full vesting may be applied to reduce employer contributions or to pay administrative expenses which would otherwise be paid by the Plan. Forfeited non-vested accounts totaled \$7,775 and \$12,556 at December 31, 2024 and 2023, respectively. The forfeiture amount used to reduce employer contributions and pay for plan expenses totaled \$13,894 for the year ended December 31, 2024.

**Participant Accounts:** Each participant’s account is credited with the participant’s contributions, allocations of the Plan Administrator’s discretionary contributions and an allocation of the Plan’s earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Note 1. Description of Plan (Continued)

**Vesting:** Participants are always fully vested in their salary deferrals (including Roth), safe harbor nonelective contributions, and rollover contributions. Employer discretionary matching contributions vest according to a 6-year graded schedule (20% after 2 Years of Service, 40% after 3, 60% after 4, 80% after 5, and 100% after 6).

**Participant Directed Investments:** Participants direct the investment of their accounts among the Plan's investment options. If a participant does not provide investment directions, amounts are invested in the Plan's default investment alternatives in accordance with applicable regulations. The Plan is intended to comply with the requirements of ERISA §404(c).

**Distributions:** A participant may receive the value of his or her vested account upon retirement, termination of employment, death, certain in-service events (including attainment of age 59½), and upon approval of financial hardship, as provided by the Plan. If a terminated participant's vested balance does not exceed \$5,000, the amount will be automatically distributed in the form of a lump sum payment. If the vested balance exceeds \$5,000, a terminated participant may elect to receive a distribution of a lump sum payment or installment payments.

**Participant Loans:** The plan does not permit participant loans.

#### Note 2. Summary of Significant Accounting Policies

**Basis of Accounting:** The financial statements are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes both realized and unrealized gains and losses. The Plan assets, which are participant directed and represent investments in mutual funds and a guaranteed annuity contract, are held in a trust for the benefit of participants and beneficiaries. As of December 31, 2023 and from January 1, 2024 through November 13, 2024, the trust was administered by Newport Trust Company, LLC. Effective November 14, 2024 through December 31, 2024, administration of the trust was provided by Ascensus, LLC.

**Payment of Benefits:** Benefits are recorded when paid.

**Expenses:** Plan expenses may be paid from the Plan's assets in accordance with the provisions of the Plan. When expenses are paid using Plan assets, they are allocated among all Participants' accounts. Allocation is performed either proportionately based on each Participant's account balance or as an equal dollar amount per Participant, depending on the nature of the expense.

**Subsequent Events:** The Plan Administrator has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued.

#### **Note 3. Fair Value Measurements**

Financial Accounting Standards Board (FASB) guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

**Mutual Funds:** The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

#### Note 4. Guaranteed Annuity Contract With Insurance Company

At December 31, 2024 and 2023, the Plan held a guaranteed annuity contract issued by New York Life Insurance Company. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the investment contract at December 31, 2024 and 2023, was \$1,074,088 and \$1,702,042, respectively. Fair value approximates contract value at December 31, 2024 and 2023.

The issuer is obligated to repay principal and interest to the Plan at the stated crediting rate, which is established by the issuer and may be adjusted prospectively. The crediting rate reflects, among other factors, the performance of the issuer's general account. The Plan Administrator believes that the occurrence of events that would cause the issuer to terminate the contract or that would limit the Plan's ability to transact at contract value is not probable.

Under the terms of the contract, the issuer does not have the ability to terminate at an amount different from contract value except in the event of the Plan's termination or a complete withdrawal from the contract, in which case a market value adjustment may apply as provided under the contract.

#### Note 5. Parties-in-Interest and Related-Party Transactions

Parties-in-interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employers and certain others. During the year ended December 31, 2024, fees for these services were \$12,265.

#### **Note 5. Parties-in-Interest and Related-Party Transactions (Continued)**

Certain Plan investments are mutual funds advised by an affiliate of the Plan Administrator; transactions in these funds (including fund-level fees) are party-in-interest under ERISA but permitted and were conducted at prevailing rates and within Plan terms. The Plan also paid recordkeeping and trust/custody fees to its service providers, which are parties-in-interest; such payments are permitted under ERISA.

The Plan invests in certain funds issued by New York Life. The guaranteed annuity contract investment options were issued by New York Life; therefore, these qualify as party-in-interest.

#### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, each adopting employer retains the right under the Plan to discontinue its contributions at any time and to terminate its participation in the Plan subject to the provisions of ERISA and the Plan summary. Upon termination, participants would become fully vested to the extent required under the IRC and ERISA, and net assets would be distributed to participants in accordance with the Plan.

#### **Note 7. Tax Status**

The Plan has adopted a preapproved plan document provided by Newport Group Inc. that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC).

The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

#### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market fluctuations, and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates, or other factors in the near term would materially affect participants' account balances as well as the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

#### **Note 9. Certified Investments**

Information related to investments from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends from participants for the year ended December 31, 2024, was obtained by the Plan Administrator and agreed to or derived from information certified as complete and accurate by Newport Trust Company, LLC (as of December 31, 2023, and January 1, 2024 through November 13, 2024) and Ascensus, LLC (effective November 14, 2024 through December 31, 2024) pursuant to 29 CFR § 2520-103-5(c).
