### ***Opinion***

We have audited the financial statements of IBEW Local 968 Pension Fund (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the year ended December 31, 2024 in accordance with accounting principles generally accepted in the United States of America.

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### ***Responsibilities of Management for the Financial Statements***

### 1 – DESCRIPTION OF PLAN

The following description of the IBEW Local 968 Pension Fund (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a multi-employer collectively-bargained defined contribution plan covering eligible employees who have worked and/or are working for any of the contributing employers as established by the agreement by and between the West Virginia - Ohio Valley Chapter National Electrical Contractors Association, and the Union. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Contributions to the Plan are made by participating employers based on the negotiated contribution rates set forth in collective bargaining agreements.

Effective May 6, 2018, the following types of rollovers are to be accepted by the Plan: pre-tax monies from tax-qualified plans, pre-tax monies from 403(b) plans, and monies from governmental 457(b) plans, and individual retirement accounts.

Effective June 1, 2018, the interest rates charged to delinquent employers can be reduced by the Trustees to a rate no lower than 1.0% per month.

Participant Accounts - Each participant's account is credited with a contribution by the contributing employer based on hours worked by the participant and plan earnings based on the participant's investment elections. Each participant's account is reduced by a pro-rata administrative charge. Participants direct the investment of their account by designating the proportion of their account to be allocated to the separate investment options offered by the Plan. The Plan currently offers various mutual funds and a collective investment trust fund as investment options for participants. The benefit to which a participant is entitled is the benefit that can be provided from the balance in the participant's account.

Vesting - Participants are immediately vested in the entirety of their accounts.

Payment of Benefits - Participants, upon reaching age 55 and retiring from employment or after becoming permanently disabled at any age, may elect to receive the value of their account in (a) a lump-sum amount, (b) a lesser lump-sum amount, with the remainder in equal monthly payments of not less than twenty-four nor for a period greater than the life expectancy of the participant or the joint life expectancy of the participant and his beneficiary, (c) equal monthly payments of not less than twenty-four nor for a period greater than the life expectancy of the participant or the joint life expectancy of the participant and his beneficiary, or (d) an annuity. Participants who at any age experience a shut-down event, requirements for which include total exhaustion of all available unemployment benefits and continuing to be available for work under the collective bargaining agreement, may elect to receive all or part of the value of their account in the form of RTS (Retirement Type Shutdown) benefits, paid as an annuity or in substantially equal payments calculated over a period of at least 120 months, until the participant is offered a return to work.

Ancillary benefits, mid-term shutdown and mid-term disability, of \$230 per week are tied to continued unemployment benefits and the exhaustion of disability benefits.

Upon the death of a participant, the value of his account shall be paid based upon options specified in the Plan.

In addition, any participant with an account balance of less than \$5,000 who has not worked in the jurisdiction of the IBEW Local Union No. 968 for a period of thirty-six months may receive the value of his account in its entirety.

Effective May 6, 2018, procedural and administrative policies for disability benefits were updated to comply with new U.S. Department of Labor guidelines.

An amendment was adopted on April 23, 2021, raising the age of required minimum distributions for participants who reach age 70 ½ after January 1, 2020 to age 72.

## 2 – SUMMARY OF ACCOUNTING POLICIES

Date of Management's Review – Subsequent events were evaluated through the date of the auditors' report, which is the date the financial statements were available to be issued.

Basis of Accounting - The financial statements of the Plan are prepared using the accrual basis of accounting.

Cash – Cash consists of cash held by the Plan at Union Trades Federal Credit Union and the investment custodian, Charles Schwab.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments - Investments are stated at fair value. Shares of registered investment companies (mutual funds) are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end. Units of the collective investment trust fund are valued at net asset value at year-end.

Purchases and sales of investments are recorded on a trade date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income.

Payment of Benefits - Benefits are recorded when paid.

Allowance for Doubtful Accounts - The Plan's administrator has evaluated employer contributions receivable and has determined that an allowance for doubtful accounts were not necessary as all amounts are deemed to be fully collectible.

### 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2—Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds – Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust Funds – Valued at the NAV of units within the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### 5 – PLAN TERMINATION

Although neither has expressed any intent to do so, the Union or the Contractors Association has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the trust fund shall continue for the sole purpose of providing benefits as explained under the payment of benefits section of Note 1.

#### 6 – INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Plan by letter dated May 6, 2016, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code.

#### 7 – RELATED PARTY TRANSACTIONS AND INVESTMENT ADMINISTRATION

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Plan Sponsor, and certain others. American Benefit Corporation is the third-party administrator. Charles Schwab is the investment custodian for the Plan. John F. Dascoli, PLLC, serves as the legal counsel to the Plan. Gray, Griffith, & Mays, A.C. provides financial statement audit services for the Plan. Harris, Hardin, & Company, A.C. provides payroll audit services for the Plan.

#### 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
