We have performed audits of the financial statements of Lamp Rynearson ESOP, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lamp Rynearson ESOP's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and December 31, 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Note 1 - Description of Plan

The following brief description of the Lamp Rynearson ESOP (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

Lamp Rynearson, Inc. (the Company) established the Plan effective as of March 31, 1976. The Plan was amended and operates, in relevant part, as a non-leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (IRC), as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Employee Benefits Administration Committee comprising up to three persons appointed by the Company's Board of Directors. The Plan's Trustee is also appointed by the Company's Board of Directors. As of December 31, 2024, three members of the Board of Directors are authorized to jointly serve as the Trustee of the Plan.

Eligibility

Employees of the Company are generally eligible to participate in the Plan after one year of service, providing they are 21 years of age or older. A year of service is defined as working at least 1,000 hours during a consecutive 12-month period. Eligible employees enter the Plan on the earlier of the first day of the first, fourth, seventh, or tenth month of the Plan year following meeting the eligibility requirements.

Contributions

Contributions to the Plan are made by the Company at the discretion of the Company's Board of Directors. The contributions are allocated according to the pro rata share of each participant's eligible compensation to total eligible compensation. Participants must have completed 1,000 hours of service and be actively employed at the end of the year, unless terminated due to retirement, death or disability, to receive an allocation of the contribution. In 2024, the Company made a discretionary contribution of \$1,572,200. Employee contributions are not permitted.

Voting Rights

The Trustee shall vote all Company stock held by the Plan. However, if any agreement entered into by the Plan provides for voting of any shares of Company stock pledged as security for any obligation of the Plan, then such shares of Company stock shall be voted in accordance with such agreement. If the Trustee does not timely receive voting directions from a participant or beneficiary, the Trustee shall vote such Company stock.

Put Option

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to a participant for which there is no market. The put price is representative of the fair market value of the stock. The repurchase can occur over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to the total eligible compensation. Plan earnings and losses are allocated to each participant's account based on the ratio of the participant's account balance.

Vesting

Vesting in the participants' accounts and related earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service. Participants are 100% vested in their account balances upon retirement, death, or disability.

Forfeitures

At December 31, 2024 and 2023, there was no balance in the forfeited non-vested account as all forfeitures are used in the same year they are forfeited. Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. During the year ended December 31, 2024, \$5,347 of cash and 44.29 shares of Company stock from forfeited non-vested accounts were allocated to eligible participants.

Payment of Benefits

Upon death, disability or retirement, a participant will receive a lump sum amount or payments over monthly, quarterly, semiannual or annual installments beginning in the Plan year following the event, provided the participant's vested account balance exceeds \$5,000. Distributions for other separations from service commence on the occurrence of an event which would result in a distribution had the terminated participant remained employed by the Company (i.e. death, disability or retirement), unless otherwise elected by the participant.

Installment payments will be made over a period not longer than the greater of five years, or in the case of a participant with an account balance in excess of \$1,380,000, five years plus one additional year, but not more than five years, for each \$275,000, or fraction thereof, by which the participant's account balance exceeds \$1,380,000 (or such amounts as adjusted pursuant to the IRC). The amount to be distributed is based upon the immediately preceding valuation date.

If the participant's vested account is less than \$5,000, but greater than \$1,000, upon separation of service, the Plan can automatically roll the account into a designated retirement account. Effective January 1, 2024, the \$5,000 amount was increased to \$7,000. If the participant's account is less than \$1,000, the Plan can automatically cash out the account. Distributions are made in cash or, if permitted, in the form of Company common stock plus cash for any fractional share of common stock. Under the provisions of the Plan, the Company is obligated to repurchase participant shares immediately upon distribution under the terms of the Plan.

The Plan also provides for a directed investment account. Participants who have retired or separated employment have the right to direct the investment of their account by choosing among a variety of investment alternatives offered by the Plan or by electing a distribution from Plan. If the Participant does not direct the Plan as to their investment, the funds are invested in the default investment option as determined by the Trustee.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the 6th year, the percentage changes to 50%.

A second diversification option is offered over a 3-year period following the expiration of the 6-year period described previously. Participants who are at least age 61 with 20 years of participation in the Plan may elect to diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any share previously diversified.

Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. If the Plan is terminated, or if employer contributions are completely discontinued, all amounts credited to participants' accounts will become 100% vested. Upon termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of the fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is accrued on the ex-dividend date. Interest income is recorded on the accrual basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. The Employee Benefits Administration Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, certified valuation specialist and insurance company.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on the Form 5500.

Payments of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statement of changes in net assets available for benefits. The Plan has historically paid the expense associated with the annual valuation of Company stock. The Company has historically paid all other operating expenses of the Plan.

Note 5 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Company common stock: The fair value of the Company common stock held in the Plan is valued at estimated fair value based upon an independent appraisal. The appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, discount rates, return on assets, return on equity, market comparables and estimated fair value of Company assets and liabilities, including discounts for lack of control and lack of marketability.

U.S. government securities: Valued using pricing models maximizing the use of observable inputs for similar securities.

Publicly traded common stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with Securities Exchange Commission (SEC). These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Exchange traded funds: Valued at the closing price reported by the fund. Exchange traded funds (ETF) held by the Plan are open-ended management investment companies that are registered with the Securities and Exchange Commission. The shares are traded throughout the day at the market price.

Interest bearing cash accounts: Cost approximates fair value due to its short-term nature.

Pooled separate accounts: Valued at fair value based on the NAV of the units held in the account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. Note 6 - Certified Information

Certain information related to the pooled separate accounts, common/collective trusts and mutual funds disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including pooled separate account, common/collective trust and mutual fund investments held at December 31, 2024 and dividends and net appreciation in fair value of the pooled separate accounts, common/collective trusts, and certain mutual fund investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company (a custodian of the Plan). Certified information related to the pooled separate account investments held at December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by United of Omaha Life Insurance Company (a custodian of the Plan).

Other investments, including Company common stock, US Government securities, publicly traded common stocks, exchange traded funds, interest bearing cash, and certain mutual funds totaling \$18,412,013 and \$19,151,409 as of December 31, 2024 and 2023, respectively, and related investment depreciation of \$396,199 and interest and dividends of \$753,617 for the year ended December 31, 2024 were not certified by the custodians.

Note 7 - Right of First Refusal

Company stock that has been distributed to a participant and not immediately repurchased by the Company or Trust, may be subject to a right of first refusal if so determined by the Company. Prior to any subsequent transfer, the shares must first be offered by written offer to the Company, and then, if refused by the Company, to the Trust at fair market value as determined by an independent appraiser appointed by the Board of Directors.

Note 8 - Dividends

The Company paid a dividend to the Plan of \$10 per share of Company stock or \$646,200 during the year ended December 31, 2024. Participants who are 100% vested in their account are given the right to take a distribution of such dividends in cash or leave the funds in the Plan to be invested, as provided by the Plan.

Note 9 - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated September 23, 2013, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. Subsequent to the issuance of the determination letter, the Plan was amended. However, the Company, Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and, therefore believe the Plan is qualified and the related trust continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10 - Related Party and Party-in-Interest Transactions

The Plan invests in Company common stock. During each of the years ended December 31, 2024 and 2023, the Plan purchased 3,000 shares of common stock from a retired participant in the Plan. These purchases are related party and party-in-interest transactions.

As described in Note 1, the Company made a discretionary contribution to the Plan during the year. Additionally, as described in Note 8, the Plan received dividends on the investment in Company common stock. These are related party and party-in-interest transactions.

Certain plan investments consist of pooled separate accounts managed by United of Omaha Life Insurance Company, a custodian as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

Note 11 - Risks and Uncertainties

The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Market risks include global events which could impact the value of investments, such as a pandemic or international conflict. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 12 - Plan Amendments

In connection with the SECURE 2.0 Act, the Plan implemented the following provisions:

- Mandatory cash-out distributions increased from \$5,000 to \$7,000 effective January 1, 2024.

A formal amendment will be completed for the provision above and any additional SECURE 2.0 Act provisions at a future date.

Note 13 - Subsequent Events

On January 2, 2025, the Plan entered into a stock purchase agreement to purchase 4,500 shares of common stock from a retired participant in the Plan. The agreement states that the purchase price shall be equal to the fair value per share of Company common stock held by the Plan as of December 31, 2024, multiplied by 4,500 shares. The Plan made a cash payment of \$988,200 on January 3, 2025, and entered into a promissory note bearing interest at 4.33% for the remainder of the purchase price. The promissory note was due within 10 days after the Trustees approved the valuation of Company common stock held by the Plan as of December 31, 2024. Final payment of \$61,294, including interest of \$994, was made on May 22, 2025.

The Company has evaluated subsequent events through October 14, 2025, the date which the financial statements were available to be issued.
