Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Blue Dot Read-Mix, LLC 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Blue Dot Read-Mix, LLC 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Notes to Financial Statements

December 31, 2024 and 2023

1. DESCRIPTION OF PLAN

The Blue Dot Read-Mix, LLC 401(k) Retirement Plan (the Plan) is sponsored by Blue Dot Read-Mix, LLC (the Company). The following description of the Plan is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under Section 401 of the Internal Revenue Code. The Plan covers substantially all employees of the Company who have one year of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Employees may defer up to 100% of their compensation, as defined by the Plan, up to limited amounts prescribed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company contributes 50% of the first 6% of base compensation that a participant contributes to the Plan.

Forfeited Accounts

Forfeited non-vested amounts are used to reduce administrative expenses or Company contributions to the Plan. There was no balance of forfeited non-vested accounts as of December 31, 2024 and 2023. Company contributions of \$16,247 were paid with forfeited funds during the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions, net earnings or losses associated with their investments and an allocation of Plan expenses. Allocated earnings and expenses are based on participant account balances or earnings, as defined by the Plan. Participants may direct the investment of their account as allowed by the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates similar to those with a lending institution at the time of the loan, which are commensurate with local prevailing rates. Principal and interest is paid ratably through payroll deductions over a term not to exceed 5 years; however, terms may exceed five years for the purchase of a primary residence. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Investment Options

Participants are afforded several investment options covering a wide range of investment objectives and risks. Participants may allocate their contributions across these options in any proportion they wish and can change this allocation at any time. All investments are participant directed.

1. DESCRIPTION OF PLAN, CONCLUDED

Payment of Benefits

The benefit to which a participant is entitled is the benefit that can be provided by the participant's account. Upon termination of service, death, disability or retirement the participant will receive the value of the vested interest in his or her account in the form of a lump-sum distribution. Upon proof, to the satisfaction of the Plan administrator of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

The Company may elect to pay the administrative expenses of the Plan. If not paid by the Company, administrative expenses are required to be paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of certain contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expense during the reporting period. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Interest rates range from 4.25%-9.50% at December 31, 2024.

3. INVESTMENTS

Other than the notes receivable from participants and the related interest income, all investment information disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023 was obtained or derived from information provided to Plan management and certified as complete and accurate by Principal Life Insurance Company, the custodian of the plan for the years ended December 31, 2024 and 2023.

4. FAIR VALUE MEASUREMENTS

The Plan categorizes its assets and liabilities measured at fair value into a three-level hierarchy based on the priority of the inputs to the valuation technique used to determine fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:
quoted prices for similar assets or liabilities in active markets;
quoted prices for identical or similar assets or liabilities in inactive markets;
inputs other than quoted prices that are observable for the asset or liability;
inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset and liabilities' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. FAIR VALUE MEASUREMENTS, CONCLUDED

Pooled Separate Accounts

Investments in pooled separate accounts are valued using the NAV of units, as determined by the insurance company. Pooled separate accounts are carried at fair value using net asset value practical expedient. Therefore, it is not categorized within the fair value hierarchy.

Guaranteed Investment Contract

At December 31, 2024 and 2023, the Plan has a guaranteed investment contract ("GIC") that is a group annuity contract, backed by the assets of the general account of Principal Life Insurance Company. This GIC, the Principal Guaranteed Interest fund, is considered a fully benefit responsive investment contract and is measured, presented and disclosed at contract value within the Statement of Net Assets Available for Benefits. Participant transactions are executed using contract value without adjustment. The earnings of the contract is based on an interest rate applied to each participant's outstanding balance. The interest rates are analyzed and may be reset by the issuer semi-annually for the contract. The interest credited to participants in the contract for the year ended December 31, 2024 was 1.77 – 5.42 percent. The interest credited to participants in the contract for the year ended December 31, 2023 was 0.80 – 5.0 percent. The contract has no minimum crediting interest rate, no restrictions on the use of Plan assets and there are no valuation reserves recorded to adjust contract amounts. Fund performance, net cash flows of the Plan investments, and duration of assets are factors that could influence the average interest credited rate. Principal has the option to payout 100% of the current value of the contract after completion of three contract years.

Contract value is calculated as contributions, plus earnings, less withdrawals and administrative expenses. Participant transactions are executed at contract value less surrender charges, if applicable, which is the relevant measure for fully benefit-responsive investment contracts. The Plan's ability to meet its contractual obligations to settle amounts due is dependent on the issuer, which could be impacted by economic and regulatory changes. Currently, there is no probability of the issuer not being able to fulfill its contractual obligations at contract value.

5. PLAN TAX STATUS

The Company adopted a non-standardized plan prototype. This prototype plan obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service states that the Plan as designed was in compliance with the applicable requirements of the Internal Revenue Code (IRC), and is therefore, not subject to tax under present income tax laws. The plan has been amended since receiving the determination letter. However, the Plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if it has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator feels the Plan had no such positions at December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. EXCESS PARTICIPANT CONTRIBUTIONS PAYABLE

The Plan did not pass the Average Deferral Percentage (ADP) and Actual Contribution Percentage (ACP) Tests for the years ended December 31, 2024 and 2023. Excess contributions amounting to \$15,017 and \$13,103 plus earnings of \$1,965 and \$2,084 respectively, on those contributions were recorded as a liability in the accompanying statements of net assets available for benefits at December 31, 2024 and 2023. These excess contributions were refunded to highly compensated employees in accordance with the applicable federal regulations in 2025 and 2024, respectively.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

8. PARTY-IN-INTEREST TRANSACTIONS

The investments are managed by Principal Life Insurance Company, the custodian of the Plan; therefore, transactions with them qualify as party-in-interest. Fees paid to the custodian during the year ended December 31, 2024 was \$4,681.

The Plan sponsor provides the Plan with certain accounting and administrative services for which no fees are charged. The Plan sponsor also pays for some audit and administrative expenses for the Plan for which no reimbursement is received from the Plan.

9. PLAN TERMINATION

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
