Note 1 - Plan Description

The following description of Neal, Gerber & Eisenberg Profit Sharing/401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time partners and administrative employees of Neal, Gerber & Eisenberg LLP (the "Firm") who have completed one or more years of service for the profit-sharing feature and 30 days of service for the 401(k) feature of the Plan. Temporary employees are eligible if they have one or more years of service for the profit-sharing and 401(k) features of the Plan. Eligible participants begin to participate in the profit-sharing feature and the 401(k) feature in January or July and on the first day of the next calendar quarter following completion of the eligibility requirements, as described in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

An employee who becomes a participant in the Plan and does not elect to make employee contributions shall automatically be enrolled in the Plan he or she elects not to participate in the Plan. Automatically enrolled employees make deferrals through payroll reductions equal to 3 percent of eligible compensation per pay period unless such participant elects to make 401(k) or Roth contributions in a different percentage or dollar amount. Such automatic enrollment shall become effective as soon as administratively practicable after the later of 30 days after the employee receives the automatic enrollment notice or the entry date on which the employee becomes a participant. Contributions are invested based on participant election or to a qualified default investment alternative if no election is made by the participant.

In the event a participant has elected to make elective contributions at a rate that is the lesser of 15 percent of his or her compensation or the maximum contribution to the Plan as permitted, the amount of the participant's elective contribution shall automatically increase as of the beginning of each plan year at a rate of 1 percent of the participant's compensation, up to a maximum of 15 percent of the participant's compensation. Such automatic annual increase shall be effective as of January 1 of each plan year.

Account balances of participants who became partners during the year are transferred from the Neal, Gerber & Eisenberg Associates' and Counsel 401(k) Plan. Account balances of employees who become attorneys during the year and are not partners are transferred to Neal, Gerber & Eisenberg Associates' and Counsel 401(k) Plan.

Contributions

The Plan is designed as a qualified cash deferral arrangement pursuant to Section 401(k) of the Internal Revenue Code (IRC) and provides for the following contributions:

- Participant-directed contributions - Each year, participants may contribute between 1 percent and 80 percent of annual compensation, as defined in the plan document, either pretax or as Roth 401(k) contributions subject to IRC Sections 402(g) and 415(d) limitations.
- Profit-sharing contributions - The Firm may contribute amounts, at the discretion of its executive committee, which are allocated in accordance with plan provisions and subject to certain limitations under the IRC.
- Rollover contributions - Participants and newly hired eligible employees may also contribute amounts representing distributions from other qualified plans.

Note 1 - Plan Description (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Firm's contributions, if any, and plan earnings or losses and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participants' contributions or account balances, as defined in the plan document.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance during the prior 12-month period, or 50 percent of their vested account balances. Each participant is allowed to have only two loans outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1 percent. Principal and interest are paid ratably through monthly payroll deductions over a term not exceeding 5 years or a reasonable period of time not to exceed 10 years, determined at the time of the loan, if used for the purchase of a principal residence.

Benefit Payments

Benefits may be paid to the participant or beneficiary upon retirement, death, disability, or termination of employment, as defined in the plan document. The Plan provides for normal retirement at age 65. The Plan does not provide for early retirement. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment. Participants experiencing financial hardship or who have attained age 59½ may withdraw a portion of this account balance, as defined in the plan document.

Vesting

Participants are immediately vested in their salary reduction contributions and rollover contributions, plus earnings thereon. Participants are 100 percent vested in the Firm's discretionary contribution portion of their accounts, if any, plus actual earnings thereon, after completion of three years of vesting service or three years of alternative vesting service, as defined in the plan document, or upon death, disability, or normal retirement.

Forfeitures

Forfeitures shall first be used to restore a participant's account and then shall be used to reduce the Firm's discretionary contributions for the plan year during which the forfeitures occurred. Furthermore, the forfeitures may also be used to reduce any minimum contributions required because the Plan is top heavy for such plan year and to pay plan administrative expenses. As of December 31, 2024 and 2023, forfeited account balances totaled approximately \$60,100 and \$10,900, respectively. Also, during the year ended December 31, 2024, the Firm's profit-sharing contributions were reduced by approximately \$10,900 from forfeited nonvested accounts.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

Although it has not expressed any intent to do so, the Firm has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in the Firm's contribution portion of their accounts.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Firm.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 10, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Charles Schwab Trust Bank (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Note 4 - Fair Value Measurements (Continued)

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Money Market Fund

The money market fund is valued at quoted prices reported in active markets.

Common/Collective Trust Funds

The common/collective trust funds are valued at net asset value per share (NAV) or its equivalent of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

Self-directed Brokerage Accounts

The Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts consist of publicly traded securities, money market funds, government securities, corporate obligations, municipal obligations, and certificates of deposit. The publicly traded securities and money market funds are valued at the daily closing price, as reported by the active markets on which they are traded. Government securities, corporate obligations, and municipal obligations are valued using pricing models maximizing the use of observable inputs for similar securities with inputs such as trades, bid price or spreads, and other standard inputs. Certificates of deposit are valued using the rates currently offered for deposits of similar remaining maturities.
