We have audited the financial statements of Arvinas, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit] for the years ended December 31, 2024 and 2023, and we will issue our report thereon dated October 7, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Reliance Trust Company and Fidelity Management Trust Company, the trustees, which are banks or similar institutions or insurance carriers that are regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated July 31, 2025. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted, and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

Management's estimate of the fair value of investments is based on the hierarchy of fair value inputs as set forth in Accounting Standards Codification (ASC 820, *Fair Value Measurements and Disclosures*). We evaluated the methods, assumptions, and data used to develop the fair value of investments in determining that it is reasonable in relation to the financial statements taken as a whole.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosure affecting the financial statements was:

The disclosure of fair value measurement in Note 4 to the financial statements identifies the fair value of the Plan's investments which are based on a hierarchy of fair value inputs as set forth in ASC 820, *Fair Value Measurements and Disclosures*.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. Management has corrected the following material misstatements detected as a result of audit procedures: 1) recording of the employer safe harbor true-up match of \$434,331, 2) reversing entry for prior year unqualified hardship distribution receivable of \$42,500, 3) reversion prior year employer safe harbor true-up match receivable of \$283,097, and 4) recording of 2024 employee and employer receivable of \$67,086 and \$25,565, respectively, due to timing of payroll.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated October 7, 2025.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

Our responsibility for the ERISA-required supplemental schedules accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

This information is intended solely for the use Arvinas, Inc. 401(k) Plan and is not intended to be, and should not be, used by anyone other than these specified parties.

Arvinas, Inc. 401(k) Plan Notes to Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following description of the Arvinas, Inc. 401(k) Plan (the Plan) is provided for general purposes only. Participants should refer to the Summary Plan Document for a more complete description of the Plan's provisions.

General

The Plan, established on January 1, 2020, is a defined contribution plan, available to all employees of Arvinas, Inc. and any participating Affiliates (the Company) who have met the eligibility requirements stipulated by the Plan. The Plan is administered by the management of the Company and is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Effective June 29, 2022, the Plan was restated in order to comply with applicable regulations. However, the restatement had no significant effect on any of the plan provisions.

Eligibility

In general, all employees are eligible to participate in the Plan, upon reaching age 21. There is no minimum service requirement, and employees can enter the Plan on the first day of the month following the completion of the eligibility requirements.

Contributions

Each year, participants may contribute a percentage from 1% to 90% of any combination of their pretax and after-tax annual compensation as defined by the Plan. Participant contributions are subject to limitations imposed by the Internal Revenue Code, which was \$23,000 and \$22,500 for 2024 and 2023, respectively, plus an additional \$7,500 for certain eligible catch-up contributions for participants over age 50 for both 2024 and 2023.

Management made a safe harbor matching contribution each payroll period equal to 100% of the first 4% of the participants' pre-tax or Roth salary deferral contributions for the years ended December 31, 2024 and 2023. Employer safe-harbor matching contributions were \$3,863,193 and \$3,372,172 for the years ended December 31, 2024 and 2023, respectively.

Investment Options

All of the assets of the Plan were held by the Reliance Trust Company, the previous trustee, through October 31, 2024 and by Fidelity Management Trust Company, the new trustee, for the period November 1 through December 31, 2024. All investments are fully participant directed. Participants may direct the investment of their contributions and the Company's matching contribution into any of the Plan's available investment options.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's safe-harbor matching contribution, and allocations of Plan earnings, and charged with withdrawals and an allocation of Plan losses and certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, Company safe harbor matching contributions, plus earnings thereon. As such, there are no forfeited accounts at December 31, 2024 and 2023.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, and a minimum of \$500, and may only have two loans outstanding at a time. In general loans are repaid over a period of 5 years unless the loan is used for the purchase of a primary residence, which may be paid over a period of no more than 30 years. Payments of principal and interest are made through payroll deductions over the loan period. A loan is secured by the vested balance in the participant's account. The loan bears interest at a rate that is equal to the prime rate as published in The Wall Street Journal in the month the loan is effective, plus two percentage points, and is fixed over the life of the note. The interest rates on participant loans as of December 31, 2024 and 2023 ranged from 5.25% to 10.50%.

Payment of Benefits

Upon a participant's separation from service due to death, disability, termination, or retirement, benefits may be distributed to them in a single lump sum amount equal to the vested value of their account, a direct rollover or in installments. Active participants may also withdraw funds from their accounts under certain hardship conditions.

1. Description of Plan (continued)

Payment of Benefits (continued)

If the vested benefit is less than \$5,000, the Plan Administrator may initiate an involuntary distribution. Prior to such distribution, the participant has the right to request that the amount be distributed directly to the participant in the form of a lump sum amount or request that it be rolled over to a different IRA provider or another retirement plan eligible to receive rollover contributions.

Forfeitures

As participants are always 100% fully vested in their total account balances, there are no forfeited non-vested accounts in the Plan.

Administrative Expenses

Individual Participant accounts may be charged directly for all administrative expenses, if not paid by the Company. Individual Participant accounts are charged directly for certain services or transactions requested by participants, such as loan or distribution fees.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Benefit Payments

Benefits are recorded when they have been approved for payment and paid by the Plan.

Notes to Financial Statements (continued)

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Investments, other than the fully benefit-responsive investment contract, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further information on fair value measurements utilized by the Plan. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

3. Information Certified by the Trustee

The Company had previously entered into an agreement with the Reliance Trust Company. Pursuant to the trust agreement, the assets of the trust were held and administered by the Reliance Trust Company, the trustee, as of December 31, 2023 and for the period from January 1, 2023 through October 31, 2024. During the year ended December 31, 2024, the Company entered into an agreement with Fidelity Management Trust Company. Pursuant to the trust agreement, the assets of the trust were held and administered by the Fidelity Management Trust Company, the trustee, as of December 31, 2024 and for the period November 1, 2024 through December 31, 2024. The Trustees hold mutual funds stated at fair value and common collective trusts stated at fair value and contract value. In accordance with the trust agreements, the Trustees hold the Plan assets and executes investment transactions. All investment information disclosed in the accompanying financial statements, including investments held and notes receivable from participants at December 31, 2024 and 2023, and interest income, dividends and net appreciation (depreciation) in fair value of investments for the years then ended, was obtained and certified as complete and accurate by the Reliance Trust Company and Fidelity Management Trust Company.

4. Fair Value Measurements

Under US GAAP, a framework for measuring fair values has been established to clarify the definition of those fair values and expand disclosures about assets and liabilities measured at fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy described under US GAAP are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

4. Fair Value Measurements (continued)

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust (Invesco Stable Value Trust Class I Fund – see Note 5) – The net asset value (NAV) reported for this fund is generally obtained directly from the fund house or other investment provider.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fully Benefit-Responsive Investment Contract

The Plan's investment in the Invesco Stable Asset Fund (the Fund), held by Reliance Trust Company (previous trustee) until October 31, 2024, is a participating trust in the Invesco Stable Value Trust which invests primarily in synthetic guaranteed investment contracts (GIC). These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. The issuer is contractually obligated to repay the principal and a specified rate of interest guaranteed to the Fund. The interest crediting rate is based on a formula established by the contract issuer.

The trust allocates investment income, to a unit class, if applicable, based on the relative net assets of each unit class.

As discussed in Note 3, the Plan transferred its assets to a new trustee October 31, 2024. The Plan's investment in the Fund was transferred to an interest in a similar fund, Invesco Stable Value Trust Class I Fund (the New Fund), which invests in similar investments to the Fund. However, the New Fund does not have a direct contract with the Plan and is therefore a common collective trust presented at fair value in Note 4.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100% vested in their accounts.

7. Party-in-Interest and Related Party Transactions

During the Plan years ended December 31, 2024 and 2023, \$4,629 and \$3,646, respectively, of administrative fees were paid to Reliance Trust Company and Fidelity Trust Management Company. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Notes receivable from Participants also qualify as exempt party-in-interest transactions as defined by ERISA.

8. Risks and Uncertainties

The Plan invests in various securities, including mutual funds and common collective trust funds. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities in the near term could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

9. Income Tax Status

Prior to October 31, 2024 change in trustee, the underlying prototype non-standardized prototype 401(k) and profit sharing Plan has received an opinion letter from the Internal Revenue Service (IRS), dated July 8, 2014, stating that the form of the Plan is qualified under Section 401(a) of the IRC, is exempt from federal income taxes under Section 501(a) of the IRC and that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the advisory opinion letter. The Plan Administrator believes the Plan is currently designed in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax-exempt as of the financial statement dates.

Effective November 1, 2024, the Plan moved to Fidelity Management Trust Company from ADP Retirement Services, and adopted the Pre-Approved Defined Contribution Plan (Profit Sharing/401(k) Plan) Fidelity Basic Plan Document No. 17. The underlying non-standardized pre-approved profit sharing plan has received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of IRC, is exempt from federal income taxes under Section 501(a) of the IRC and that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the advisory opinion letter. The Plan Administrator believes the Plan is currently designed in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax-exempt as of the financial statement dates.

9. Income Tax Status (continued)

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. It is the Plan's policy to account for any uncertainties as described under the income tax laws. Under the income tax laws, the tax-exempt status of an entity is considered a tax position. No such uncertain tax positions have been recognized by the Plan.

The Plan files Form 5500 with the IRS, and is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.
