Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the MelroseWakefield Healthcare 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Notes to Financial Statements

Note 1 - Description of the Plan

The following description of the MelroseWakefield Healthcare 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored by the MelroseWakefield Healthcare Parent Corporation, including the following affiliated employers: Hallmark Health Medical Associates, Inc. and MelroseWakefield Healthcare, Inc. (the “Employer” or “Company”), covering substantially all employees of the Company. The Plan was most recently amended and restated effective June 11, 2021. Effective January 1, 2019, all participants of the Plan became eligible to participate in the MelroseWakefield Healthcare 403(b) Plan and participant and discretionary contributions ceased to the MelroseWakefield Healthcare 401(k) Savings Plan. Prior to January 1, 2019, all eligible employees could immediately make elective participant contributions upon hire. Eligible employees had to complete one year of service to receive Employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Substantially all investments are participant-directed.

Contributions

The Company may make a discretionary contribution to non-highly compensated employees hired prior to December 31, 2018 who have completed 1,000 hours during the plan year and were employed on the last day of the plan year. The discretionary contributions are allocated to eligible participants based on a participant’s eligible compensation relative to the total eligible compensation paid to all eligible participants for the year. For the year ended December 31, 2024, the Company made a \$143,606 discretionary contribution, funded through forfeitures in April of 2025.

Participant Accounts

Each participant’s account is credited or charged with contributions, investment income, and administrative expenses. Investment income, including realized and unrealized gains and losses, and expenses are allocated to participants’ accounts based on each participant’s account balance within each fund. Participants determine the percentage in which contributions are to be invested in each fund. Participants may change their investment options as set forth in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their deferral, rollover, and after-tax contributions and actual earnings thereon. Participants become 100% vested in the Company’s discretionary contributions and earnings thereon upon death, total and permanent disability, or attainment of normal or early retirement age. Otherwise, participants vest in the Company’s discretionary contributions based on years of continuous service, as follows:

Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of a participant's account represents a forfeiture, as defined by the Plan. Forfeitures are retained in the Plan and may be used to pay administrative expenses or to reduce Company contributions payable under the Plan. Total unapplied forfeitures were \$139,887 and \$70,307 at December 31, 2024 and 2023, respectively. For the Plan year ended December 31, 2024, \$143,606 of forfeitures were used to reduce the 2024 Employer contribution funded in 2025.

Unallocated Assets

The Plan holds assets in a recapture account which receives deposits as a result of a revenue sharing agreement with Fidelity Management Trust Company ("Fidelity"). During 2024, there were no deposits to the account. Funds in the account are used to pay qualified plan expenses or allocated to participants. During 2024, \$55,085 was used to pay plan expenses. The balance of unallocated assets was \$2,074 and \$55,701 at December 31, 2024 and 2023, respectively.

Withdrawals and Distributions

Benefits are distributed to participants upon termination of employment by reason of retirement, disability, death or other separation from service. Participants may elect a distribution in the form of an annuity, installment payments, or a lump sum. Upon termination, if a participant's vested account balance is \$1,000 or less, and the participant does not elect to take a distribution, the plan administrator may distribute the participant's vested account balance directly to the participant without consent.

A participant may also request a withdrawal upon attainment of age 59 ½ or upon demonstration by the participant to the plan administrator that the participant is suffering from "hardship", as defined in the plan document. Participants may withdraw from their rollover account at any time.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Loans must bear a reasonable rate of interest. Loans must be repaid over a period not to exceed five years unless the loan proceeds are used for the purchase of a primary residence, in which case a longer repayment period is allowed. No more than one loan may be outstanding at any time. Principal and interest is generally repaid at least quarterly by participants directly to the plan custodian.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

Investments, Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the trustee and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Benefits Paid

Benefits are recorded when paid.

Plan Expenses

Participant transaction fees, investment expenses, and certain administrative fees incurred by the Plan are paid by the participants. Investment related expenses are included in net appreciation in fair value of investments. Any remaining fees not paid from plan assets are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Reclassifications

Certain amounts have been reclassified in the 2023 financial statements to conform to the 2024 presentation. There was no effect on the net assets available for benefits or Statement of Changes in Net Assets Available for Benefits.

Subsequent Events

The Employer has evaluated subsequent events through October 14, 2025, the date that the financial statements were available to be issued. No significant matters were identified for disclosure during the evaluation.

Note 3 - Information Certified by the Trustee and Custodian

Plan investments are held by the Plan's trustee and custodian, Fidelity Management Trust Company ("Fidelity"). The fair value of investments as of December 31, 2024 and 2023, and all investment transactions for the year ended December 31, 2024, including interest and dividends and net appreciation in fair value of investments are reported to the Plan and certified as complete and accurate by Fidelity. Information contained in the supplemental schedule and notes receivable from participants are also certified by Fidelity. The Plan offers investment choices to allow Participants to create a diversified portfolio of assets based on a participant's risk tolerance. Participants in the Plan may direct contributions to a variety of investment options.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

U.S. government bonds: Certain bonds are valued at the closing price reported on the active market on which the bond is traded. Other bonds are valued based on yields currently available on comparable securities of issuers with similar credit ratings. When quoted prices are not available for identical or similar bonds, the bond is valued under a discounted cash flow approach that maximizes observable inputs, such as current yields of similar instruments, but includes adjustments for certain risks that may not be observable, such as credit and liquidity risks.

Mutual funds (including mutual funds in self-directed brokerage accounts): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Balances consist of interest bearing cash and common stocks and are valued at quoted market prices reported on the active market on which the individual securities are traded, and mutual funds and U.S. government bonds are valued as noted above.

Note 5 - Risks and Uncertainties

The Plan provides for various investment options in registered investment companies and self-directed funds. Investment securities are exposed to various risks which include, but are not limited to, interest rate, market and credit risks. Market risks include global events such as an international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 6 - Related-Party Transactions and Exempt Party-In-Interest Transactions

Investments are held by Fidelity, the trustee and custodian of the Plan. Accordingly, these investments are considered exempt party-in-interest transactions. During the Plan year ended December 31, 2024, \$199,858 was paid to Fidelity and other service providers as administrative and investment expenses. In addition, notes receivable from participants are also considered exempt party-in-interest transactions. The Plan also received revenue credits from Fidelity in the amount of \$61,250 and reported as other income on the Statement of Changes in Net Assets Available for Benefits. The credits are used to offset Plan expenses.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

Note 8 - Tax Status

The Plan has adopted the Fidelity Volume Submitter Defined Contribution Plan that received its latest opinion letter on June 30, 2022, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC, and that the related trust is therefore tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
