Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Sullivan & Worcester LLP Savings and Investment Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1 - Description of the Plan

The following description of the Sullivan & Worcester LLP Savings and Investment Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored by Sullivan & Worcester LLP (the “Firm”). All non-lawyer staff employees, equity partners and certain income partners are eligible to participate in the 401(k) portion of the Plan on the first day of the month following their date of hire and other portions of the Plan upon completion of one year of service (“Participants”). Staff and associate attorneys (which term includes summer associates), seasonal employees, paralegal interns, Israeli law specialists, and (in general) income Partners and “counsel” attorneys, contractors, independent contractors and leased employees are not eligible to participate. Participants, excluding partners, are automatically enrolled in the Plan once they become eligible at a rate of 3% unless they elect otherwise. Employees deferring at a rate of less than 10% will have annual automatic increases in increments of 1% up to 10% of compensation unless they elect otherwise. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). As of December 31, 2024 and 2023, all Plan assets are held in a trust, the trustee of which is Charles Schwab Trust Bank (“Charles Schwab” or the “Trustee”). Substantially all investments are participant directed.

Administration of the Plan

The Plan is administered by the Retirement Plan & Benefits Committee, the members of which are appointed by the Firm.

Contributions

Participant Contributions

Participants may elect to contribute up to 100% of their gross compensation up to the maximum amount allowed for federal income tax purposes. These contributions, which may be pre-tax or Roth (at the participant’s election), are made by payroll deduction. Additionally, participants may elect, within certain limits, to have the Firm contribute amounts on an after-tax basis to the Plan instead of receiving such amounts directly. Participants may enter the Plan on the first day of the month following the completion of the eligibility requirement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Otherwise eligible partners and employees may also contribute amounts representing distributions from other tax-favored retirement vehicles (“Participant Rollovers”).

Firm Contributions

The Firm may contribute amounts on behalf of all participants on a discretionary basis. Contributions are allocated to those who are partners or employees on the last day of the Plan year (unless such contributions are required to satisfy top-heavy rules), and who have completed 1,000 hours of service for the Plan year. For the year ended December 31, 2024, a top-heavy contribution was made totaling \$205,446, net of forfeitures of \$5,352 applied.

Vesting

Participant Contributions

Participants are immediately vested in their own contributions plus earnings thereon.

Firm Contributions

Participants vest in Firm contributions and the related investment earnings based on years of continuous service. Participants become fully vested after three years of service. A participant also becomes fully vested upon reaching normal retirement age or upon death prior to termination of employment.

Participant Accounts

Each Participant's account is credited with the participant's contribution, the Firm's contributions and an allocation of Plan earnings or losses and revenue credits from certain investments (see Note 7 below), and may be reduced by participant transaction fees or administrative expenses associated with a participant's election to use the managed account service. Allocations are based on participant compensation, account balances or specific participant transactions, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Withdrawals and Distributions

In-service withdrawals from a participant's vested account balance are permitted from their Firm Contributions Account as of April 1 following the close of the Plan year in which the participant attains age 35 or completes 15 months of participation in the Plan. In-service withdrawals from a Participant's Rollover Account and/or Voluntary Contribution Accounts (after-tax) are permitted at any time. In-service withdrawals from all other sources are permitted upon the attainment of age 59½. In-service withdrawals are also permitted due to financial hardship, after exhausting the maximum amount available to the Participant as a loan under the Plan.

Participants are entitled to their total vested account balance upon death, retirement or termination of employment. Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the Participant's vested account balance or installment payments of such amounts at a frequency and duration as the participant or beneficiary may elect. If a participant's vested account is not more than \$1,000, the Plan administrator, after notification, may distribute the entire vested account balance to the participant. If a participant's vested account is greater than \$1,000 but not more than \$7,000, the Plan administrator, after notification, may distribute the entire vested account balance to an IRA rollover account in the participant's name.

In-Plan Roth Conversions

Participants may elect to convert all or a portion of their account in the Plan into a designated Roth account within the Plan, provided a participant is otherwise eligible to receive a distribution under the Plan (generally having attained age 59½). This will trigger income tax on the amount converted but the ten percent federal penalty tax will generally not apply.

Investments

Contributions are invested as directed by the participants individually in selected investment funds or self-managed brokerage accounts. Participants are allowed to invest up to 100% of their accounts in self-managed brokerage accounts. The self-managed brokerage accounts enable participants to invest in any publicly traded debt or equity security, corporate and U.S. government bonds, exchange traded funds, unit investment trusts, and shares of mutual funds.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000, and generally up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have two loans outstanding at any time. Principal and interest are paid through periodic payroll deductions. Loan terms range up to five years (or longer for the purchase of a primary residence). The loans are secured by the balance in the participant's account and bear interest at a rate as determined by the Plan administrator, based on prevailing interest rates.

Forfeitures

A participant who leaves the employment or otherwise ceases to perform services for the Firm forfeits any non-vested balance at the earlier of the last day of the Plan year in which five consecutive one-year breaks in service occur or the distribution (or deemed distribution) of the participant's entire vested account. Forfeitures are required to be used to restore forfeited contributions of returning participants, pay recordkeeping and other plan-level (non-investment) expenses and to reduce Firm contributions, in that order of priority. Forfeitures as of December 31, 2024 and 2023 totaled \$4,428 and \$14,115, respectively. During 2024, the Firm used \$19,957 of forfeitures to offset the 2023 contribution receivable. Subsequent to year-end, the Firm used \$5,352 of forfeitures to offset Firm contributions due for the year ended December 31, 2024.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

Investments, Investment Valuation and Income

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

Unit Values

Individual participant accounts for the common/collective trust accounts are maintained on a unit value basis. Participants do not have beneficial ownership in their specific underlying securities or other assets in these funds, but do have an interest therein represented by units valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

Contributions

Contributions from Plan participants and the contributions from the Firm are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Administrative Expenses

Except for certain participant transactional and managed account fees, the Firm pays all administrative and recordkeeping expenses directly. Investment management expenses of each of the investments offered under the Plan are borne by participants. All expenses paid by participants are regularly reviewed by the Plan Administrator.

Benefits Paid

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from the estimates that were used.

Plan Transfers

Transfers into this Plan came from the Sullivan & Worcester LLP Savings and Investment Plan for Associates in the amount of \$290,873.

Subsequent Events

The Plan administrator has evaluated subsequent events through October 14, 2025, the date that the financial statements were available to be issued. No matters of significance were identified for disclosure during this evaluation.

Note 3 - Information Certified by the Trustee and Custodian

Plan investments are held primarily in mutual funds, common/collective trusts and self-managed brokerage accounts by the Plan's trustee and custodian, Charles Schwab. The fair value of all investments as of December 31, 2024 and 2023, and all investment transactions for the year ended December 31, 2024, including interest and dividends, net appreciation in fair values, and information contained in the supplemental schedule of assets (held at end of year), and notes receivable from participants, are reported to the Plan and certified as complete and accurate by Charles Schwab. Participants in the Plan may direct contributions to any of a variety of investment options. The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common Stock: Valued at the closing price reported on the active market on which the individual securities are traded.

Corporate Bonds and Obligations of the U.S. Government or Its Agencies: Valued based on yields currently available on comparable securities of issuers with similar credit ratings. When quoted prices are not available for identical or similar bonds, the bond is valued under a discounted cash flow approach that maximizes observable inputs, such as current yields of similar instruments, but includes adjustments for certain risks that may not be observable, such as credit and liquidity risks.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Units in Common/Collective Trust: Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Stable Value Common/Collective Trust: A stable value fund that is composed primarily of indirect fully benefit-responsive investment contracts is valued at the NAV of units of the bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Self-managed Brokerage Assets: Consist of mutual funds, interest bearing cash, publicly traded limited partnership, and common stocks and are valued at quoted market prices reported on the active market on which the individual securities are traded, exchange traded funds and unit investment trusts are valued at NAV calculated daily and actively traded, and bonds are valued under a discounted cash flow approach.

Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 7 - Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by Charles Schwab. Charles Schwab is the Trustee and Custodian as defined by the Plan and, therefore, it is a party-in-interest. Fees paid by the Plan to Charles Schwab for administrative services primarily for managed account services and participant transaction fees amounted to \$47,173 for the year ended December 31, 2024. Fees for recordkeeping and other services are paid directly by the Firm. During the Plan year ended December 31, 2024, the Plan received \$41,971 of revenue credits from Charles Schwab, all of which was allocated to participants. In addition, notes receivable from participants qualify as exempt party-in-interest transactions, as defined by ERISA.

Note 8 - Plan Termination

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Firm may determine.

Note 9 - Tax Status

The Plan obtained its latest determination letter dated February 22, 2018, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
