### Opinion

## NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

---

### Note 1—Description of the Plan

The following description of the Restaurant Brands International Flexible Benefits Plan (the “Plan”) as amended and restated effective January 1, 2017 provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

*General* – The Plan is a health and welfare plan established June 11, 1971, to provide health and other benefits to eligible participants. The Plan is subject to the provisions of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. Eligible participants are employees of Restaurant Brands International, its subsidiaries, and affiliates (collectively, the “Company”), who have adopted the Plan. Effective January 1, 2005, the Plan was amended and restated to incorporate all group health and welfare benefit programs available to eligible employees, including certain former employees who may qualify for postretirement benefits. Effective September 30, 2011, the Plan was amended whereby the credited service for postretirement benefit obligations was frozen for all participants and all participants became fully eligible to receive benefits.

*Eligibility and Participation* – The Plan provides health, dental, vision, disability, and life insurance coverage to full and part time salaried employees, or any hourly-paid employees designated by the Company as eligible, their eligible spouses, domestic partners, and dependents. Former salaried employees who meet the eligibility requirements may be eligible for postretirement medical, dental and life insurance benefits.

*Benefits* – The Plan provides a comprehensive selection of health and welfare benefits including but not limited to self-insured and fully insured medical plan options, a dental plan, vision, life insurance and disability plans. A more detailed description of benefits under the Plan can be found in the Plan document.

*Contributions and Funding Policy* – The Plan provides participants with the ability to pay for certain benefits with pre-tax dollars based on the benefits selected by the employee. The employee contribution rates are determined annually by the Benefits Committee. The remaining cost is contributed by the Company. Beginning January 1, 2012, the annual employer-provided subsidy is \$160 (pre-age 65), \$80 (post-age 65), and \$120 (retiree and spousal split ages) per year of credited service (maximum of 30 years) to purchase postretirement coverage.

*Other* – The Benefits Committee has the right to alter, modify, or amend the Plan at any time.

### Note 2—Summary of significant accounting policies

*Basis of Accounting* – The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

*Investment Valuation and Income Recognition* – Investments held by the Plan are recorded at fair value. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction. A fair value hierarchy exists which requires an entity to maximize the use of observable inputs when measuring fair value.

### Note 2—Summary of significant accounting policies (continued)

Three levels of inputs may be used to measure fair value:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodology used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Money Market Funds* – This investment is valued using amortized cost to the extent that periodic fair value approximates market value. The amortized cost is provided by the administrator of the fund. The amortized cost is classified within Level 2 of the valuation hierarchy and is a high-quality money market fund which is based on the value of \$1.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of investments are recorded on a trade-date basis. Interest income, if any, is recorded on the accrual basis.

*Postretirement Benefit Obligation* – The amount reported as the postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the Plan sponsor.

The postretirement benefit obligation represents the amount that is to be funded by contributions from the Plan sponsor and from existing Plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date. Effective September 30, 2011, the valuation date has been frozen as of that date (see Note 1).

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

### Note 2—Summary of significant accounting policies (continued)

For measurement purposes, the per capita cost of covered healthcare benefits was assumed to decrease gradually from 6.4% for pre-65 and 6.1% for post-65 for a small group of pre-1987 employees who receive medical coverage to 3.7% in 2074 and expected to remain at that level thereafter. These assumptions are consistent with those used to measure the benefit obligation at December 31, 2023.

The following were other significant assumptions used in the valuation as of December 31, 2024 and 2023:

Mortality	Pri-2012 White Collar Dataset Mortality Tables projected forward using the IRS 2024 adjusted Scale MP-2021 on a generational basis, with sex-distinct employee rates before benefit commencement and annuitant rates after benefit commencement for 2024, and PRI-2012 White Collar Dataset Mortality Table projected forward using Adjusted Scale MP-2021 on a generational basis, with sex-distinct employee rates before benefit commencement and annuitant rates and after benefit commencement for 2023.
Weighted average discount rate	5.46% and 4.94% for 2024 and 2023, respectively.
Average retirement age	Based on probabilities of retirement that vary by age.
Marital status	60% of all participants not in pay status are assumed to be married to a spouse of the opposite sex. Males are assumed to be three years older than females for 2024 and 2023.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

*Other Benefit Obligations* – Benefit claims currently payable include the Plan's liability for claims incurred as of December 31, 2024 and 2023 but not reported, and the Plan's liability for claims reported as of December 31, 2024 and 2023 but not yet processed. The Plan's liability for claims incurred but not reported is estimated by the Plan's actuary utilizing actuarial methods which take into consideration prior claims experience and the expected time period from the date such claims are incurred to the date such claims are submitted and paid.

*Administrative Expenses* – Certain administrative costs arising under the Plan are paid by the Company. Reasonable expenses for administration of the Plan, may be paid from the assets of the Plan and certain administrative costs of the Plan were paid from the Plan's assets.

*Stop-Loss Insurance* – The Plan sponsor has obtained an applicable stop-loss insurance policy with deductible amounts of \$550,000 per participant for excess claim amounts as outlined within the executed policy document.

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, claims incurred but not reported, eligibility credits, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Note 3—Investment in trust fund

The Plan's investment assets are held in a trust account at U.S. Bank, National Association established by the Company and administered by U.S. Bank, National Association. The investment assets of the trust as well as the fair value hierarchy levels (described in Note 2) as of December 31 were as follows:

### Note 4—Administration of the Plan

For self-insured claims incurred, the Plan is administered by Blue Cross Blue Shield Insurance Company who has responsibility to determine the qualifications of claims submitted and the validity of continued benefit payments. Fully insured claims are administered by the insurance companies providing the coverage. The Plan is administered by the Plan's Benefits Committee of Restaurant Brands International.

### Note 5—Federal income tax status

The trust fund established under the Plan to hold the Plan's assets qualifies as an exempt organization under Section 501(c)(9) of the Internal Revenue Code ("IRC") of 1986, as amended.

The Internal Revenue Service has made a favorable determination in a letter dated January 31, 1978, that the trust meets the requirements of IRC Section 501(c)(9) and is, therefore, exempt from income tax under Section 501(a) of the IRC. The Company believes the trust, as amended, continues to meet the requirements of Section 501(c)(9) of the IRC and is exempt from income tax under Section 501(a) of the IRC.

### Note 6—Party-in-interest transactions

Transactions resulting in Plan assets being transferred to or used by a related party are prohibited under ERISA unless a specific exemption applies. U.S. Bank, National Association, is a party-in-interest as defined by ERISA. The Plan invests its assets through U.S. Bank, National Association. However, such transactions are exempt under Section 408(b)(8) and are not prohibited by ERISA. Administrative fees paid by the trust fund to U.S. Bank, N.A. amounted to \$5,625 for the year ended December 31, 2024. In addition, fees paid to Blue Cross Blue Shield Insurance Company for administration and benefit payments for self-insured claims amounted to \$1,008,303.

### Note 7—Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

Claim liabilities are recorded when it is probable that a claim has occurred, and the amount of the claim can be reasonably estimated. Liabilities include an amount for claims that have been incurred but not reported ("IBNR") representing principally medical services provided to covered participants prior to the fiscal year end which have not been submitted for payment to the administrator prior to December 31. The IBNR amount is actuarially determined by an analysis of past, current, and future estimated claim experience. The actuarial present value of accumulated plan benefits is reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions, in the near term, would be material to the financial statements.

### **Note 8—Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. Upon termination, the assets then remaining, if any, shall be subject to the applicable provisions of the Plan then in effect and shall be used until exhausted to pay benefits to employees in the order of their entitlement. Benefits earned through the date of termination to the extent they exceed the assets of the Plan will be funded by the Company.

### **Note 9—Benefit obligations**

The Plan's excess of benefit obligations over net assets at December 31, 2024, related primarily to the postretirement benefit obligation, is the funding which is not covered by the contribution rates provided by the current agreement. It is expected that the deficiency will be funded through future contributions from the Company and participants.

Assumed healthcare cost trend rates do not have a significant effect on the amounts reported for the postretirement healthcare plan as there was no change in cost trend rates for the year ended December 31, 2024.

### **Note 10—Subsequent events**

Management has evaluated subsequent events through October 14, 2025, in connection with the preparation of these financial statements, which is the date the financial statements were available to be issued.
