As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

(1) Description of plan

The following description of the Nipro PharmaPackaging Americas Corporation Non-Union 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator. The Plan was restated in January 2022.

General - The Plan is a defined contribution plan covering employees of Nipro PharmaPackaging Americas Corporation (the "Company" or "plan sponsor") who are not covered by a collective bargaining agreement and who are not nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions - Participants may contribute up to 100% of their pre-tax annual compensation as pre-tax contributions, as defined in the Plan document. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Additionally, participants aged 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan.

The Plan includes an auto-enrollment function whereby all newly eligible participants are automatically enrolled in the Plan unless otherwise requested by the employee. The deferral percentage for auto-enrolled employees is set at a fixed rate of 3% of the employee's compensation and will not increase in Plan years following the entry into the Plan.

The Plan requires the Company to make a fixed contribution, matching 100% of the participant contributions up to a maximum of 3% of compensation for each payroll, as defined by the Plan. The Company may make additional profit sharing contributions using a formula that considers the combined age and service of each participant for an annual profit sharing contribution ranging between 1% and 11% of compensation. For the year ended December 31, 2024, there were \$577,542 of employer matching contributions and \$1,201,626 of profit sharing contributions.

Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

Participant investment account options - Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds and one group annuity contract as investment options for participants.

Participant accounts - Each participant's account is credited with the participant's contribution and an allocation of the Company's contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based upon participant earnings, participant contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants' contributions and actual earnings thereon are 100% vested immediately. Vesting in the Company's matching and profit sharing portion of participant accounts, plus actual earnings thereon, is as follows:

Participants who are terminated as a result of any future plant closing and a reduction in force will become fully vested in all accounts.

Notes receivable from participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Participants may only have one loan balance outstanding at any given time, and loan terms cannot exceed five years unless used for the purchase of a primary residence. The loans are secured by the balances in the participants' accounts and bear interest at rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits - On termination of service due to death, disability, or retirement, a participant or their beneficiary(ies) may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account, or annual installments over a ten-year period. The Plan also allows in-service hardship distributions upon the participant experiencing a qualified hardship event. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If the participant's account balance is over \$7,000, he or she may elect to leave his or her account in the Plan until he or she reaches the later of retirement or age 72. Participant balances under \$7,000 can be forced out of the Plan at the plan sponsor's discretion.

Forfeited accounts - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,627 and \$10,324, respectively. These accounts will be used to reduce future employer contributions or pay plan expenses. Employer contributions were reduced by \$53,616 from forfeited nonvested accounts for the year ended December 31, 2024.

(2) Summary of significant accounting policies

Basis of accounting - The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

(2) Summary of significant accounting policies (continued)

Investment valuation and income recognition - Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions - Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

Payment of benefits - Benefits are recorded when paid.

Administrative expenses - Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits.

(3) Information prepared and certified by the trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC ("Empower") (trustee and recordkeeper for the Plan) and Empower Annuity Insurance Company of America ("Empower Annuity") (custodian for group annuity contract).

(4) Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification ("ASC") Topic 820, "Fair Value Measurements and Disclosures," provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

(4) Fair value measurements (continued)

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The investments at fair value as of December 31, 2024 and 2023, totaled \$32,876,493 and \$28,076,767, respectively, and consist exclusively of mutual funds that are valued at Level 1 within the fair value hierarchy.

(5) Investment contract with an insurance company

The Plan entered into a fully benefit-responsive group annuity contract with Empower Annuity. Empower Annuity maintains the contributions in a general account. The account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement for the group annuity contract. Contract value, as reported to the Plan by Empower Annuity, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

(5) Investment contract with an insurance company (continued)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable to occur that might limit the ability of the Plan to transact at contract value with the contract issuer, and that would limit the Plan to transact at contract value with the participants.

(6) Related-party transactions and party-in-interest transactions

Certain Plan investments are shares of funds managed by Empower. Empower is the trustee, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Fees paid from the Plan to the trustee for the year ended December 31, 2024, were \$94,823.

(7) Excess contributions refundable

The Plan failed its discrimination testing for the years ended December 31, 2024 and 2023. As of December 31, 2024 and 2023, excess contributions refundable of \$13,789 and \$29,360, respectively, have been recorded as liabilities in the accompanying statements of net assets available for benefits. Refundable amounts are recorded as a reduction to participant contributions on the statement of changes in net assets available for benefits in the year the amounts were originally contributed. The Plan distributed the excess contributions to the affected participants in the following years.

(8) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

(9) Tax status

On November 14, 2022, the Internal Revenue Service ("IRS") stated in an advisory letter that the volume submitter plan document adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC and, therefore, the related trust was exempt from taxation. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that "more likely than not" would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(10) Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(11) Transfer out/to related plan, net

The Company sponsors another defined contribution plan benefiting employees who are covered by collective bargaining agreements. When a participant changes job classifications, the participant's account is transferred to the appropriate plan, as necessary. The Company transferred \$74,502 to and \$1,991 from Nipro PharmaPackaging Americas Corporation Union 401(k) Plan to this Plan as a result of the job classification clause.

(12) Subsequent events

The Plan has evaluated subsequent events through September 9, 2025, which is the date the financial statements and supplemental schedule were available to be issued.
