I write in connection with the Form 5500 that Daybright Financial (“Daybright”) is preparing and filing on behalf of Blackfish Federal, LLC (“Blackfish”). Blackfish understands that the filing will be made on or before October 15, 2025, but that Daybright Financial specifically notifies Blackfish that the filing will need to be amended subsequent to the issuance of an audit report regarding Blackfish’s financial records and Daybright reviewing said audit report.¹

Blackfish understands that the audit report would normally be filed with the Form 5500. The audit report is not yet prepared in light of the unusual factual circumstances surrounding Blackfish’s ownership, as explained below.

Blackfish was sold in December 2023, with a majority of its equity being acquired by Anglin Consulting Group, Inc. (“ACG”). Two lenders (hereinafter, the “Funds”) combined to lend \$14,500,000 to ACG in connection with the acquisition of Blackfish’s equity. In the first half of 2025, ACG defaulted, and the Funds obtained judgments against ACG. In connection with those judgments, the Funds were awarded, by an August 8, 2025 Court order after a contested hearing, ACG’s equity in Blackfish, such that Blackfish’s ownership and governance were taken over by the Funds with no cooperation from ACG (which, itself, had only owned Blackfish equity for approximately a year and a half, and which subsequently filed for bankruptcy). Thus, the TPA and the recordkeeper changed in 2024 after ACG took over Blackfish, and then changed again after August 8, 2025, when the Funds took over Blackfish under contested, litigious circumstances.

Accordingly, the Funds, having only gained control of Blackfish in August 2025, and under circumstances where they had extremely limited access to Blackfish’s financial records, were not in a position to cause the audit report to be completed by October 15, 2025. The Funds are, of course, committed to honor and maintain the retirement plan on behalf of Blackfish’s employees.

I will send the audit report as soon as it is prepared. Thank you.
