Basis for Opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

General

The Schuyler Hospital Employee Retirement Savings Plan (the Plan) is a defined contribution plan covering all employees of Schuyler Hospital, Inc. (Schuyler or Employer) who are age twenty-one (21) or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The following description of the Plan provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

Administration

The Plan is administered by management who are appointed by authorized officers of Schuyler. Management administers the Plan in accordance with its terms and applicable laws and has all necessary and appropriate powers to carry out the provisions of the Plan. Newport Trust Company, LLC (NTC) is the custodian of the Plan's assets. NFP Corporate Services, LLC was the third-party administrator of the Plan during 2023. Effective January 1, 2024, Newport Group, Inc. is the third-party administrator of the Plan. Newport Group, Inc. provides recordkeeping services to the Plan.

Eligibility

Participants may become eligible for employer contributions after the attainment of age 21. For elective deferrals made by the participant, the eligibility requirements are age 21.

Contributions

Participants may make voluntary contributions subject to certain limitations of the Plan and Internal Revenue Code (the Code). In addition, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement accounts (rollover), subject to approval by the Plan Administrator. In addition, as of July 1, 2024, the Plan was restated, and participants have the option to elect to have Roth 401(k) contributions made to the Plan. Roth 401(k) contributions are includable in a participant's taxable gross income for the year in which the contribution is made.

The Plan provides for safe harbor matching contributions of 100% of a participant's pre-tax contributions up to 3% of the participant's compensation, plus 50% of the participant's pre-tax contributions up to an additional 2% of compensation.

Participant Accounts

Participants direct the investment of their vested contributions and Schuyler's contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions, Schuyler's contributions, any allocations of Plan earnings or losses, and any applicable administrative expenses. Participants direct the investment of the contributions into various options offered by the Plan.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their voluntary contributions and safe harbor contributions plus earnings and losses thereon. Prior to July 1, 2024, participants became fully vested in Schuyler's profit sharing contributions plus earnings and losses thereon after three years of service.

Payment of Benefits

Upon termination of service due to death, retirement or other reasons, a participant or beneficiary will receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum payment.

Hardship Withdrawals

Participants may receive distributions up to 100% of their elective deferral account balance in the form of a hardship withdrawal upon meeting financial hardship requirements outlined in the Plan document.

Notes Receivable from Participants

Plan participants may borrow up to the lesser of \$50,000, or 50%, of the amount of the participant's vested interest in the Plan and have a maximum of one outstanding loan. The minimum loan amount is \$1,000. Notes receivable from participants are secured by their account balances and bear interest at the prime rate plus 1% on the date of the loan.

Forfeitures

Forfeitures of non-vested discretionary contribution accounts can be used to reduce Plan fees. There were no forfeitures used to reduce Plan fees for the years ended December 31, 2024 and 2023. There were no balances remaining of forfeited non-vested discretionary contribution accounts at December 31, 2024 and 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment valuation and Income Recognition

The Plan's investments in mutual funds are stated at fair value, based on quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's investments in group annuity contracts are fully benefit-responsive and are stated at contract value. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

All investments are participant directed. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC Section 820 are described below:

- Level 1 - Valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations are based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations are based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The valuation methodology used for mutual funds, which are measured at fair value, is based on the quoted market price of shares held at year end. Mutual funds are considered Level 1 inputs.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no changes in the valuation methodologies used during 2024 or 2023.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the financial statements.

Payment of Benefits

Benefit payments to participants are recorded when paid.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Expenses

The Plan's expenses are paid by the Plan and allocated to the participants' accounts, as provided by the Plan document. Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are recorded as a reduction to additions in the accompanying statements of changes in net assets available for benefits.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan has a fully benefit-responsive group annuity contract with MetLife, which is included in the financial statements at contract value for the years ended December 31, 2024 and 2023. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. There are no redemption restrictions or unfunded commitments related to the group annuity contract.

The strategy for having this investment option is to provide safety and stability by preserving principal and accumulated earnings this investment. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment to non-competing funds at contract value. MetLife is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The Plan Administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

6. PLAN TERMINATION

While Schuyler has not expressed any intent to discontinue the Plan, it has the right to do so at any time, subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts.

7. TAX STATUS

The Plan adopted a pre-approved plan offered by Newport Group Inc. The pre-approved plan received an IRS Opinion Letter dated November 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

7. TAX STATUS (Continued)

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. PARTY-IN-INTEREST TRANSACTIONS

NTC is the trustee and custodian of the Plan's assets. NFP Corporate Services, LLC was the third-party administrator of the Plan during 2023. Effective January 1, 2024, Newport Group, Inc. is the third-party administrator of the Plan. Newport Group, Inc. is the recordkeeper, and Schuyler is the Plan Sponsor. As such, transactions between NTC, NFP Corporate Services, LLC, Newport Group, Inc., Schuyler, and the Plan qualify as party-in-interest transactions. Additionally, notes receivables from participants qualify as party-in-interest-transactions.

9. RECONCILIATION TO FORM 5500

While total net assets available for benefits and the change in net assets available for benefits agree between the financial statements and Form 5500 as of and for the years ended December 31, 2024 and 2023, certain classifications differ between the financial statements and Form 5500.

10. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, participants in the Schuyler Hospital Employee Retirement Savings Plan became eligible for benefits under the Cayuga Health 403(b) Plan. In accordance with a corporate resolution approved by the Plan Sponsor on December 12, 2024, the Schuyler Hospital Employee Retirement Savings Plan's assets and liabilities held with NTC were frozen to new contributions as of December 31, 2024. These assets and liabilities will be transferred to Transamerica for recordkeeping and trustee and custodial services, and a new frozen Plan will be named the Cayuga Health 401(k) Plan.

These changes occurred subsequent to year-end and did not affect Schuyler Hospital Employee Retirement Savings Plan's financial position as of December 31, 2024.
