Independent Auditors' Report

To the Trustees of
Royal Neighbors of America 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Royal Neighbors of America 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section :

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A | DESCRIPTION OF THE PLAN

The Royal Neighbors of America 401(k) Retirement Plan (the Plan) is a defined contribution plan available to all eligible employees of Royal Neighbors of America (the Society). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following description of the Plan provides only general information. Participants should refer to the pamphlet *Royal Neighbors of America 401(k) Retirement Plan* for a more complete description of the Plan's provisions. Copies of the pamphlet are available from the plan administrator.

1. Contributions

Eligible participants may contribute 100% of their compensation to the plan annually, subject to maximums imposed by law. The maximum deferral is \$ 23,000 and \$ 22,500 in 2024 and 2023, respectively, with the option of an additional \$ 7,500 catch-up deferral for 2024 and 2023, for those 50 years of age or older. Contributions of 2% of each eligible participant's compensation are made each year by the Society, in addition to the Society matching 100% of the first 4% of employee contributions. An additional discretionary employer contribution of up to 3% of each eligible participant's annual compensation will be contingent upon approval by the Board of Directors subsequent to the end of each year. At the February 19, 2024, meeting of the Board of Directors, a discretionary employer contribution of 2.70% was approved. A discretionary employer contribution of 1.90% was also approved in 2023.

2. Participant Accounts

Each participant's account is credited with employee and employer contributions and an allocation of Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Forfeitures of employees' non-vested accounts are applied to reduce the Society's expenses as described in the Plan.

3. *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Immediate vesting occurs with respect to the Society's regular and matching contributions. Vesting in the Society's discretionary employer contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100% vested after three years of credited service with regards to the discretionary contribution.

4. *Forfeitures*

The Plan applies forfeited non-vested account balances to reduce administrative expenses and employer contributions. In 2024 and 2023, the Plan realized \$ 3,383 and \$ 14,766 of non-vested forfeited contributions, respectively. During 2024 and 2023, the Plan used \$ 3,383 and \$ 14,766, respectively, to reduce administrative expenses and employer contributions. There was no non-vested forfeiture account balance as of December 31, 2024 and 2023.

5. *Withdrawals*

Upon retirement (normally age 65), permanent disability, or death, the participant will automatically become fully vested in their account and the participant or his/her beneficiaries, as applicable, may receive a lump-sum payment equal to the value of the account. On termination of service, a participant may receive a lump-sum amount equal to the vested value of his or her account. Certain other withdrawals are permitted in the event of financial hardship, as defined in the Plan agreement.

6. *Participant Notes Receivable*

Participants may borrow from their fund accounts a minimum of \$ 1,000, up to a maximum of the lesser of \$ 50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear an interest rate that ranges from 4.25 – 9.50%, which is commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deduction.

7. *Plan Termination*

Although it has not expressed any intent to do so, the Society has the right to terminate the Plan in whole or part at any time subject to the provisions of ERISA. In the event of termination of the Plan, the participant accounts will be 100% vested and nonforfeitable.

NOTE B | SUMMARY OF ACCOUNTING POLICIES

1. Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

2. Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for a discussion of fair value measurement.

The change in the difference between fair value and the cost of investments is reflected in the statement of changes in net assets available for benefits as unrealized appreciation (depreciation) of investments. Realized gains and losses on sales of investments are determined on the basis of specific identification of investments. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

3. Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances, plus any accrued but unpaid interest.

4. Administrative Expenses

The Plan is administered by the Society. Certain administrative expenses of the Plan are paid by the Society and the Society also provides certain administrative services, which have not been charged to the Plan. The cost of such services has not been determined.

Fees related to the administration of notes receivable from participants and member requested services are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

5. Benefits

Benefits are recorded when paid.

6. *Use of Estimates*

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

7. *Subsequent Events*

Management has evaluated subsequent events for recognition and disclosure in the financial statements through October 14, 2025, which is the date the financial statements were available to be issued. Through October 14, 2025, no subsequent events required recognition or disclosure in the financial statements.

NOTE C | FAIR VALUE MEASUREMENTS

The Plan follows the fair value measurement guidance for financial assets and financial liabilities. This guidance defines fair value, establishes a framework for measuring fair value and expands disclosure about fair value measurements.

Fair value is defined to be the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between the market participants at the measurement date. A three-level hierarchy has been established for fair value measurements based upon the inputs to the valuation of an asset or liability as follows:

Level 1 - Valuation is based on quoted prices for identical assets and liabilities in active markets.

Level 2 - Valuation is derived from inputs other than quoted prices included in Level 1, which are observable for the asset or liability either directly or indirectly. Investments classified as Level 2 are generally valued by benchmarking model-derived prices to quoted market prices and trade data for identical or comparable securities. The significant inputs used in this approach include interest rates, prepayment timing, yield spreads, maturities, credit losses and credit ratings of the securities.

Level 3 - Valuation is derived from unobservable inputs that are not corroborated by market data.

NOTE C | FAIR VALUE MEASUREMENTS

The Plan offers a guaranteed interest account, which is non-benefit-responsive, representing investments in the general account of Principal Life Insurance Company (Principal). The guaranteed interest account is stated at fair value as reported by Principal. The general account fair value is the amount plan participants would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity for an event other than death, disability, termination, or retirement. This fair value represents contract value adjusted to reflect current market interest rates only to the extent such market rates exceed contract crediting rates.

The Plan's investments in registered investment companies consist of mutual funds valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan's investments in units of pooled separate accounts held with an insurance company are stated at estimated fair market value and are valued by the insurance company based on the net asset value of units held by the Plan at year end. The net asset value is determined by the insurance company based on the market value of the underlying investments held in the pooled fund.

The Plan has investments in a collective trust fund. These investments are reported at the Plan's proportionate share of the NAV (or its equivalents) as provided by the management of the trust.

NOTE D | INVESTMENTS IN ENTITIES THAT CALCULATE NET ASSET VALUE PER SHARE

As a part of the Plan's investment portfolio, there are certain investments made in entities in which purchases and withdrawals are not made in an open market. Instead, the purchases and withdrawals occur with the entities, and in certain circumstances, those transactions are entirely controlled and/or restricted by the entities. The fair values of these investments are determined by the management of Principal and are reported to the Plan as the Plan's proportionate share of the NAV of the entities. The NAV is based on the fair value of the underlying investments held by the funds, less their liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

NOTE F | INCOME TAX STATUS

The Society has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G | RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H | TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain Plan investments are units of the pooled separate accounts and insurance company general accounts managed by Principal Life Insurance Company (Principal). Fees paid by the Plan to Principal for investment management and administrative services amounted to \$ 65,305 and \$ 53,999 for the years ended December 31, 2024 and 2023, respectively. The Society pays for CAPTRUST consulting fees that also qualify as party-in-interest transactions.
