## Independent Auditor's Report

To the Plan Administrator

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Brooklyn Plaza Medical Center 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). ## Notes to Financial Statements December 31, 2024

### Note 1 - Description of Plan

The following description of Brooklyn Plaza Medical Center 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution retirement plan covering all eligible employees age 18 or older of Brooklyn Plaza Medical Center, Inc. (the "Center"). Employees covered by a collective bargaining (union) agreement, acquired employees, as defined, and nonresident aliens are excluded from participating in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator is responsible for oversight of the Plan. The Plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### Contributions

Each year, participants may make salary deferral contributions to the Plan based upon a percentage of their pre-tax annual compensation, as defined in the Plan. Eligible employees may begin to make salary deferral contributions to the Plan on the first day of the month following the completion of one month of service. Participants may elect to designate all or a portion of their salary deferral contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds, a money market fund and a common collective trust fund as investment options for participants.

The Center may, at its discretion, make flexible matching contributions to the Plan. Participants must have completed a year of service and be actively employed on the last day of the Plan year to be eligible to receive any discretionary flexible matching contributions. For the year ended December 31, 2024, the Center elected not to make any discretionary flexible matching contributions to the Plan. The Center may, at its discretion, also make nonelective contributions to the Plan. Participants must have completed a year of service and be actively employed on the last day of the Plan year to receive an allocation of any discretionary nonelective contributions. Terminated participants may also share in an allocation of any discretionary nonelective contributions provided they have completed 1,000 of service during the year. For the year ended December 31, 2024, the Center elected not to make any discretionary nonelective contributions to the Plan. Participants also direct the investment of any Center contributions. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

#### Participant accounts

Each participant's account is credited with the participant's contributions and any discretionary flexible matching contributions, as well as an allocation of any discretionary nonelective contributions and Plan earnings. Participant accounts are also charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their salary deferral and rollover contributions plus actual earnings thereon. In the event of termination due to death, total and permanent disability, or normal retirement, participants shall become 100% vested in the Center's contribution portions of their account. For all other participants, vesting in the Center's matching contribution portion of their account is based on credited years of service, as defined in the Plan, according to the following schedule:

#### Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account. The loan interest rate, determined monthly, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

#### Payment of benefits

Upon termination of service for any reason, a participant or beneficiary may elect to receive his or her vested account balance as a lump-sum distribution, as partial withdrawals or in substantially equal installments. A participant or beneficiary with a vested account balance less than \$1,000 will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For a participant or beneficiary with a vested account balance greater than \$1,000, but less than \$5,000, who elect not to receive a lump-sum distribution, the Plan administrator will make a direct rollover of the participant's account to an individual retirement account designated by the Plan administrator. Participants with a vested account balance greater than \$5,000 may defer payment of benefits until a later date.

Withdrawals from a participant's salary deferral, Center contributions and rollover account may also be made for a financial hardship, in accordance with the provisions of the Plan. Participants may make withdrawals from the rollover portion of their account at any time.

#### **Forfeited accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$20,225 and \$8,583, respectively. These forfeited nonvested accounts will be used to reduce future employer contributions or to pay Plan administrative expenses. There were no amounts utilized from forfeited nonvested accounts during the year ended December 31, 2024.

#### **Note 2 - Summary of accounting policies**

##### **Basis of accounting**

The Plan's financial statements have been prepared on the accrual basis of accounting.

##### **Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the trustee and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold, as well as held during the year.

##### **Contributions**

Contributions from Plan participants and any flexible discretionary matching contributions from the Center are recorded in the year in which the employee contributions are withheld from compensation. Any nonelective contributions from the Center are recorded in the year in which the contributions are earned.

##### **Payment of benefits**

Benefits are recorded when paid.

##### **Noninterest-bearing cash**

Assets of the Plan that are not invested by the trustee and custodian may, at times, be temporarily held in a noninterest-bearing cash account. These temporary cash accounts are not subject to federally insured limits. The Plan has not experienced any losses in such accounts. The Plan believes it is not exposed to any significant credit risk on cash.

##### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

##### **Expenses**

Certain expenses to maintain the Plan are paid by the Plan, unless otherwise paid by the Center. Expenses that are paid by the Center are excluded from these financial statements. Fees related to distributions, certain accountant maintenance fees, and an asset-based third-party administration fee are charged directly to the participant's account and are included in administrative expenses. Other indirect investment related expenses are included in the net appreciation in fair value of investments.

#### Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Subsequent events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

#### Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability; and
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market fund:* Valued at the daily closing price as reported by the funds. The mutual funds and money market fund held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

*Common collective trust fund:* Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the trustee of the fund reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### Note 4 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2024 and 2023, and investment income for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Mid Atlantic Trust Company dba American Trust Custody, the trustee and custodian of the Plan.

#### Note 5 - Plan termination

Although it has not expressed any intent to do so, the Center has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Center contribution portions of their account.

#### Note 6 - Tax status

The Plan has been designed using a non-standardized pre-approved defined contribution plan document sponsored by Mutual of America Life Insurance Company. Mutual of America Life Insurance Company received an opinion letter dated November 30, 2020, in which the Internal Revenue Service ("IRS") stated that the non-standardized pre-approved defined contribution plan document, as then designed, was in compliance with the applicable requirements of IRC. Although the Plan itself has not received a determination letter from the IRS, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7 - Related party transactions and party-in-interest transactions**

Plan investments include mutual funds, a money market fund and a common collective trust fund held by Mid Atlantic Trust Company dba American Trust Custody, the trustee and custodian of the Plan. Mutual of America Life Insurance Company is the Plan's recordkeeper and is responsible for managing the notes receivable from participants. Transactions with these service providers qualify as party-in-interest transactions. Direct expenses paid from Plan assets to these service providers for certain administrative expenses were \$30,904 for the year ended December 31, 2024. Indirect fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments. The Plan sponsor pays directly any other fees related to the Plan's operations. The Plan allows participants to take loans against their account balances, which are also considered party-in-interest transactions.

#### **Note 8 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 9 - Nonexempt transactions**

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), certain salary deferral contributions were not remitted to the Plan within the time frame specified by DOL Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Center for the year ended December 31, 2024. These delinquent participant contributions pertain to payroll periods during the years ended December 31, 2019, 2021 and 2023. The Center made a corrective contribution of lost earnings that was deposited into the Plan and allocated to the affected participants in October 2025. The Center believes that these transactions should not affect the tax-qualified status of the Plan.
