Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the SMART Plan for Employees of the Chamber of Commerce of the United States of America (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Notes to Financial Statements

December 31, 2024

1. Description of Plan

The following is a brief description of the SMART (Save Money and Reduce Taxes) Plan (the Plan) for Employees of the Chamber of Commerce of the United States of America (the Chamber and the Chamber Affiliates), which is the plan sponsor. The Plan became effective on October 1, 1984, and has been subsequently amended. This description is provided for general information purposes only. Participants should refer to the plan document and summary plan description for a complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

The Plan is a defined contribution savings plan, pursuant to the provisions of Section 401(k) of the Internal Revenue Code (the IRC). The Plan is administered by the Retirement Committee of the Chamber, the members of which are appointed by the Chamber. Fidelity Management Trust Company (the Trustee or Fidelity) and Fidelity Workplace Services LLC serves as the trustee and recordkeeper, respectively, of the Plan.

The Plan is subject to the reporting and disclosure requirements, the participation and vesting standards, and the fiduciary responsibility provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

All employees of the Chamber and its affiliates are eligible to participate in the Plan at any time on and after their hire date. Leased employees and independent contractors are not eligible.

Contributions and Participant Accounts

Employees can elect to contribute from 1% to 100% of compensation directly to their accounts within the Plan up to the federal maximum dollar limit. Participants have the ability to change or terminate their contribution at any time.

1. Description of Plan (continued)

If participants are at least 50 years old on or before the close of the calendar year (December 31), they may elect to make an additional pretax contribution called a “catch-up” contribution. To be eligible to make a catch-up contribution, participants must contribute the maximum permissible as a regular pretax contribution for the year under the terms of the Plan. The additional catch-up contribution maximum is adjusted annually by federal regulations.

The Chamber will match 100% of the first 4% of compensation that an employee contributes to the Plan.

Employees hired on or after January 1, 2006, are eligible for a Chamber Funded Contribution after one year of service. This Chamber Funded Contribution is in addition to all other matching contributions that an employee hired after January 1, 2006, also receives. The Chamber Funded Contribution is 2.5% of compensation for employees with less than three years of service and 6.5% of compensation for employees with more than three years of service.

Participants’ accounts are credited with the participants’ and Chamber’s contributions and allocated plan earnings.

Participants may direct the Trustee to invest their accounts in any of the registered investment companies and a common/collective trust funds.

Vesting

Participants are immediately vested in their contributions and Chamber-matching contributions plus actual earnings thereon. The vesting for the Chamber Funded Contribution is on a three-year cliff vesting schedule.

Forfeitures

Upon termination of employment, participants forfeit their nonvested balances. If a participant is rehired within a five-year period, the forfeited contributions are reinstated. Forfeited balances of terminated participant’s nonvested accounts are used to reduce future company contributions. Unallocated forfeitures balances as of December 31, 2024 and 2023, were \$ 29,429 and \$35,000, respectively, and \$56,500 of forfeitures were used to reduce company contributions for 2024.

1. Description of Plan (continued)

Participant Loans

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested account balance or \$50,000. A participant may have only one loan outstanding at any time. The Trustee, upon application by a participant, may make a loan to a participant for any reason. The period of repayment for any loan shall not exceed five years, other than the period of repayment for a loan used to purchase the participant's principal residence, which may be up to ten years. The loans are secured by the balance in the participant's account. Loan repayments, both principal and interest, are made through ACH payments on a monthly basis or at least quarterly. Each loan shall bear an interest rate equal to the prime rate plus 1%. If a participant terminates employment and has an outstanding loan, he or she may elect to continue to repay the outstanding loan balance based on the same payment frequency as in effect prior to termination of employment.

Payment of Benefits

Upon separation from service with the Chamber due to death, disability, retirement or termination, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or maintain his or her balance in the Plan or roll it over into an individual retirement account or another eligible retirement plan. The Plan also allows in-service withdrawals and hardship withdrawals under certain circumstances.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Chamber, as provided by the Plan's provisions. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate.

Plan Termination

Although it has not expressed any intent to do so, the Chamber has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, all participants will become fully vested in their accounts as of the date of such termination.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are presented on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

Investments in shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

The Fidelity Managed Income Portfolio Fund, a common/collective trust fund, invests in fully benefit-responsive guaranteed investment contracts. This fund is recorded at fair value, using net asset value (NAV) as the practical expedient (see Note 4).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by the Trustee.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
 - Quoted prices for similar assets and liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in markets that are not active

4. Fair Value Measurements (continued)

- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

The following tables set forth by level, within the fair value hierarchy, the Plan’s assets carried at fair value as of December 31, 2024 and 2023.

⁽¹⁾This category includes a common/collective trust fund that is designed to deliver safety and stability by preserving principal and accumulating earnings. This fund is primarily invested in guaranteed investment contracts and synthetic investment contracts. Participant-directed redemptions have no restrictions; however, the Plan is required to provide a one-year redemption notice to liquidate its entire share in the fund. The fair value of this fund has been estimated utilizing net asset value as reported by the issuer of the fund as a practical expedient. The net asset value approximates the contract value.

In accordance with ASU 2015-07, *Disclosures for Investments in Certain Entities that Calculate Net Asset Value Per Share*, as the Plan has elected to use the practical expedient for the fair value measurement of its common/collective trust that does not have readily determinable fair market value, the Chamber has not included this investment in the fair value hierarchy. The fair value of the participation units in the common/collective trust is based on quoted redemption values. Participation units in the common/collective trusts are generally redeemable upon request.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Related-Party Transactions

Certain Plan investments are in shares of registered investment companies or a common/collective trust managed by the Trustee. Therefore, the transactions in these funds qualify as party-in-interest transactions for which a statutory exemption exists.

7. Income Tax Status

The Plan received a determination letter from the Internal Revenue Service (IRS) dated February 9, 2017, stating that the Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. Subsequent to the receipt of the determination letter, the Plan was amended and restated. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code, and therefore, believes the Plan, as amended and restated, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Subsequent Events

Management evaluated subsequent events for the Plan through October 10, 2025, the date the financial statements and supplemental schedule were available to be issued.
