Opinion

We have audited the financial statements of Telemedik Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024, and 2023 and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Telemedik Retirement Plan as of December 31, 2024, and 2023, and the changes in its net assets available for benefits for the years ended December 31, 2024, and 2023, in accordance with accounting principles generally accepted in the United States of American.

Basis for Opinion

1. Description of the Savings Plan

TELEMEDIK RETIREMENT PLAN is a contributory, defined contribution plan established by **Jaye, Inc.**, (the Plan), to encourage among employees a team working relationship and a genuine interest and loyalty to the Company. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's investments are principally held in mutual funds administered on a discretionary basis by the Banco Popular Trust Division (the Trustee) (a party-in-interest). The Plan and the Trust were established on October 1, 2006.

The main provisions of the Plan, which has been established for the exclusive benefit of the employees and/or their beneficiaries, are as follows:

Contributions to the Plan:

Participants may elect to make contributions Pre-Tax and/or After-Tax contributions. Pre-Tax may not exceed the lesser of 10% of total compensation or \$23,500, or any limit established under Puerto Rico Internal Revenue Code of 2011, as amended. After-Tax contributions may not exceed 10% of the aggregate compensation paid to the employee during all the years he or she has been a plan participant. The employer will make a matching contribution equal to 50 cents of each dollar of a participant's pre-tax contributions, not to exceed \$3,000 per employee. However, the employer will not make matching contributions above 4% of the participant's eligible compensation as defined, for matching and profit-sharing contribution.

Benefits to Participants:

Benefits to participants are recorded as a deduction during the period in which they are paid.

Eligibility:

All employees with 3 months of service and 21 years of age are eligible to participate in the Plan.

Participant's Individual Account:

Each participant's individual account is adjusted with the corresponding portion of; Company's contribution, participants' contributions, plan's gains or losses and participation of nonvested individual accounts of participants terminated. The benefits to which the employee has rights are limited to the amount of his/her individual account.

1. Description of the Savings Plan (continued)

Retirement Benefits:

Upon termination of employment, participants may elect to receive the value of their accumulated plan benefits, in accordance with the provisions of the Plan, in a lump-sum distribution or in an alternative manner mutually agreed-upon by the participant and the administrative committee. In addition, hardship withdrawals can be made by participants in the Plan.

Vested Benefits:

A participant's vested rights to his/her accrued benefit account under the Plan are determined in accordance with the following table:

Trustee of the Plan:

The Plan has a trust agreement with Banco Popular, Trust Division, which is considered a party-in-interest to the Plan, for the handling of the Cash or Deferred Profit-Sharing Plan's funds available for investments.

Basis of Accounting:

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Uses of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities at the date of financial statements and the

reported amounts of additions and deductions to net assets during the reporting period. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies

Investment Valuation and Income Recognition:

The Plan's investments in the mutual funds are stated at fair market value as determined by quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction market participant at the measurement date.

Investment Valuation and Income Recognition:

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investment bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are paid when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Excess Contributions Payable:

Amounts payable to participants for contributions in excess as amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits:

Benefits are recorded when paid.

Plan Administration Cost:

The Plan sponsor absorbs a significant portion of the administrative cost of the plan.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liability (level 1) and the lowest priority to unobservable inputs (level 3). The three level of fair value hierarchy under FASB ASC 820 are describe below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan could access.

Level 2 Inputs to the valuation's methodology include:
Quoted prices for similar assets or liabilities in active markets:
Quoted prices for identical or similar assets or liabilities in inactive markets:

Inputs other than quoted prices that are observable for the asset or liability.

Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liabilities' s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuations techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measures at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. Plan Termination

Although it has not expressed any intent to do so, the Plan's sponsor has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the regulations of ERISA. In the event of the Plan's termination, participants will become 100% vested in their accounts.

5. Forfeitures

The forfeitures will be first applied to reduce administrative expenses and then to reduce the Employer Profit Sharing Contribution and/or the matching contribution. In 2024, \$1,695 were used for this purpose and \$8,147 in 2023.

6. Administrative expenses

Administration, participants and assets fees are assessed by the third-party administrator and by the Plan trustee. They are accounted for on a cash basis in Form 5500.

7. Tax status

The Plan obtained a determination letter dated April 13, 2015, in which the Puerto Rico Department of Treasury stated that the amendments submitted by the Plan, continued to qualify under Section 1165(a) of the Puerto Rico Internal Revenue Code of 2011 (the Code).

7. Tax status (continued)

U.S. GAAP require plan management to evaluate tax position taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position to more likely than not would be sustained upon examination by the tax authorities. The plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for the year prior to December 31, 2020.

8. Management Review of Financial Statements

The Company performed an assessment of subsequent events through October 9, 2025, the date the financial statements were available to be issued and determined that no subsequent events have occurred requiring adjustments to the financial statements or disclosures.

9. Related Party Transactions and Party-in-Interest

The plan sponsor paid certain expenses related to the plan (auditor's fees and bond charges). These are related party transactions. The plan paid for the trustee fees. The plan has several services providers. Providers are parties in interest under ERISA.

10. Risks and Uncertainties

The plan's participants invest in certain securities and mutual funds that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain participant directed investments, it is least reasonably possible that changes in the values of invested securities will occur in the near term and that such changes could materially affect participants' account balances, and the amount reported in the statements of net assets available for benefits.
