Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - PLAN DESCRIPTION

The following description of the EHRA 401(k) Plan (“the Plan”) provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan covering eligible employees of Edminster, Hinshaw, Russ & Associates Inc. dba EHRA (the “Employer”, “Company”, or “Plan Administrator”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was adopted effective August 1, 2014 and was restated effective October 1, 2020.

Automatic Data Processing, Inc. (“ADP”) Retirement Services serves as recordkeeper of the Plan. Reliance Trust Company (“Reliance”) serves as the Plan’s asset custodian and trustee. On December 31, 2024, effective January 1, 2025 Reliance Trust Company resigned as the Plan’s Trustee and the Employer consented to the appointment of ADP Retirement Trust Services (ADP Trust).

ELIGIBILITY

Employees age 18 or older who have completed one month of service are eligible to contribute to the Plan, as allowed under Section 401(k) of the Internal Revenue Code (“IRC”). Union employees are not eligible to participate. The Plan was amended on February 01, 2023, to exclude interns from participating in the Plan.

CONTRIBUTIONS

Participants may elect to contribute up to 90% of their annual compensation to the Plan as a pre-tax elective deferral, as defined by the Plan. These contributions made by individual participants are limited by federal income tax laws to \$23,000 and \$22,500 (\$30,500 and \$30,000 for participants who have attained age 50 by the end of the calendar year) in 2024 and 2023, subject to certain non-discrimination tests for excess deferral contributions. These limitations are adjusted periodically to reflect cost-of-living increases.

Each eligible employee will be automatically enrolled in the plan as a participant, with 3% of the participant’s eligible compensation being deferred on their behalf. Eligible employees may opt out of automatic enrollment.

The Company will make matching contributions equal to 100% of the participants’ elective deferral up to 5%. The Company made matching contributions of \$883,932 for the year ended December 31, 2024.

The Company may also make a discretionary profit-sharing contribution to the Plan. No discretionary contribution was made for the year ended December 31, 2024.

NOTE 1 - PLAN DESCRIPTION (CONTINUED)

VESTING

Participants are immediately vested in their voluntary contributions, including rollover contributions, plus earnings thereon. The portion of the participants' accounts attributable to the Company's matching and profit-sharing contributions begin vesting in the first year at 25%, increasing by 25% each year thereafter, with the participant being 100% vested after four years of service. Regardless of the vesting schedule, participants become fully vested upon death, total and permanent disability and upon reaching normal retirement age of 65.

FORFEITURES

Matching and profit-sharing amounts contributed by the Company which are forfeited by participants as a result of the participants' separation from service prior to becoming 100% vested may be used to pay Plan expenses or to reduce the Company's matching contributions. Forfeitures pending application totaled approximately \$23,210 and \$11,177 for the years ended December 31, 2024 and 2023, respectively. Forfeited amounts of \$42,961 and \$13,505 were used to reduce employer contributions for years ended December 31, 2024 and 2023, respectively.

PARTICIPANT ACCOUNTS

Under the Plan, earnings and losses on the investments are allocated to participants' accounts on a daily basis. Upon enrollment in the Plan, a participant may direct ADP with regard to the investment of his or her account balance. Participants may change their investment options at any time. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow funds from their accounts at a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The loans are secured by the balance in the participants' accounts and bear interest based on the prime rate plus 1%. Interest will remain fixed throughout the duration of the loan. The interest rates on loans outstanding ranged from 4.25% to 9.50% for the year ended December 31, 2024. Principal and interest are repaid ratably through payroll deductions. Participants may have a maximum of one loan outstanding at a time. Loans must be repaid within five years unless the loan is used for the purchase of a primary residence, in which case the repayment term can be longer.

ROLLOVERS

Rollovers represent funds transferred to the Plan from other qualified plans of the participants.

NOTE 1 - PLAN DESCRIPTION (CONTINUED)

PAYMENT OF BENEFITS

Upon termination of service, distributions will be made to eligible participants from their vested interest in their account as soon as reasonably practicable following the date the participant's application for distributions is received by the administrator. In addition to benefit payments made due to termination of service, the Plan also allows for hardship distributions. In-service distributions are permitted for all participants who have attained age 59 ½.

PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE 2 – BASIS OF PRESENTATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF PRESENTATION

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Loans to participants are classified as notes receivable from participants and measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

ADMINISTRATIVE EXPENSES

Administrative expenses are paid by the Plan unless paid by the Company, at its sole discretion.

PAYMENTS OF BENEFITS

Benefits are recorded when paid.

USE OF ESTIMATES

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

RISKS AND UNCERTAINTIES

The Plan provides for several investment options which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

UNCERTAIN TAX POSITIONS

The provisions of Financial Accounting Standards Board Accounting Standards Codification ("ASC") Topic 740 *Income Taxes* requires the use of a two-step approach for recognizing and measuring tax benefits taken or expected to be taken in a tax return and disclosures regarding uncertainties in income tax positions. Only tax positions that meet the more likely than not recognition threshold at the effective date may be recognized.

The plan administrator does not believe that the Plan has any material uncertain tax positions at December 31, 2024; however, the Plan's tax returns for the years ending December 31, 2023, 2022, and 2021 are still subject to examination by relevant taxing authorities.

DATE OF MANAGEMENT'S REVIEW

The Plan administrator has evaluated subsequent events through September 10, 2025, the date which the financial statements were available to be issued.

NOTE 3 – CONCENTRATION OF MARKET AND CREDIT RISK

The Plan maintains investments considered to be cash equivalents which are not federally insured. The Plan does not believe it is exposed to any significant credit risk on these cash equivalents and has not experienced any losses in such accounts.

The financial instruments, which potentially subject the Plan to concentrations of market and credit risk, are principally investments. The Plan's investments consist of various mutual funds. To reduce concentrations of credit risk, the plan administrator has made available various types of these accounts to the participants, and the participants themselves choose their own accounts based upon their appropriate risk level. As a consequence, the Plan administrator believes that the Plan's credit risk exposure for participant directed investments is limited.

NOTE 5 – FAIR VALUE DISCLOSURES

ASC Topic 820-10, *Fair Value Measurements and Disclosures* ("ASC 820-10") establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities and the lowest priority to unobservable inputs.

The three levels of the fair value hierarchy under ASC 820-10 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Other significant observable inputs (including quoted prices in active markets for similar assets or liabilities), or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities. Level 3 assets and liabilities include financial instruments whose value is determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust fund: Valued based on the NAV of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Levels 1, 2, or 3.

NOTE 6 – TAX STATUS

The Plan obtained its latest determination letter for the prototype plan dated June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believe that the Plan is qualified, and the related trust is exempt.

NOTE 7 – RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as a fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others.

Plan investments are managed by LPL Financial LLC and are held by Reliance Trust Company, who is also trustee of the Plan. ADP is the third party administrator of the plan. Each of these service providers are a party-in-interest to the Plan.

Miller Grossbard Advisors, LLP is the independent auditor of the Plan.

NOTE 8 – EXCESS CONTRIBUTIONS

For the plan year ended December 31, 2023, employee contributions exceeded the Internal Revenue Code limits for certain participants. The excess contributions were refunded to the affected participants during 2024. No excess contributions were identified for the plan year ended December 31, 2024.

These amounts are included in the Plan's Statements of Net Assets Available for Plan Benefits under the caption "excess contributions payable".

NOTE 9 – SUBSEQUENT EVENT

Subsequent to year end, effective February 3, 2025 the Company changed its recordkeeper from ADP to Principal. Management does not expect this change to have a material impact on the Company's financial statements.
