**Note 1. Description of Plan**

The following description of the Meherrin Agricultural & Chemical Company Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan covering all full-time employees of Meherrin Agricultural & Chemical Company and affiliates (the “Company”), who have three months of service and are age 21 or older. The Board of Directors controls and manages the operation and administration of the Plan. Principal Life Insurance Company and Principal Trust Company served as the custodian of the Plan through November 22, 2024. John Hancock Trust Company, LLC serves as the custodian (“custodian”) of the Plan, effective November 23, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On May 1, 2024, the Plan was amended and restated to merge the Cache Creek Foods, LLC 401(k) Profit sharing plan into the Plan. The amount of funds merged into the Plan on May 1, 2024, totaled \$1,388,093. Former employees of Cache Creek Foods, LLC became eligible to participate in the Plan on January 1, 2024.

***Contributions***

Each year, participants may contribute up to 35% of pre-tax, as well as Roth (after-tax), annual compensation, as defined in the plan document, subject to certain Internal Revenue Code (“IRC”) limitations. Participants are automatically enrolled to defer 4% unless the participant elects a different percentage, and are automatically increased each January 1 by 1% up to a maximum percentage of 8%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company matching contribution is at the discretion of the Board of Directors. For the year ended December 31, 2024, the Company contributed 50% of the first 8% of base compensation that a participant contributed to the Plan. Contributions are subject to certain limitations.

***Investment Options***

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a stable value collective trust fund as investment options for participants.

***Participant Accounts***

Each participant’s account is credited with the participant’s contribution, the Company’s contributions, and allocations of the Plan earnings. The account is charged with benefit payments and allocations of administrative expenses and Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service according to the following schedule:

***Payment of Benefits***

Upon termination of service due to retirement, death, disability or other termination of employment a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants may also withdraw all or a portion of their vested account balances upon attainment of age 59 ½.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,436 and \$11,467, respectively. These accounts are used to reduce employer contributions. During 2024, forfeitures totaling \$112,916 were used to reduce Company matching contributions.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of assets and liabilities. Accordingly, actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Plan management determines the Plan's valuation policies utilizing information provided by the custodian.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded upon distribution.

***Administrative Expenses***

Substantially all administrative expenses are paid by the Company. Certain transaction fees are paid by the Plan. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (distributions) are charged directly to the participant's account.

***Subsequent Events***

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

The Plan was amended and restated on August 29, 2025 to allow employees of Sandy Land Peanut Company, Inc. to participate in the Plan starting on January 1, 2026.

**Note 3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual Funds***

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

***Stable Value Collective Trust Fund***

The Plan invests in a stable value collective trust fund for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the Net Asset Value ("NAV") per share provided by the custodian as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The stable value collective trust fund is not required to be classified within a level on the fair value hierarchy.

**Guaranteed Interest Account**

The Plan had a guaranteed interest investment contract with Principal Life Insurance Company. Principal Life Insurance Company maintained the contributions in a general account and the contract was not considered benefit-responsive. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at fair value as represented to the Plan by Principal Life Insurance Company. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract adds interest at rates from 0.88% to 1.85%. These rates were guaranteed through various maturity dates ending December 2024.

Guaranteed investment contracts are valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. Since the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. In determining the reasonableness of the methodology, the Board of Directors evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (for example, duration or payout date) while others are substantiated utilizing available market data (for example, swap curve rate.) Disclosure of unobservable inputs to fair value measurement has not been included for the guaranteed interest account because quantitative unobservable inputs are not developed by the Plan when measuring fair value and have not been made available to the Plan by the insurance company.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses (realized and unrealized) included in changes in net assets for the period above are reported in net appreciation in fair value of investments in the Statement of Changes in Net Assets Available for Benefits.

**Note 4. Unaudited Information Certified by Custodian**

**Note 5. Exempt Party-In-Interest Transactions**

Plan investments include a guaranteed interest account which is managed by Principal Life Insurance Company. Principal Life Insurance Company is the custodian of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan to the custodian for transaction fees amounted to \$126,085 for the year ended December 31, 2024.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 7. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (the “IRS”) stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the non-standardized prototype plan that it is utilizing. The IRS has determined and informed the custodian by a letter dated June 30, 2020 that the prototype plan document was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
