INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and Participants of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Lee-Smith, Inc. and Lesco, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived

from the certified investment information, we compared such information to the related certified investment information.

1. Description of the Plan

The following description of the Lee-Smith, Inc. and Lesco, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of the controlled group employers. The controlled group employers are Lee-Smith, Inc. and Lesco, Inc. (collectively, the Company). Employees of the Company generally become eligible to join the Plan on the first day of the quarter following or coinciding with their date of hire and after attaining the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In 2025, the Company was acquired by Thompson Truck Group. Employees of the Company continued to participate in the Plan following the acquisition. As a result of the acquisition, the Plan is expected to merge with Thompson Truck Group's existing plan, however, the plan merger has not been finalized as of October 14, 2025.

Contributions

Participants may make pre-tax and/or Roth contributions up to 100% of eligible compensation, as defined by the Plan document, subject to a maximum of \$23,000 in 2024, plus an additional \$7,500 in catch-up contributions for participants who have attained age 50 by the end of the Plan year. All eligible employees will be automatically enrolled in the Plan on the first day of the Plan quarter following or coinciding with their hire date, at a contribution rate of 5% of eligible compensation unless they elect otherwise. Beginning on the first day of the second Plan year following the Plan year during which the initial automatic enrollment became effective, and the first day of each subsequent Plan year, this will be increased annually by 1% of eligible compensation not to exceed 10%, unless the participant elects otherwise. The contributions will be invested in a retirement date fund based on the participant's age, unless directed otherwise. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company makes a matching contribution at the Company's discretion for participants if they attain 1,000 hours of service during the year and are employed by the Company on the last day of the Plan year or upon death, disability, or retirement. During 2024, the Company's discretionary matching contribution was equal to 25% of participant contributions up to 10% of eligible compensation. The matching contribution is invested in the participant's directed investments. During 2025, the Company contributed \$62,929 as a discretionary matching contribution for the 2024 Plan year. The Company may make a non-elective contribution at the Company's discretion for participants who have completed at least 1,000 hours of service during the Plan year. During 2024, the Company did not make any non-elective contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, and earnings or losses on the investments in their account, and is charged with transaction fees for services received by the participant and certain administrative expenses. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and rollovers plus actual earnings and losses thereon. Company discretionary matching and Company non-elective contributions vest 20% after two years of service and each year thereafter and are fully vested after six years of service. A participant's entire account balance becomes fully vested in cases of death, total and permanent disability or retirement at or after the age of 65.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have 1 note outstanding at any time. The notes are secured by the balance in the participant's account and bear interest at rates that are commensurate with rates charged by lenders on similar loans. During 2024, notes had rates of 6% for the term of the note, not to exceed 5 years or 30 years if used for the purchase of a residence. Principal and interest are paid through payroll deductions.

Payment of Benefits

At the time of death, disability, termination of service or retirement, the participant or their beneficiary may receive payment of the vested interest in their account in a lump-sum distribution or installment payments equal to the value of the participant's vested interest in their account. The participant's contributions may also be withdrawn for certain hardship situations. If a participant terminates employment and has an account balance less than \$7,000, the participant will automatically receive a lump-sum payment equal to the vested interest in their account.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$53,412 and \$26,922, respectively. These accounts may be used to pay Plan administrative expenses or offset the Company's contributions. In 2024, no forfeitures were used to pay Plan administrative expenses or offset the Company's contributions. In 2025, \$66,959 of forfeitures were used to reduce 2024 discretionary matching contributions.

Administrative Expenses

The Plan document permits certain administrative expenses to be paid by the Plan. Expenses for transactions which are specifically attributable to a participant's account are charged directly to the participant's account. These expenses are paid to service providers of the Plan and therefore qualify as party-in-interest transactions. All other expenses are paid by the Company and the Company does not expect reimbursement from the Plan for these expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company discretionary matching contributions and Company non-elective contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan and approved by the Company. Any unfunded participant or Company contributions are included in participant or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

In accordance with Financial Accounting Standards Board's Accounting Standards Codification 326, *Financial Instruments—Credit Losses*, the Company estimates the current credit risk associated with employer contribution receivables. The Company determined that no allowance for credit loss was necessary as of December 31, 2024 and 2023.

Valuation of Investments

The Plan's investments are stated at fair value, except for the AUL stable value account, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion on fair value measurements.

The net change in fair value of investments includes interest, dividends, certain administrative expenses, and realized and unrealized gains and losses on those investments. Interest income is recorded when received.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received by the Plan. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded as a deemed distribution. Notes receivable from participants also qualify as party-in-interest transactions.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to participant contributions. The Plan expects to distribute the 2024 excess contributions as required.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule of assets held, including investments held and notes receivable from participants at December 31, 2024 and 2023, and the net change in fair value of mutual funds, contract value of the AUL stable value account, and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by American United Life Insurance Company, a OneAmerica Company (AUL), the Plan's qualified institution.

4. Investments

Plan investments include units of a fully-benefit responsive investment contract managed by AUL. AUL is the qualified institution of the Plan; therefore, transactions in these investments qualify as party-in-interest transactions.

Investment securities are exposed to various risks, such as market, currency, interest rate and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, and significant cybersecurity attacks, among others. It is at least reasonably possible that changes in their fair values will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are valued at quoted market prices for the identical security in an active market (Level 1).

The AUL stable value account is a fully-benefit responsive investment contract and is a general obligation of AUL. AUL maintains the contributions in a general account. The account is credited with contributions, and charged for participant withdrawals and administrative expenses. AUL is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Contract value of the guaranteed income fund represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with AUL, but may not be less than 2%. Such interest rates are reviewed on an annual basis for resetting.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has a right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

6. Income Tax Status

In January 2021, the Plan that was based on a prototype plan document created by Erisa Services, Inc. (ESI) moved to a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (pre-approved plan) sponsored by ESI. ESI received an opinion letter from the IRS, dated June 1, 2021, which states that the pre-approved plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has not obtained an individual determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.
