Independent Auditor's Report

To the Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Blue Sky 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. PLAN DESCRIPTION AND BASIS OF PRESENTATION

The following description of the Blue Sky 401(k) Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering the employees of Blue Sky Smart Solutions, Inc. ("the Company") and Streamline Connections, Inc. who have completed three months of service. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. During April 2022, the Plan executed an amendment to complete a cycle 3 restatement in order to maintain compliance with IRS regulations. During 2023, the Plan Sponsor made an amendment to the Plan to add Blue Sky Energy Solutions, LLC as a participating employer of the Plan.

Contributions

Participants may contribute from 1% to 90% of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may contribute a discretionary matching contribution to the Plan. Participants are eligible for the employer's matching contribution upon admittance to the Plan. Additionally, the Company may make a discretionary non-matching contribution to the Plan. To be eligible to receive both the matching and non-matching contribution, participants must be employed on the last day of the Plan year. For the plan years ended December 31, 2024 and 2023, the Company elected to match 25% of participants' eligible contributions that do not exceed 6% of participants' qualified compensation. During the years ended December 31, 2024 and 2023, the total matching contributions made by the Company were \$32,202 and \$55,557 respectively. Contributions are subject to certain limitations as determined by Federal Tax Law.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in the employer matching and non-matching discretionary contributions to the Plan over a five-year vesting schedule.

Investment options

The Plan's assets are held by Reliance Trust Company ("Reliance"). During the years ended December 31, 2024 and 2023, the third-party administrator, ADP Retirement Services, contracted with Reliance as the Trustee.

Upon enrollment in the Plan, participants direct contributions in any of twenty-four investment options. Participants may change their investment options at any time.

Payment of benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan also allows for in-service withdrawals for "hardship" (as defined in the Plan) and after a participant attains age 59 ½. Benefits are recorded when paid.

Forfeitures

Forfeitures attributable to matching contributions will be used to reduce matching contributions. For the Plan years ended December 31, 2024 and 2023, \$9,068 and \$1,713 of forfeitures were used to reduce employer contributions, respectively. At December 31, 2024 and 2023, forfeited non-vested accounts were \$0.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan have been prepared using the accrual method of accounting.

Investment valuation

The Plan's investments are stated at fair value. The fair value is unaudited.

Investment information is provided and certified by Reliance for the years ended December 31, 2024 and 2023. In accordance with FASB ASC 820, investments are grouped at fair value in three levels, based on the market in which assets are traded and the reliability of the assumptions used to determine fair value. See Note 7 for discussion of fair value measurements.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

3. RELATED PARTY TRANSACTIONS

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Legal, accounting and third-party administration fees may be paid directly by the Company or from the Plan.

4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants will become 100% vested in their accounts. Unallocated assets, if any, will be allocated to participant accounts and distributed in such a manner as the Company may determine.

5. TAX STATUS

The Plan and related trust were designed under a prototype form, which was approved by the Internal Revenue Service. The IRS determined and informed Automatic Data Processing, Inc. (ADP) by a letter dated October 6, 2020, that the Plan was designed in accordance with the applicable regulations of the Internal Revenue Code (IRC) to be tax-exempt. The Plan has been amended since the determination letter was received, but the Plan's Trustees believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Trustees believe the Plan was qualified and the related trust was tax-exempt as of the financial statement date. Accordingly, no provision

for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. INFORMATION CERTIFIED BY THE TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments and guaranteed investment contracts held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, dividends, other income and interest for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance.

7. FAIR VALUE MEASUREMENT

FASB ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, it consists of three levels:

- Level 1 – Valuation is based upon quoted prices for identical instruments traded in active markets.
- Level 2 – Valuation is based upon quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market.
- Level 3 – Valuation is generated from model-based techniques that use significant assumptions not observable in the market.

Reliance provided the following descriptions of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: Valued at the NAV of units held. The NAV is used as a practical expedient to estimating fair value. The NAV is based on the fair value of the underlying investments held by the respective fund less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

8. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. FULLY BENEFIT – RESPONSIVE GUARANTEED INVESTMENT CONTRACT

In 2011, the Plan entered into a benefit-responsive guaranteed investment contract (Invesco Stable Asset Fund), referred to as a common trust, with Reliance Trust Company. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Reliance, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the Plan's ability to transact at contract value with Reliance. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash

provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974.

The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of not occurring. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

10. SECURE ACT 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. The most significant changes impact existing plan provisions included updates to required minimum distributions, hardship distributions rules, expanded eligibility of part-time employees, and modifications to catchup contribution rules. SECURE Act 2.0 amendments must be adopted by December 31, 2026 for calendar year plans. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

11. CONTINGENCIES

The company periodically pays bonuses to its employees. The Plan's definition of compensation does not exclude bonuses and therefore, they are subject to a participant's salary reduction agreement. The Sponsor and Plan have determined that periodic bonus payments have not included deferrals according to participant salary reduction agreements in force. Additionally, employer match contributions for deferrals related to periodic bonus payments have not been calculated and included, if applicable. The dollar amount of deferrals, employer matching contributions, and other possible expenditures has not yet been determined and cannot be reasonably estimated at this time and therefore, no such amounts have been accrued in the accompanying financial statements. Plan management is currently investigating corrective action.

13. RECLASSIFICATIONS

Certain prior year amounts have been reclassified to conform to the current year presentation.

14. SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 13, 2025, the date which the financial statements were available to be issued.
