Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. **Description of the Plan** The following description of the Genetics & IVF Institute Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Genetics & IVF Institute, Inc. (the "Institute") who have completed two months of service, except for employees covered by a collective bargaining agreement, and residents of Puerto Rico. Employees may enter the Plan on the first day of the month coincident with or following satisfying the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: Each year, participants may contribute up to 60 percent of pretax annual compensation, as defined in the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan allows for automatic enrollment. Any newly eligible employee who has not affirmatively elected to contribute to the Plan or has not affirmatively declined to participate in the Plan will be automatically enrolled in the Plan with a two percent withholding of pretax annual compensation. This withholding will increase by one percent each subsequent year until the automatic election reaches a maximum withholding contribution of five percent of compensation. The Plan allows for discretionary matching and profit sharing contributions. Participants must complete at least 1,000 hours of service during the Plan year and be an active employee on the last day of the Plan year to receive an allocation of any discretionary matching and profit sharing contributions. During the year ended December 31, 2024, the Institute made a discretionary matching contribution of 100 percent of the first three percent of eligible compensation contributed by the participant. Participants direct the investment of their contributions and Institute contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions, the Institute's discretionary matching contributions, if any, as well as allocations of the Institute's discretionary profit sharing contribution, if any, and Plan earnings. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations of the Institute's discretionary profit sharing contributions, if any, are based on compensation using a formula integrated with Social Security, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the Prime interest rate plus one percent. Principal and interest are paid through payroll deductions.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Institute matching and profit sharing contributions is based on years of continuous service. A participant is 20 percent vested after two years of service is completed, 40 percent after three years of service, 60 percent after four years of service, and fully vested after five years of service.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12,431 and \$11,848, respectively. These accounts will be used to reduce future Institute contributions or to pay Plan expenses. During 2024, no forfeited nonvested accounts were used.

Payment of benefits: Benefits are payable upon retirement at age 65, early retirement at age 55 and 10 years of service, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Benefits are payable in lump sum or installment payments.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Institute. Transaction expenses, such as loan and distribution administration fees, are charged directly to the participant's account and are included in administrative expenses.

2. Significant accounting policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions: Participant contributions and discretionary matching contributions are recognized in the period the participant contribution is withheld from compensation. Institute discretionary profit sharing contributions are recognized in the period the related eligible compensation is paid to the participant.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through October 14, 2025, which is the date the financial statements were available to be issued.

3. Certified information Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

4. Fair value measurements The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- 5. Risks and uncertainties** The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.
- 6. Plan termination** Although it has not expressed any intent to do so, the Institute has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
- 7. Party-in-interest transactions** Reliance Trust Company and ADP, Inc. are the trustee and recordkeeper, respectively, as defined by the Plan. During the Plan year ended December 31, 2023, the Plan paid \$26,584 to ADP, Inc. for recordkeeping services. These transactions qualify as exempt party-in-interest transactions.
- During 2018, 2019 and 2020, the Institute failed to remit to the trustees certain employee contributions and loan repayments totaling \$61,884 within the period prescribed by Department of Labor regulations. These delinquent remittances are considered nonexempt party-in-interest transactions. The Institute made corrective contributions to the Plan in 2025 to compensate affected participants for lost earnings on the delinquent remittances.
- 8. Tax status** The Plan is a pre-approved plan of ADP, LLC which received an opinion letter on October 6, 2020, in which the Internal Revenue Service (“IRS”) stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code (“IRC”). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.
- Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- 10. Subsequent events** The Plan was amended effective January 1, 2025 to remove the allocation conditions for the discretionary employer matching contribution. Participants are no longer required to be employed on the last day of the plan year or complete 1,000 hours of service to be eligible for the match.

In 2024, a component of the Institute was spun off into a separate entity, which created and maintains a separate retirement plan. The balances of participants who transferred employment to the separate entity, which amounted to approximately \$5.5 million, were transferred to the new plan in February 2025.
