Note 1 - Description of Plan

The following description of the Boys & Girls Clubs of Central Florida, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document and adoption agreement for a more comprehensive description of the Plan's provisions.

General

The Plan, originally effective January 1, 2005, and most recently restated October 1, 2024, is a defined-contribution plan covering substantially all employees, as defined by the Plan, of Boys & Girls Clubs of Central Florida, Inc. (the Company, Employer or Plan Sponsor). The Plan is intended to satisfy all the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was restated on October 1, 2024, in connection with a change in trustee. No material modifications were made to the provisions of the Plan.

Eligibility

Employees become eligible to make salary deferrals and receive Company contributions upon completion of twelve consecutive months of service during which at least 1,000 hours of service are completed, and upon attaining the age of 21. Contributions may be made to the Plan on the first day of the calendar quarter coinciding with, or next following, the date eligibility requirements are met.

Contributions

Participants may elect to make pre-tax or after-tax Roth contributions up to 90% of their eligible annual compensation, as defined in the Plan agreement, up to a certain statutory maximum which is set by law each year. In addition, participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions to the Plan. The Company may provide a discretionary matching contribution equal to a uniform percentage of participant salary deferrals as determined by the Company. The Company did not provide a discretionary match during 2024. Additional profit sharing amounts may be contributed by the Company at its discretion. Employer profit sharing contributions during 2024 were 7% of eligible compensation. The Company also provides a safe harbor matching contribution to each eligible participant in an amount equal to 100% of the participant's salary deferrals up to 3% of Plan compensation plus 50% of the participant's salary deferrals up to the next 2% of Plan compensation. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

Participant Accounts

Participant accounts are credited with the participant's and Employer contributions, and allocations of the Plan's earnings, and charged with benefit payments and an allocation of the Plan's losses and administrative expenses. Plan earnings and losses, and certain administrative expenses, are allocated based on account balances while contributions are credited based upon elective deferrals and compensation, as defined. Transaction fees are charged directly to the accounts of the participants who incur those fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investments of their accounts into various options offered by the Plan. Participants may change their investments periodically, as permitted by the Plan sponsor.

Vesting

Participants are immediately vested in their elective deferral contributions, rollover contributions, and Employer safe harbor matching contributions plus actual earnings thereon at all times and also become 100% vested in their Employer discretionary matching and profit sharing contributions upon death or disability or attainment of normal retirement age, as defined. Upon termination for any other reason, participants are entitled to a portion of their Employer discretionary matching and profit sharing contributions in accordance with the following vesting schedule:

Participant Loans

The Plan does not allow loans to participants and beneficiaries.

Forfeitures

Any non-vested amounts remaining after the distribution of a terminated participant's vested account balance are forfeited. Amounts forfeited by participants may be used to pay Plan expenses or to reduce Company contributions. During the year ended December 31, 2024, forfeitures of \$61,800 were used to reduce Company contributions and \$500 was used to pay Plan expenses. At December 31, 2024 and 2023, the balance of the forfeited non-vested accounts was \$41,879 and \$23,265, respectively.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination of employment, a participant with a vested balance greater than \$5,000 may receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, a series of installments over time, or partial withdrawals. If the amount of the participant's vested balance is \$5,000 or less, the Plan will automatically distribute the vested balance in a lump-sum payment. Participants attaining the age of 59 ½ may request an in-service distribution from their vested account balance at a minimum of \$500. Hardship withdrawals may be requested at a minimum amount of \$500 and are paid in one lump-sum upon approval.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See additional discussion on fair value measurements in Note 4.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's net gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Certain transaction fees for disbursements are charged directly to the accounts of the participants who incur those fees. Certain investment-related expenses are included in net appreciation in the fair value of investments on the accompanying statement of changes in net assets available for benefits. Certain administrative fees are allocated to participants proportionally based on the value of their account balance. Any costs associated with the investment of a participant's account are charged to the participant.

Note 3 - Information Certified by John Hancock Life Insurance Company (U.S.A.) (John Hancock) and ADP Retirement Trust Services, LLC (ADPRTS)

The following is a summary of the Plan's financial information and data included in the Plan's financial statements and supplemental Schedule of Assets (Held at End of Year), which was certified by John Hancock as of December 31, 2023, and for the period from January 1, 2024 to September 30, 2024, and ADPRTS as of December 31, 2024, and for the period from October 1, 2024 to December 31, 2024, as complete and accurate, as permitted by 29 CFR 2520.103 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2—Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – As of December 31, 2024, and for the period from October 1, 2024 to December 31, 2024, the Plan holds investments in mutual funds valued as determined by quoted market price, which represents the net asset value (NAV) of shares held by the Plan at year-end. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts – As of December 31, 2023, and for the period from January 1, 2024 to September 30, 2024, the Plan held units of participation in separate accounts, which were valued daily at their NAV. Included in pooled separate accounts was a stable value fund which represents participation units of a collective investment trust for which the NAV was based on the market value of the underlying investments. The stable value fund was composed primarily of fully benefit-responsive investment contracts that were valued at the NAV of the bank collective trust. NAV is computed by dividing the proportion of the market value, after deduction of any applicable charges, by the number of units outstanding. The NAV was used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund would sell the investment for an amount different from the reported NAV.

Participant transactions (purchases and sales) may have occurred daily and there were no unfunded commitments on these investments. Redemption restrictions included a maximum of two exchange days per calendar month. In addition, payment of certain withdrawals from the stable value fund may be delayed for up to 12 months.

- (a) Target Date - Seeks high total return until its target retirement date, with a greater focus on income as the target date approaches.
- (b) Fixed Income - Seeks to maximize total return consistent with reasonable risk investing primarily in net assets in a diversified portfolio of bonds or fixed income instruments of varying maturities.
- (c) Large Cap - Seeks long-term growth of capital or a combination of growth and income by investing primarily in stocks of larger, mature companies.
- (d) International - Seeks international diversification by investing in stocks of companies outside of the United States.
- (e) Small/Mid Cap - Seeks capital appreciation by investing primarily in stocks of small and medium sized companies.
- (f) Stable Value Fund - Seeks to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long-term.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Related-Party and Party-in-Interest Transactions

As of December 31, 2023, and for the period from January 1, 2024 to September 30, 2024, the Plan's investments and non-interest-bearing cash were managed by John Hancock. The Plan also pays fees to John Hancock, ADPRTS, and the Plan's investment advisor and third-party administrator. These transactions qualify as party-in-interest transactions. Fees paid to these parties-in-interest totaled \$47,871 for the year ended December 31, 2024.

Note 6 - Plan Termination

Although the Company has not expressed any intent to do so, it has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 - Income Tax Status

The Plan adopted a non-standardized defined contribution pre-approved plan which received a favorable opinion letter from the IRS dated June 30, 2020. Upon the Plan restatement effective October 1, 2024, the Plan received a favorable opinion letter dated October 6, 2020. The opinion letters stated that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been restated since the date of the latest ruling, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, changes in the values of investment securities could occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Non-Exempt Transactions

During the Plan year ended December 31, 2024, the Company did not remit certain employee deferrals within the appropriate time period prescribed by the Department of Labor. These transactions constitute prohibited transactions as defined by ERISA. The Company is currently in the process of taking the appropriate steps to correct the 2024 late remittances, including restoring lost earnings.
