NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of the **Gillman, Inc. 401(k) Plan** (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - On September 1, 1998, Gillman, Inc. (the "Sponsor") adopted a Section 401(k) profit sharing plan. The Sponsor is a member of a controlled group. As a result, GHCO, Inc. is a participating employer in the Plan and collectively, Gillman, Inc. and GHCO, Inc. are referred to as the "Companies". The Plan allows all employees of the Companies, who are at least 21 years of age and have completed one year of service, to participate. To meet the one year of service requirement, employees must perform a minimum of 1,000 hours of service in a year. In accordance with the SECURE Act, effective January 1, 2024, long-term part-time employees who worked at least 500 hours in each of the prior three years are eligible to participate in the Plan. Upon satisfaction of the eligibility requirements, employees may enter the Plan on the first day of the first month and seventh month of the Plan year. Effective July 1, 2024, upon satisfaction of the eligibility requirements, employees may enter the Plan on the first day of the subsequent month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions - The Plan provides for employee salary deferrals within statutory limits, as defined in the Plan, each year as an elective deferral. In addition, participants may also make Roth contributions on after-tax compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions.

The Plan utilizes automatic enrollment. Once eligibility requirements are met, employees are automatically enrolled into the Plan with a 6% deferral rate, unless they notify the Sponsor that they do not wish to participate. The automatic deferral percentage shall increase upon the first day of the Plan year by 1% in the second and third year to a maximum of 8%. Effective July 1, 2024, the maximum deferral percentage as part of the automatic enrollment feature was increased to 10%.

Company Match - The employer match is discretionary. The Companies contributed 50% of a participant's employee contributions that were not in excess of 6% of the participant's compensation for the years 2024 and 2023. Employer matching contributions are not provided to long-term part-time employees who worked less than 1,000 hours but were eligible to participate in the Plan under the SECURE Act. The Company contributed \$234,511 and \$221,082 in 2024 and 2023. In addition, the Company contributed \$7,135 as qualified non-elective contributions during 2024. There were no qualified non-elective contributions during 2023.

The Companies may, at their discretion, make a profit-sharing contribution to the Plan to those participants that meet the eligibility requirements. In addition, participants must have completed at least 500 hours of service during the Plan year or be employed by the Companies on the last day of the Plan year. Profit-sharing contributions are not provided to long-term part-time employees who worked less than 1,000 hours but were eligible to participate in the Plan under the SECURE Act. Profit-sharing contributions will be allocated to each participant eligible to share in the allocation, and such contributions, should they be made, will be allocated in the ratio that each participant's compensation bears to the compensation of all eligible participants. No profit-sharing contribution was made for 2024 or 2023. No contributions shall be made on behalf of a participant to the extent that, when added to the participant's salary deferral contributions, it would cause the amounts allocated to exceed the limitation allowed by the Internal Revenue Service.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

Participant Accounts - ADP Retirement Trust Services, LLC, is the Custodian of the Plan investments beginning July 1, 2024. Prior to this date, Mid Atlantic Trust Company was the Custodian of Plan investments. Each participant's account is credited with the participant's contributions, Company contributions, net earnings or losses, forfeitures, distributions, and withdrawals. Company contributions and forfeitures are allocated based on participants' compensation as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs both separately, and distinctly, into which investment the participant contribution, employer matching contribution, and discretionary contribution are to be invested.

Vesting - Participants are immediately vested in their voluntary contributions, rollovers, and corresponding earnings. The following schedule will be used to determine vesting in the Plan match, profit-sharing, and their earnings:

Notes Receivable from Participants - Participants may borrow from their fund account balance in any amount between \$1,000 and \$50,000, but not more than 50% of their vested account balance. Loans bear interest at the prime rate plus 1%. Loan terms are for a period not exceeding five years. A longer term may be approved by the Plan if proceeds are to be used for the purchase of a primary residence. Loans are secured by the balance in the participants' accounts. Principal and interest are paid ratably through payroll deductions.

Benefits Paid - Upon termination of service by reason of retirement, death, permanent disability, or otherwise, participants, or designated beneficiaries, may elect to receive their vested balance either in a lump-sum amount, or payments over a period of time in cash installments, or in a form agreeable to the Plan Administrator. If the participant's account balance is \$1,000 or less, the Plan Administrator may elect to automatically distribute the balance to the participant in a single-sum payment. If the participant's account balance is over \$1,000 but less than \$5,000, the Plan Administrator may elect to automatically roll over the account into an individual retirement account. In addition, participants may receive distributions of the employee deferral amount, qualified non-elective contributions, and qualified matching contributions for qualified hardships.

Forfeitures - Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company contributions, pay Plan expenses, restore forfeitures to participants' accounts, and may be reallocated to participants' accounts. Forfeitures in the amount of \$13,331 and \$14,206 were used during 2024 and 2023. Unallocated forfeitures at December 31, 2024 and 2023 were \$21 and \$164.

Investment Options - Upon enrollment in the Plan, a participant may direct contributions in investment options in increments of one percent. Participants may change their investment options and deferral percentages at any time via paper form or the Internet.

NOTES TO FINANCIAL STATEMENTS

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Financial Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of net assets, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. There was no reserve recorded at December 31, 2024 and 2023, for loans that might be uncollectible. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - The Companies pay certain administrative expenses of the Plan, and the Plan participants will bear the responsibility of the remaining expenses. Administrative fees for distributions and loans are paid by Plan participants. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Reclassifications - Certain amounts in the 2023 financial statements have been reclassified to conform to the 2024 financial statement presentation.

Subsequent Events - In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.

NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and net appreciation in fair value of investments for the period July 1, 2024 to December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by ADP Retirement Trust Services, LLC (the Custodian of the Plan).

NOTES TO FINANCIAL STATEMENTS

NOTE 3 - CERTIFIED INVESTMENTS - CONTINUED

Certain information related to cash and investments disclosed in the accompanying financial statements and supplemental schedule, including cash and investments held at December 31, 2023 and net appreciation in fair value of investments for the period January 1, 2024 to June 30, 2024 and the year 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Mid Atlantic Trust Company (the Custodian of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting standards provide a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the accounting standards are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs, and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Common collective trusts: Valued at the net asset value (NAV) of units held by the Plan at year-end.

Investments in registered investment companies: Valued at the quoted market price of shares held by the Plan at year-end.

NOTE 4 - FAIR VALUE MEASUREMENTS - CONTINUED

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - RELATED PARTY TRANSACTIONS

Mid Atlantic Trust Company served as the Custodian of the Plan through June 30, 2024. Fees paid by the Plan during the period January 1, 2024 through June 30, 2024 and the year 2023 totaled \$1,509 and \$2,378. Beginning July 1, 2024, ADP Retirement Trust Services, LLC serves as the Custodian of the Plan. There were no fees paid to ADP Retirement Trust Services, LLC in 2024.

American Pension Benefits served as the third-party administrator of the Plan through June 30, 2024. Fees paid by the Plan during the period January 1, 2024 through June 30, 2024 and the year 2023 totaled \$10,273 and \$13,512. Beginning July 1, 2024, ADP, Inc. serves as the third-party administrator of the Plan. Fees paid by the Plan during 2024 totaled \$2,837.

First Financial Bank is the Trustee, handles the recordkeeping, and serves as the investment advisor to the Plan. Net fees incurred by the Plan during the years 2024 and 2023 totaled \$17,994 and \$17,576.

The Plan Sponsor provides certain accounting, recordkeeping, and administrative services to the Plan, for which it receives no compensation.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants will become 100% vested in the employer matching and profit-sharing portion of contributions.

NOTE 7 - TAX STATUS

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan with a cash or deferral arrangement, which received a favorable opinion letter from the Internal Revenue Service on October 6, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan, and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - BENEFITS ALLOCATED TO WITHDRAWN PARTICIPANTS

At December 31, 2024 and 2023, there were no amounts due to participants who have withdrawn from the Plan and requested benefit payment prior to year-end.

NOTE 10 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

For the years 2024 and 2023, there were no differences between the financial statements and the Form 5500.
