Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, line 4i—schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of Plan

The following description of the Mission Pharmacal Company Retirement Savings Plan (the Plan) provides general information about the Plan's provisions. Participants should refer to the Plan document and summary Plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the Plan sponsor.

General: The Plan is a defined contribution plan covering substantially all employees of Mission Pharmacal Company (the Company or Plan Sponsor) immediately upon date of hire. The Plan is for the exclusive benefit of its eligible participants and their beneficiaries. The Plan is designed to meet the requirements of Internal Revenue Code (IRC) Section 401(a) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, (ERISA) as amended.

Contributions: Participants can contribute up to the amounts permitted by the Internal Revenue Service (IRS). Also, the Company may make a discretionary matching contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. During 2024, the employer match was 50% of employee contributions up to a maximum of \$11,500.

Eligible participants are automatically enrolled in the Plan immediately upon hire with a contribution rate of 6% of base salary each payroll period, unless the employee elects an alternative deferral amount or elects not to defer under the Plan. The Plan does not have an age requirement. Once an employee reaches six months of service with the Company, this automatic enrollment contribution rate increases by 1% every January 1 until the automatic enrollment contribution rate reaches 10%.

Participant accounts: Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contribution, allocations of the Company's contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions, and actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts is based on years of credited service. A participant will be 100% vested after their fourth year of service. Company matching and nonelective contributions have a four-year graded vesting period as follows:

Payment of benefits: Upon the death, disability, or retirement of a participant, vested benefits are paid to the participant or his or her designated beneficiary. Benefits are payable in the form of cash, as outlined in the Plan.

Note 1. Description of Plan (Continued)

In the event a participant dies or becomes totally and permanently disabled prior to the commencement of benefits, the participant's account balance becomes fully vested. Upon termination of employment with the Company, a participant is not eligible to make further contributions to the Plan. A terminated participant may share in Company discretionary contributions in the year of termination if the minimum service requirements for the participant as outlined in the Plan are met. A terminated participant may elect to withdraw the vested balance from his or her account or may leave the account intact to be distributed at a later date. A participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. Any balance that does not exceed \$5,000 is automatically paid out as soon as administratively possible. In the absence of an election by the participant within the time period specified by the Plan Administrator, any balance that exceeds \$1,000, but does not exceed \$5,000, is paid as a direct rollover to an individual retirement account designated by the Plan Administrator and any balance that does not exceed \$1,000, is paid directly to the participant in the form of a cash, lump-sum distribution.

The Plan incorporates a normal retirement age of 65. The Plan does not provide for an early retirement benefit. Participants who do retire early will be vested in accordance with the Plan vesting schedule and will receive their benefits in the same manner as in termination of employment. Participants may elect to postpone retirement beyond the normal retirement age of 65 and continue to make contributions and share in the Company discretionary matching contributions. Further, participants may elect to receive funds from their 100% vested accounts at any time after attaining the age of 59½.

Distributions of plan benefits are not permitted before the age of 59½ except in the event of the following: (1) death, (2) disability, (3) termination of employment, or (4) reasons of proven financial hardship. In the case of financial hardship, distributions are limited to the participant's vested account.

Forfeitures: Forfeitures represent amounts not vested at the date of a participant's retirement or withdrawal from the Plan.

At December 31, 2024 and 2023, forfeited accounts totaled \$10,251 and \$15,618, respectively. These accounts will be used first to pay the administrative expenses of the Plan and reduce future employer contributions. During 2024, forfeitures of \$68,268 were used to reduce employer contributions.

Administration: The Plan is administered under a written agreement entered into by the Plan trustee and the Company. Fidelity Management Trust Company (Fidelity) serves as the trustee of the Plan. The Company is the Plan Administrator. The plan trustee is responsible for investing the plan assets, and all investments are held with the trustee. The Company is responsible for all significant administrative costs that are not specifically related to participant investment election options.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Note 2. Summary of Significant Accounting Policies (Continued)

Payment of benefits: Benefit payments are recorded when paid.

Risks and uncertainties: The Plan provides for investments in various investment securities, which, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying statements of net assets available for benefits and participant account balances.

Investment valuation and income recognition: The Plan's investments are stated at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for discussion of fair value measurements. Investments in mutual funds and certain common/collective trust funds are stated at fair value based on quoted market prices. Investments in certain common/collective trust funds are stated at net asset value (NAV) per units held by the Plan as determined by the issuer. The NAV is used as a practical expedient to estimate fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes realized gains and losses on investments bought, sold, and held during the year.

Contributions: Contributions from Plan participants and the matching contribution from the Plan Sponsor, if any, are recorded in the year in which the participant contributions are withheld from amounts paid. All participant and employer contributions are participant-directed. Participant contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction in contributions.

Expenses: Administrative expenses may be paid by either the Plan Sponsor or the Plan, as provided by the Plan document. Fees related to the administration of benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements.

Subsequent events: The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified or Provided by Fidelity Management Trust Company (Fidelity)

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management, and agreed to or derived from information certified by Fidelity, the trustee of the Plan. The Plan Administrator has obtained certifications from Fidelity that the information provided to the Plan Administrator by Fidelity related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

Note 4. Fair Value Measurements

The Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 820, Fair Value Measurement, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted market prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data, correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques that are used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Following are descriptions of the valuation methodologies used for assets measured at fair value:

Mutual funds: Mutual funds are valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust funds: The common/collective trust funds are valued at the NAV of units of the bank collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust funds, the investment advisor reserves the right to temporarily delay withdrawal from the collective trust funds in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

Note 5. Related-Party and Party-in-Interest Transactions

Investments of the Plan are managed by the trustee and certain investments are issued by affiliates of the trustee. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules under ERISA.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the IRC. The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
