INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of
Clarity Software Solutions 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Clarity Software Solutions 401(k) Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Notes to Financial Statements

December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Clarity Software Solutions 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established on January 1, 2010, to provide retirement and other related profit-sharing benefits to the employees of Clarity Software Solutions, Inc., and Clarity Output Solutions, Inc. (the “Employer”). The Plan was established for the exclusive benefit of participating employees and their beneficiaries. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended and related rules and regulations.

Participant Contributions

Each year, participants may contribute a percentage of their annual pre-tax and after-tax compensation, as defined by the Plan. Participants may make these contributions up to the limits prescribed by the Internal Revenue Service (“IRS”). The Plan also allows for participants who are 50 years old or older to make catch up contributions up to the limits prescribed by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Employer Contributions

The safe harbor matching contribution equals 100% of the first 3% of salary deferral plus 50% of the next 2% of salary deferral. The safe harbor matching contribution is 100% vested at all times. Profit sharing contributions may be contributed at the discretion of the Employer.

Eligibility

All employees (other than excluded employees) become eligible on the first day of the month following 60 days of employment and the employee must have attained age 21.

To be eligible to receive an Employer profit sharing contribution and a safe harbor contribution, participants must have attained age 21 and have completed twelve months of service. This requirement is not satisfied until the last day of the 12-month period. Safe harbor contributions will begin on the first day of the month after satisfaction of the eligibility requirements.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Employer’s contributions, and Plan earnings, and is reduced by Plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

As of December 31, 2024 and 2023, there were no unutilized forfeitures. These accounts if any, may be used to reduce future Employer contributions or administrative expenses. For the year ended December 31, 2024, no forfeitures were used to reduce administrative expenses or Employer contributions.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. Participants may have one loan outstanding at any time.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or periodic installments (at least annually) subject to the minimum distribution rules. For the termination of service for other reasons, a participant may receive the value of the vested amount in his or her account as a lump sum distribution.

Withdrawals from a participant's salary deferral account may also be made in the event of a financial hardship, or for adoption or childbirth expenses, in accordance with the provisions specified in the Plan. Additionally, participants who are at least 59½ years of age may withdraw all or a portion of the balance in their account prior to termination for any reason.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the Plan's financial statements in conformity with generally accepted accounting principles in the United States of America requires management of the Plan to make certain estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of income and expense during the reporting period. Actual results could differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by investment advisers and John Hancock Life Insurance Company (U.S.A.) ("John Hancock"), the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

Subsequent Events

The Plan has monitored and evaluated subsequent events for footnote disclosures or adjustments required in its financial statements for the year ended December 31, 2024 through October 10, 2025, the date on which financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

Level 1 Fair Value Measurement - Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 Fair Value Measurement - Collective investment trust fund: Collective investment trust (“CIT”) is valued at fair value. Fair value is calculated as the number of units of the sub-account held on a particular date multiplied by the unit value on that date, and generally is the value that would be paid out for participants-initiated, or benefit withdrawals as defined in the CIT’s Declaration of Trust.

NOTE 4 - TAX STATUS

The Plan is a prototype plan. The Internal Revenue Service has determined that the form of the prototype plan is acceptable under Section 401(a) of the IRC on a letter dated June 30, 2020. The Plan is designed to constitute a qualified tax-exempt plan under section 401(a) of the IRC. Although the Plan has been amended since the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTIES-IN-INTEREST TRANSACTIONS

John Hancock performs certain administrative functions for the Plan's investments. John Hancock is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan also pays certain expenses related to Plan operations to various service providers. These transactions are party-in-interest transactions under ERISA. Fees paid by the Plan to the trustee and other service providers for Plan operations amounted to \$107,474 for the year ended December 31, 2024.

The Plan provides for participant loans. Transactions in such investments qualify as party-in-interest transactions as defined by ERISA.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan provides for various investment options. The investments held by registered investment companies may include stocks, bonds, fixed income securities, and other investment securities. Such investments are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities in the near term could materially affect participant's account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100 percent vested in their Employer contributions.

NOTE 8 - CERTIFIED INVESTMENTS

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required schedule of assets (held at end of year), including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock, the trustee of the Plan.
