## INDEPENDENT AUDITOR'S REPORT

To the Trustee and Plan Administrator

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements**

We have performed an audit of the financial statements of Atlantic Waste Services, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ### ***Responsibilities of Management for the Financial Statements***

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1. DESCRIPTION OF THE PLAN**

The following description of the Atlantic Waste Services, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which was established on January 1, 2018, and last amended and restated, effective November 1, 2021, is a defined contribution plan covering all employees of Atlantic Waste Services, Inc. (the Company) who have completed three months of service and are age 21 or older. Employees are automatically enrolled in the Plan on the first day of each plan quarter, coincident with or following the date they become eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute a percentage of pretax and post-tax annual compensation, not to exceed statutory limitations as set by law, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and an insurance investment contract as investment options for participants. The Plan operates under an automatic enrollment program, under which after a participant receives a notice from the Plan Administrator of eligibility, if the participant does not make an elective deferral contribution election, the participant will be deemed to have an automatic contribution. The elective deferral contribution amounts are specified in the table below:

<u>Employment Period</u>	<u>Percentage of Compensation</u>
Initial period*	3%

2nd year after initial period	5%
3rd year after initial period	6%

\* The initial period begins when you are first eligible and continues until the end of the subsequent Plan year.

The Company may make various types of employer contributions, including safe harbor matching contributions. A participant is eligible to receive all above employer contributions after completing 3 months of service and age 21. During the year, the Company contributed safe harbor matching contributions in an amount equal to: (i) 100% of the matched employee contributions that are not in excess of 1% of compensation, plus (ii) 50% of the amount of the matched employee contributions that exceed 1% of compensation but that do not exceed 6% of total compensation. The Company did not make other types of employer contributions during the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, employer contribution, and an allocation of investment earnings and charged with an allocation of investment expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their contributions and any qualified non-elective contributions made on their behalf. Participant's interest in their safe harbor matching contributions account will vest based on the participant's years of vesting service (defined below) in accordance with the following schedule:

Payment of Benefits

On termination of service due to death, disability, or retirement, termination, or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account, in either a lump-sum amount, or in installments over a designated period of time.

Notes Receivable from Participants

Participants may borrow from their participant account at a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the participant's vested interest in the Plan. The loans are secured by the balance in the participant's account and bear reasonable interest rates which were 4.25%-9.50%. Loan terms currently range from 1 to 5 years. Principal and interest are paid ratably through payroll deductions.

Forfeited Accounts

Forfeitures are used to reduce employer contributions in the Plan. At December 31, 2024 and 2023, there were forfeitures held in the amount of \$8,842 and \$1,117, respectively. The forfeited accounts will be allocated or used to pay administrative expenses or fund future employer contributions as soon as administratively feasible. Forfeitures of \$2,250 were used during 2024 to pay Plan expenses.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value and contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements. See Note 4 for further explanations of contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Subsequent Events

Subsequent events have been evaluated for potential recognition and/or disclosure through October 14, 2025. This represents the date the financial statements were available to be issued.

**NOTE 3. CERTIFICATION OF ASSETS AND INCOME**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under the ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, (collectively as "Empower"), the custodians of the Plan, as complete and accurate to the best of their knowledge, except for comparing such information certified by the custodians to information included in the Plan's financial statements and supplemental schedules.

**NOTE 4. CONTRACT WITH INSURANCE COMPANY**

The Plan has a benefit-responsive investment contract with Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. At December 31, 2024 and 2023, contract value equals the fair value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value, which approximates contract value, of the investment contract at December 31, 2024 and 2023 was \$58,066 and \$54,164, respectively. Interest rates are reviewed on a quarterly basis for resetting.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include but may not be limited to the following: (1) partial or complete Plan termination; (2) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs.

**NOTE 5. FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered investment companies. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting year.

**NOTE 6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investment contract with an insurance company is managed by Empower. Empower is the custodian of this investment and, therefore, this investment qualifies as a party-in-interest.

Administrative expenses paid directly from the Plan assets to the party-in-interest stated above or its related affiliates totaled \$51,904 for the year ending December 31, 2024. Other service providers including the Plan's investment advisor and the Plan's TPA were paid directly from the Plan's assets. The transactions are considered exempt party-in-interest transactions.

Notes receivable from participants, totaled \$176,379 and \$132,474 at December 31, 2024 and 2023, respectively, and qualify as party-in-interest transactions.

**NOTE 7. PLAN TERMINATION**

The Company anticipates and believes that the Plan will continue without interruption but has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the Plan assets would be distributed to participants on the basis of their prorated values at the termination date.

**NOTE 8. TAX STATUS**

The Company has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with a cash or deferral arrangement, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

FASB ASC 740-10-5 requires the Plan Administrator to annually evaluate the Plan's tax positions, including accounting and measurement of uncertain tax positions. For the year ending December 31, 2024, the Plan Administrator concluded that no uncertain tax positions had been taken that would require adjustment to or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by federal, state, or local tax authorities for years before 2021.

**NOTE 9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 10. PROHIBITED TRANSCATIONS AND DELINQUENT PARTICIPANT CONTRIBUTIONS**

During the years ended December 31, 2024, 2023, and 2022, the Company inadvertently failed to deposit \$657,184, \$547,870 and \$267,069, respectively of participant contributions within the required timeframe as stated by the United States Department of Labor regulations. To correct these failures, the Company will deposit lost earnings to participants accounts. The Company will also file Form 5330 and pay the applicable excise taxes related to the lost earnings. The lost earnings and excise tax payments will be paid from the Plan Sponsor's assets and not from the assets of the Plan.
