INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Amarillo National Bank Health Benefit Plan and Trust** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits and of plan benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and in plan benefit obligations for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.



- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Supplemental Schedules Required by ERISA

The supplemental schedules, Schedule H, Part IV (4i) – Schedule of Assets (Held at End of Year) and Schedule H, Part IV (4j) – Schedule of Reportable Transactions as of and for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the **Amarillo National Bank Health Benefit Plan and Trust** (the Plan) provides only general information. Participants should refer to the Plan agreement and to the current Plan document for a more complete description of the Plan's provisions.

General

The purpose of the Plan is to provide health and certain welfare benefits covering substantially all employees and qualified retirees of Amarillo National Bank (the Sponsor) and all related participating companies. The Plan and related trust were established on January 1, 1983. The Plan and trust are subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The trust is also subject to certain provisions of the Internal Revenue Code.

Amarillo National Bank serves as the Plan's trustee and investment custodian.

Benefits

The Plan provides health benefits (medical, hospital, surgical and major medical) to full-time employees who have completed a 60-day waiting period (or, if classified as an officer of the Sponsor, is actively at work on the first day of employment) and actively working at least 30 hours per week. Benefits are also provided to dependents of active employees, certain former employees, or qualified retired employees.

Under the Plan, eligible active employees and dependent participants may elect to be covered under a self-insured PPO option or a high-deductible option (HDHP). For those participants electing the HDHP option, the sponsor will make discretionary contributions to a Health Savings Account (HSA) in the name of the participant. The Plan is managed by Insurance Management Services (IMS) who serves as the third-party administrative services provider with respect to payment of such health benefits. Retirees are covered under a fully-insured option through United Healthcare.

Wellness Benefits

Wellness benefits are expenses paid from the Trust that are not specifically covered by the Plan. Items such as health screenings, weight loss programs, flu shots for Bank employees not participating in health insurance, and other such expenses are covered.

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of supplemental and dependent life insurance and supplemental accidental death and dismemberment insurance programs based on the current group rate premium cost. The Sponsor pays the full cost of basic life insurance, basic accidental death and dismemberment insurance, long term disability, short term disability and prescription benefits.

For employees retiring prior to December 31, 2017, the costs of the post-retirement benefits plan are shared by the Sponsor and retirees. Retiree contribution rates are \$1,200 per year for retiree, \$6,108 for spouse and \$4,560 for surviving spouse. For employees retiring after December 31, 2017, the retiree is responsible for the full cost of coverage.

The Sponsor makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the plan's net assets over benefit obligations is funded by the Sponsor on a pay-as-you-go basis.

Risk Assurance

As of December 31, 2024, the Trustee of the Plan has limited the risk through the purchase of stop-loss type insurance. The stop-loss insurance limits the Sponsor's liability on specific claims to \$150,000 per individual and the stop-loss aggregate, which was approximately \$9,726,000 in 2024.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. Significant estimates subject to change in the near future are the amount of estimated health claims incurred but not reported, and the post-retirement benefit obligations.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Sponsors' Contributions

The Sponsor and associated companies make contributions to the Plan on a monthly basis. The Trust makes payments to the claims processor each week for self-insured benefits to be paid on behalf of the Plan, in addition to various insurance companies for insured benefits.

Health Claims Payable

Health claims are accrued when presented by the service provider to the third-party administrator for reimbursement.

Estimated Health Claims Incurred But Not Reported

The estimated provision for claims incurred but not reported is determined based on claims history provided by the third-party administrator and actual claims experience subsequent to year end.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

NOTE 3 - INVESTMENT INFORMATION CERTIFIED BY AMARILLO NATIONAL BANK

The following is a summary of the asset information as of December 31, 2023 and 2022, included in the Plan's financial statements and supplemental schedule that was prepared by or derived from information provided by Amarillo National Bank and furnished to the Plan Administrator. The Plan Administrator has obtained certification from the custodian that the information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following Plan assets:

Amarillo National Bank also certified to the completeness and accuracy of \$131,939 and \$102,904 of interest income related to the aforementioned assets for the years ended December 31, 2024 and 2023, respectively.

NOTE 4 - ADMINISTRATIVE EXPENSES

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, insurance brokers, and auditors. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses are paid by the Sponsor on behalf of the Plan.

NOTE 5 - BENEFIT OBLIGATIONS - POST-RETIREMENT HEALTHCARE BENEFITS

The Sponsor provides post-retirement healthcare benefits to former employees who meet certain eligibility requirements, including age and years of employment with the Bank, and who have retired prior to December 31, 2017. At December 31, 2024 and 2023, the accumulated post-retirement benefit obligations were approximately \$1,118,000 and \$1,383,000, with partially funded plan assets held in trust for post-retirement healthcare benefits of approximately \$60,000 and \$177,000, resulting in an unfunded benefit obligation of approximately \$1,178,000 and \$1,206,000, respectively.

During 2017, the Sponsor amended the Plan to eliminate the retiree benefit for active-eligible participants not currently receiving benefits (i.e. non-retirees).

For the year ended December 31, 2023, the present value of the expected post-retirement benefit obligation was determined by an independent actuary and was the amount that resulted from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, or retirement) between the valuation date and the expected date of payment.

For the year ended December 31, 2024, the Sponsor ceased the engagement of an actuary for estimate of the benefit obligation. Instead, management utilized the expected payments provided by the actuary in their 2023 report to estimate annual amortization of the remaining benefit obligation. This calculated amortization was adjusted for an expected return on plan assets of 5.00% and a discount rate of 4.78% for changes in present value.

For measurement purposes, a 5.0% weighted-average annual rate of increase in the average per capita cost of covered health care benefits was assumed for 2024 and 2023; the rate was assumed to remain at 5.0% for 2025.

NOTE 6 - PLAN TERMINATION

Although it has not expressed the intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Sponsor or be used for purposes other than for exclusive benefit of the Plan's participants.

NOTE 7 - TAX STATUS

The trust established to hold the Plan's net assets is not intended to be qualified pursuant to Section 501(c)(9) of the Internal Revenue Code. Thus, the trust's net investment income is subject to income taxes to the extent it exceeds eligible deductions from the trust. Since inception, eligible deductions have exceeded net investment income. No income tax has been paid or is believed to be due.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and has taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

NOTE 8 - TRANSACTIONS WITH PARTIES - IN - INTEREST

Certain Plan assets were held in trust and managed by the custodian of the Plan. As described in Note 1, the Plan has several arrangements with service providers, these transactions are party in interest transactions under ERISA. Transactions and balances maintained within the Plan's money market funds maintained by the Plan sponsor are also party in interest transactions.

Administrative Fees paid from Plan assets to the Plan's third-party claims processor, Insurance Management Services, Inc., a party-in-interest were approximately \$293,000 and \$228,000 for the years ended December 31, 2024 and 2023, respectively. Brokerage commissions and fees paid from Plan assets to the Plan's insurance brokers, parties-in-interest, were approximately \$166,000 and \$162,000 for the years ended December 31, 2024 and 2023, respectively.

NOTE 9 - RISKS AND UNCERTAINTIES

The present value of benefit obligations is estimated by management based on certain assumptions pertaining to interest rates, health care cost trend rates, employee demographics, and retiree life expectancy, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 10 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Fund: Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily net asset value (NAV) and to transact at that price. The money market fund is deemed to be actively traded.
