Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the accompanying financial statements of ABC Security Service, Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ABC Security Service, Inc. Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. DESCRIPTION OF PLAN:

The following description of the ABC Security Service, Inc. (Company) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all employees of the Company who have completed one year of service (defined as twelve consecutive months and at least 1,000 hours). As of April 1, 2010, an employee must attain the age of 21 before entering the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). It was created on January 1, 1993 and has been amended various times since then. This note includes the provisions of the Plan as amended.

Contribution and allocation information:

Non-elective profit sharing contributions are discretionary and are set by the Company's board of directors. An employee must work 1000 hours during the Plan year and be an employee on the last day of the Plan year to receive an allocation of the profit sharing contribution in proportion to their compensation for the Plan year. These rules will be waived in the case of termination of employment on or after 1) full retirement age (65) or 2) early retirement age (55) and six years of service.

Participant accounts:

Each participant's account is credited with an allocation of (a) the Company's contribution and, (b) Plan earnings. Allocations are based on participant earnings or annual compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant receives 20% vesting for each year of credited service and is 100% vested after five years if the first day of employment was on or before September 1, 1999. If the first day of employment was after September 1, 1999, a participant starts vesting after three years of service and receives 20% vesting for each year thereafter and is 100% vested after seven years. If the first day of employment was on or after April 1, 2010, a participant starts vesting after two years of service and is 100% vested after six years. While a participant is an employee, he or she will become 100% vested upon death, total and permanent disability or upon reaching normal retirement age. During 2010 participants were allowed to contribute to their accounts. The feature was terminated in 2011. However, participants are immediately vested in their contributions plus actual earnings thereon.

Payment of benefits:

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in either a lump-sum amount, substantially equal installments, or partial withdrawals of \$1,000 or more.

Note 1. DESCRIPTION OF PLAN (Continued):

Plan expenses:

Plan expenses may be paid by the Company. Expenses for operating and maintaining the Plan that are not paid by the Company will first be paid from forfeitures available for allocation and then from individual accounts, except that any expenses attributable to the single sum benefit payment fee for a distribution other than at death, total and permanent disability or retirement shall be charged against that participant's individual account.

Forfeitures:

All forfeitures will be deposited into a suspense account and will be applied toward Plan expenses and toward employer contributions as they accrue. Forfeitures reallocated to participants during the year ended December 31, 2024 totaled \$2,338. The balance of the suspense account at December 31, 2024 was \$2,319.

Note 2. SUMMARY OF ACCOUNTING POLICIES:

Basis of accounting:

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Plan's stable value fund within its group annuity contract with Standard Insurance Company (SIC) is believed to be fully benefit responsive. Accordingly, the Statement of Net Assets Available for Benefits presents the insurance contract at contract value that approximates fair value.

Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of benefits:

Benefits are recorded when paid.

Note 3. GROUP ANNUITY CONTRACT AND PARTICIPANT DIRECTED INVESTMENTS (Unaudited):

Through March 31, 2010, the Plan was funded with a group annuity contract with Standard Insurance Company (SIC) at which time JP Morgan Chase became the Trustee of the Plan. On November 19, 2010, the Trustee of the Plan changed from JP Morgan Chase to Reliance Trust Company. On January 1, 2011, the Plan terminated the Trust Agreement with Reliance Trust Company as well as the Administrative Services Agreement with Automatic Data Processing. On the same date, the Plan adopted the Standard Retirement Services, Inc. Volume Submitter Profit Sharing Plan and entered into

a group annuity contract with Standard Insurance Company (SIC). The assets were transferred to SIC on February 1, 2011. SIC maintains the contributions in a pooled separate account. The separate account is composed of mutual funds and a stable value fund. The account is credited with actual earnings on the underlying investments and charged for Plan withdrawals and administration expenses charged by SIC. Investments are directed by the participants.

The December 31, 2024 and December 31, 2023 Statements of Net Assets Available for Benefits and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared from information certified by SIC to be complete and accurate in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$1,114,465 and \$985,168 at December 31, 2024 and December 31, 2023 respectively and the related income and deductions for the year ended December 31, 2024.

The stable value fund within the separate account is believed to be fully benefit responsive and is appropriately valued at contract value which approximates fair value. Certain events may limit the ability of the plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. The plan administrator does not believe that the occurrence of any such value event is probable.

Note 4. TAX STATUS:

The Plan obtained its determination letter on March 2, 1995, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter and the Plan has adopted and relied on the prototype or volume submitter plans of various institutions over the years and has relied on the corresponding opinion letters from the Internal Revenue Service. On January 1, 2011, the Plan adopted the Standard Insurance Company Group Annuity Contract under a volume submitter profit sharing plan. The Plan is operating under the most recent opinion letter received by the volume submitter plan dated June 30, 2020. Since then the volume submitter plan was amended to be in compliance with further legislative and regulatory changes. The plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Note 5. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8. FAIR VALUE MEASUREMENTS (Continued):

The underlying mutual funds of the Separate Account certified by SIC are traded daily on an active market although the Separate Account is not itself publicly traded. SIC buys and sells shares of mutual funds through its Separate Account. SIC then allocates portions of that fund to its retirement plan clients by establishing a unit value which incorporates changes in market value of the underlying mutual funds, reinvestment of all dividends and capital gains received from the fund company, any revenue sharing SIC expects to receive from the fund company and SIC's fee calculated on a daily basis and based on the total underlying assets of the Plan. The Stable Asset Fund II is not actively traded and significant other observable inputs are not available. Thus, the contract value of the Stable Asset Fund II represents net deposits plus interest credited. Crediting rates are reset periodically and in advance and are guaranteed per the terms of the contract. The average crediting rate is .60% for 2024 and .43% for 2023.

Note 9. PARTY IN INTEREST TRANSACTIONS:

Certain plan investments are shares of mutual funds through separate pooled accounts managed by Standard Insurance Company (SIC). SIC is the custodian, as defined by the plan, and is considered a party in interest as defined by ERISA. The selection of these investment options was determined to be prudent and in the best interest of plan participants and beneficiaries, in accordance with ERISA.

The plan sponsor and the plan auditor are also considered parties in interest due to their administration and oversight of the plan.

The transactions are conducted in the normal course of plan operations. No prohibited transactions were identified.

Note 10. SUBSEQUENT EVENTS:

Subsequent events were evaluated through October 6, 2025, the date on which the financial statements were available to be issued.


