Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the CUBRC and Avarint Employee Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statement or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statement or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Notes to Financial Statements

1. Description of the Plan

The following brief description of the CUBRC and Avarint Employee Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a pre-approved prototype profit sharing/401(k) plan sponsored by CUBRC, Inc. (the “Plan Sponsor”) and covers substantially all employees of the Plan Sponsor and its wholly-owned subsidiary, Avarint, LLC (“Avarint”), who have attained the age of 21. The Plan was established January 1, 2011 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). In accordance with the Plan agreement, the following classes of employees are excluded from eligibility:

- Employees who are residents of Puerto Rico;
- Employees covered by a collective bargaining agreement;
- Leased employees;
- Non-resident aliens; and
- On-call employees, seasonal employees, temporary employees, and interns (unless these employees attain the age of at least 21 and complete at least 1,000 hours of service).

Contributions – Participants may elect to contribute between 1% and 100% of their annual compensation, limited by the amount imposed by law. Additionally, participants age 50 or older may elect to make a catch-up contribution limited to the amount imposed by law.

All employees receive safe-harbor contributions from the Plan Sponsor equal to 3% of their compensation. Additionally, the Plan Sponsor makes profit sharing contributions to eligible participants equal to 7% of participant compensation for all participants who have worked for the employer for seven years or more. Participants who have worked for the employer for more than one year, but less than seven, receive profit sharing contributions equal to 5% of participant compensation.

Participant Accounts – Individual trust fund accounts are established and maintained for each participant, illustrating the participant’s interest in the Plan. Each participant’s account is credited with the participant’s contributions, Plan Sponsor contributions, and earnings on the participant-directed investments. Each participant’s account is charged with the participant’s distributions, losses on the participant-directed investments, and expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Vesting – Participants are immediately vested in their salary deferral contributions, Plan Sponsor contributions, rollover contributions and actual earnings thereon.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Payments of Benefits and Withdrawals – Participants may elect to withdraw their funds from the Plan upon death, disability, termination or attaining age 59½. Benefit payments are made in the form of a lump-sum distribution. Participants may apply for a hardship withdrawal by certifying to the Administrator all of the required criteria with documentation substantiating the hardship.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their account balance, reduced by any outstanding loan balance, or \$50,000 reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. A participant may have one loan outstanding in any twelve-month period, and loans are repayable over a period of up to five years, or a maximum of 10 years for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear a rate of interest based on the prevailing interest rates for loans which would be made under similar conditions. Principal and interest is paid ratably through monthly payroll deductions. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Income Taxes – The Plan obtained a letter dated June 30, 2020 in which the Internal Revenue Service (“IRS”) stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Plan Termination – Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan agreement to terminate the Plan at any time, subject to the provisions of ERISA.

2. Summary of Significant Accounting Policies

Basis of Accounting – The accompanying financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Valuation of Investments – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

CUBRC and Avarint Employee Retirement Plan

Notes to Financial Statements (continued)

2. Summary of Significant Accounting Policies (continued)

The Plan presents in the accompanying statements of changes in net assets available for benefits the net appreciation in the fair value of its investments which consists of the realized gains and the unrealized appreciation of those investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Benefit Payments – Benefits are recorded when paid.

Administrative Expenses – Certain accounting and administrative expenses of the Plan are paid by the Plan Sponsor. Expenses relating to certain investment activity are paid by participants from their respective individual accounts.

Party-in-Interest Transactions – For the years ended December 31, 2024 and 2023, certain Plan investments are units of participation in mutual funds managed by Fidelity Management Trust Company (“Fidelity”), the Plan trustee, as defined by the Plan document. Therefore, these transactions qualify as party-in-interest transactions.

Risks and Uncertainties – Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term could materially affect participants’ account balances and the amounts reported in the accompanying financial statements.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein. Accordingly, actual results may differ from those estimates.

Subsequent Events – The Plan Administrator has evaluated subsequent events, for recognition or disclosure, through July 15, 2025, the date the accompanying financial statements were available to be issued, and determined that no additional recognition or disclosure was necessary.

3. Information Certified by the Trustee (Unaudited)

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity has certified that the investments and participant loans included in the accompanying financial statements and supplemental schedule are complete and accurate at December 31, 2024 and 2023, respectively.

Fidelity also certified interest and dividend income of \$1,524,255 and \$1,051,064 and net appreciation in fair value of investments of \$5,017,582 and \$5,491,911 for the years ended December 31, 2024 and 2023, respectively.

4. Fair Value Measurements

ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- **Level 1** – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.
- **Level 2** – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. This level also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security. There were no assets of the Plan that were valued using Level 2 inputs at December 31, 2024 and 2023.
- **Level 3** – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability. There were no assets of the Plan that were valued using Level 3 inputs at December 31, 2024 and 2023.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end.

4. Fair Value Measurements (continued)

Collective Investment Fund (“CIF”): The CIF is valued daily at net asset value (“NAV”), as a practical expedient, based on the market value of the underlying assets. NAV is determined by dividing the fair value of the CIF’s net assets by the total number of units owned. The CIF invests primarily in a variety of high-quality stable value investment contracts as well as cash and cash equivalents. It is intended that the CIF’s stable value investment contracts will maintain a minimum weighted average credit quality rating of “A” or better. Unitholders may redeem units, but the units may not otherwise be transferred without the consent of Principal Global Investors Trust Company.

5. Reconciliation with Form 5500

The accompanying financial statements, which are prepared in accordance with U.S. GAAP, calculate realized gains and losses on sales of securities and unrealized gains and losses (change in market value on securities held at year end) using historical cost. However, Form 5500, Annual Return/Report of Employee Benefit Plan, requires the calculation of such gains and losses to be measured on the basis of revalued cost on Schedule H. Revalued cost is calculated based on the market value of a security on the first day of the fiscal year plus the cost of any current year purchases, less the beginning market value of any current year sales. In total, however, the financial statement calculation of gains and losses and the calculation for Form 5500 are the same.
