Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the 401(k) Profit Sharing Plan for Employees of Santa Fe South Schools, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED DECEMBER 31, 2024

1. PLAN DESCRIPTION

The following description of the 401(k) Profit Sharing Plan for Employees of Santa Fe South Schools, Inc. (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering the employees of Santa Fe South Schools (the “Company”). The plan covers fulltime employees of Santa Fe South Schools, Inc. (the “Company”). Employees are eligible to participate in the plan after reaching 21 years of age and completing 3 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The plan administrator determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Participant contributions – Eligible participants may contribute up to 100% of their eligible compensation, as defined by the Plan, not to exceed the maximum amounts established by federal law. The Plan was amended, effective July 1, 2022, whereby participants of the Plan will be automatically enrolled to contribute 1% of their eligible compensation, unless participants elect a different contribution amount or declines to participate in employee deferrals. Participants who were automatically enrolled to contribute to the Plan will have their deferral percentage increased by 1% each July, up to a maximum of a 3% deferral percentage. The Company may make discretionary non-elective contributions based on each participant’s eligible compensation, as defined by the Plan. Participants may direct their contributions and employer contributions among various investment options offered through the Plan. Participants may change their investment options at any time.

During the year ended December 31, 2024, certain employee contributions to the Plan were not remitted to the plan on a timely basis as required by the Department of Labor. The total amount of delinquent contributions was \$351,443. These contributions were ultimately deposited within 18 days of the required remittance date. Plan management has instituted additional procedures to ensure future contributions are remitted in a timely manner.

Employer contributions – At its discretion, the Company may provide matching contributions on behalf of each participant at a rate determined by the Company’s board of directors. In 2024, the Company made nonelective discretionary contributions equal to 7% percent of eligible employee compensation, as defined by the Plan. Company contributions are subject to Internal Revenue Code (“IRC”) limitations. Participants direct the investment of all participant and employer contributions.

Participant accounts – Each participant’s account is credited with the participant’s contributions and allocations of the Company’s contributions and plan earnings or losses and charged with applicable plan expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment options – Upon enrollment in the Plan, a participant directs contributions among the investment options provided by the Plan. Participants may change their investment options anytime throughout the year via internet or direct phone access to the Plan’s third-party administrator.

Vesting – Participants are immediately vested in their contributions as well as actual earnings or losses on those amounts. Vesting of all employer contributions is based on continuous years of service.

Any participant who attains normal retirement age, becomes disabled, or dies, becomes fully vested regardless of length of service and will receive all benefit payments in accordance with distribution provisions of the Plan.

Forfeited accounts – Forfeited non-vested accounts are used to reduce future employer contributions or pay plan expenses under the terms of the Plan. During 2024, no forfeitures were used to pay plan expenses or to reduce employer contributions. There were approximately \$154,000 and \$7,900 forfeited non-vested amounts held in the Plan as of December 31, 2024, and 2023, respectively.

Payment of benefits – Upon death, permanent disability, retirement, or termination of service, participants whose total account balance does not exceed \$7,000 will automatically receive a distribution of all vested amounts in their participant account. Participants whose total account balance exceeds \$7,000 may receive all vested amounts immediately or as soon as administratively feasible. Beneficiaries of a deceased participant may elect to postpone payment to a later date within 5 years of the qualifying event. All non-vested amounts are forfeited.

Plan termination – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts, and the Trustee shall be directed to distribute all assets in the Plan to participants in the same manner as if each participant had then retired.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan’s valuation policies utilizing information provided by investment advisors, the trustees and other third parties. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change includes the Plan’s gains and losses on investments bought and sold, as well as held, during the year.

Payment of benefits – Benefits are recorded when paid.

Administration – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to benefit payments are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included as an offset to net change in fair value of investments.

Subsequent events – The Plan Administrator has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED OR PREPARED BY TRUSTEE

The following is a summary of the Plan’s asset information as of December 31, 2024, and 2023, and for the year ended December 31, 2024, included throughout the Plan’s financial statements and supplemental schedules, which was prepared by or derived from information provided by Mutual of America Financial Group. (the “Custodian” to the Plan) and furnished to the Plan administrator. The plan administrator has obtained certifications from the Custodian that the information provided to the plan administrator by the Custodian related to the following assets and earnings is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and supplemental schedules including Schedule H, line 4i, Schedule of Assets (held at year end) and the following:

4. FAIR VALUE MEASUREMENTS

The Plan measures fair value in accordance with accounting standards that establish a fair value hierarchy based on the observability of inputs used to measure fair value. These inputs are summarized in the three broad levels listed below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value of measurement.

The Plan uses appropriate valuation methods based on the available inputs to measure the fair value of its assets and liabilities.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for plan benefits, as well as the general classification of such assets pursuant to the valuation hierarchy.

The fair value of pooled separate accounts is based on NAV per unit, using the practical expedient. The NAV is based upon the value of the underlying assets owned by the account, minus its liabilities, and then divided by the number of units outstanding. The NAVs of the underlying investments are quoted in an active market.

Due to the short-term nature of the money market account, fair value approximates the respective account balance.

Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. RISKS AND UNCERTAINTIES

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the

near term, and such changes could materially affect the amounts reported in the statement of net assets available for benefits.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain investment funds are managed by Mutual of America Financial Group, and therefore qualify as party-in-interest transactions.

7. TAX STATUS

The Plan uses a prototype plan document which received a determination letter from the IRS, dated November 30, 2020, stating that the prototype document satisfies the applicable provisions of the IRC. The prototype document and the Plan itself have since been amended, and no further determination letter from the IRS has been received. Plan management believes that these amendments have an insignificant impact to the IRS determination, and therefore, Plan management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. OPERATIONAL ERRORS AND CORRECTIVE ACTIONS

During the year ended December 31, 2024, the Plan identified certain operational errors related to participant deferrals:

- Certain employees had eligible compensation excluded from the calculation used to determine employee contributions during the Plan year.
- In certain cases, deferral elections submitted by employees were not properly executed in the plan sponsor's payroll system.

The plan sponsor is reviewing impacted participants and determining the required corrective actions in accordance with IRS correction principles, including making qualified nonelective contributions (QNEC) to the affected participants' accounts to compensate for missed deferrals, as well as any applicable earnings. The plan sponsor has determined that any corrective contributions will be immaterial to the Plan as a whole. The plan sponsor has implemented additional controls to help ensure compliance with the Plan's automatic enrollment and deferral election provisions in the future.
