INDEPENDENT AUDITOR'S REPORT

To the Hamilton Community Health Network, Inc. 401(k) Plan Participants

Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the accompanying financial statements of Hamilton Community Health Network, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Hamilton Community Health Network, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note three to the financial statements, is complete and accurate.

Opinion

Notes to the Financial Statements

A. Description of the plan

The following brief description of the Hamilton Community Health Network, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document, adoption agreement and plan summary for a more complete description of the Plan's provision. Plan custodian was Mutual of America in 2024 and 2023.

General

The Plan is a defined contribution plan that covers substantially all employees of Hamilton Community Health Network that are 21 years of age or over. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). A participant becomes eligible for the plan at the age of 21 and after 180 days of service. In order to share in any annual employer safe harbor contributions and employer discretionary contribution, a participant must also be employed on the last day of the plan year and must have completed at least 1,000 hours of service during the plan year. The Plan was restated effective November 15, 2016. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants are enrolled at a set deferral rate of 3% of eligible compensation and contributions are invested in a designated balanced fund until changed by the participant. The Plan allows for Roth deferrals.

Contributions

Participants may contribute a percentage of their base pay by means of payroll deductions, subject to certain discrimination tests prescribed by the Internal Revenue Code and other limitations specified in the Plan. A maximum deferral of \$23,000 and \$22,500 was allowed in 2024 and 2023, respectively. In addition, participants who are age 50 or older were allowed to defer an additional \$7,500 and \$6,500 in 2024 and 2023. The employer portion of the Plan includes a 3% safe harbor match and a discretionary contribution which was 3% for 2024 and 2024.

Participants Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings (losses). The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

Vesting

A participant has a 100% vested interest at all times in their account attributable to elective deferrals and rollovers. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service. Vesting for employees hired before January 1, 2012 are subject to a separate vesting schedule increasing in 20% increments after 1 year of service to 100% vesting after 5 years of service.

Participant Loans

Participants may borrow from their account balances at a minimum of \$1,000 up to a maximum of the lesser of \$50,000 less the outstanding loan balance during the one-year period prior to the new loan application date, or 50% of the participant's account balance less any current outstanding balance. Participants may only take out one loan during any 12-month period and may only have one loan outstanding at a time. The loans are secured by the balance in the participants' account. Interest charged on loans is at a rate similar to loans from commercial lending institutions and is credited as earnings to the participant's account balance. Principal and interest are paid ratably through payroll deductions. Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest.

Payment of Benefits

The Plan provides for payment of 100% of the account balance to participants upon normal retirement at age 65, early retirement at age 55 with 10 years of service, death, or total and permanent disability. Participants terminating for any other reason are entitled to receive 100% of their vested account balances. Participants may elect to receive their benefits in the form of an annuity, lump sum payment or installment payments, based upon the Plan agreement.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$0, respectively. Forfeitures of the non-vested portion of terminated participant's accounts will be first used to pay any administrative expenses and any remaining forfeitures will be allocated to employee accounts. Forfeitures of \$25,375 and \$28,708 were used in 2024 and 2023, respectively.

B. Summary of Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Participant Loans

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year. Investment income includes dividends, interest, and the net appreciation on assets bought, sold, or held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain administrative functions are performed by officers or employees of the Hamilton Community Health Network. No such officer or employee receives compensation from the Plan. In addition, certain administrative expenses for the Plan are paid directly by Hamilton Community Health Network.

Accounting Changes

The Plan has not adopted any Accounting Standards Updates in the current year.

Date of Management Review

Management has evaluated, for potential recognition or disclosure, significant events or transactions that occurred during the period subsequent to December 31, 2024, through the date of the Independent Auditor's Report, October 3, 2025, which is the date the financial statements were available to be issued.

D. Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use Level 2 or 3 inputs for the period presented.

Level 1

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Mutual of America General Account

The General Account (Interest Accumulation Account) is comparable to a cash equivalent and therefore exempt from classification as a Level 1, 2, or 3 asset under ASU 820-10 for the following reasons:

- There are no front of back end charges, so investments in the General Account are completely liquid;
- The interest rate credited to investments is a current rate, and is not dependent upon length of time the assets are invested with Mutual of America.
- Requests for withdrawal can be made at any time and are processed on the day that they are received; they are not dependent on the Company having to liquidate securities in order to generate a payment;
- The value shown is the redeemable value of the fund: there are no deferred sales charges, load assessments or interest rate adjustments that would affect the value as a result of a withdrawal request.

E. Party-In-Interest and Related-Party Transactions

All plan investments were managed and administered by Mutual of America in 2024 and 2023 therefore, these transactions qualify as party-in-interest transactions as defined in ERISA. Administration and custodial fees totaling \$5,041 and \$8,074 were paid to Mutual of America during the 2024 and 2023 plan year, respectively.

F. Plan Termination

Although it has not expressed any intent to do so, the organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

G. Risks and Uncertainties

The Plan invests in various mutual funds with underlying assets consisting of any combination of stocks, bonds, fixed income securities and other investment securities, and collective investment trusts. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

H. Tax Status

The sponsor adopted a nonstandard prototype plan, which received a favorable opinion letter from the Internal Revenue Service, dated March 31, 2008, indicating that the prototype Plan qualifies under Section 401(a) of the Internal Revenue Code (IRC) and is therefore generally exempt from future taxes under present income tax laws. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification.

The prototype plan has been amended since receiving this opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan may be subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress.
