However, this consideration was **not** for the purpose of expressing an opinion on the effectiveness of the Plan's internal control.

Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified.

## Identified Deficiencies

We identified certain deficiencies in internal control that we consider to be other deficiencies.

### Deficiencies

- During our audit procedures, we noted that the plan sponsor, Inova Surgery Centers, incorrectly calculated the employer match for three of the ten participants sampled, causing those participants to have a deficiency in employer match for the plan year. Upon further investigation, it was determined that participants who elected a flat dollar amount deferral were affected. The plan sponsor intends to correct impacted participants for these errors in the calculation. We recommend the plan sponsor review its policies and procedures over employer matching contributions to ensure the proper calculation of the contributions and that these calculations be reviewed by someone other than the individual performing the calculation. We also recommend management review the matching contributions for 2024 to determine if other participants may have been affected by the calculation error.
- We noted that the Morley Stable Value Fund was classified as a group annuity contract that met the criteria for reporting the contract as a fully benefit responsive guaranteed investment contract at contract value in the 2023 audited financial statements. However, the fund is actually a common collective trust fund that should have been reported at fair value. The Plan had changed its investment offering from the group annuity contract to the Morley Stable Value Fund in 2022. Although there was no difference in the balance reported, there were footnote disclosures that required revisions in the 2024 audited financial statements, including deletion of the disclosure regarding fully benefit responsive investment contract and revisions to the fair value measurement disclosure. We recommend that management understand any changes in investments offered by the Plan, as well as the understanding the determination of the balances reported in the trust statement.

  - c. We believe the significant assumptions or interpretations underlying the measurement and/or presentation of the supplemental schedules are reasonable and appropriate.

- e. There are no subsequent events that require adjustments to the fair value measurements and disclosures included in the financial statements.

***Investments***

42. Investments are properly measured at fair value, except for fully benefit responsive investment contracts which are reported at contract value. Investments measured at fair value include:

- a. Investments with a readily determinable fair value that are reported at net asset value (NAV) per share/unit.

b. Investment values determined using NAV as a practical expedient.

43. The Plan has revised the 2023 financial statements to conform with accounting principles generally accepted in the United States of America. Management has provided you with all relevant information regarding the revision. We are not aware of any other known matters that require correction in the financial statements.
