## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
Coinbase Inc. Retirement Trust:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Coinbase Inc. Retirement Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## NOTES TO THE FINANCIAL STATEMENTS

### AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

---

#### 1. DESCRIPTION OF THE PLAN

The following description of the Coinbase, Inc. Retirement Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the plan instrument for a more complete description of the Plan’s provisions.

**General**—The Plan is a defined contribution plan covering all eligible employees of Coinbase Global, Inc. and its subsidiaries (the “Company” or “Plan Administrator”). Eligible employees include all employees unless they are covered by a collective bargaining agreement, are leased, temporary, or part-time employees, or are non-resident aliens who do not earn income in the United States. Effective January 1, 2023, the eligibility criteria of the Plan were amended. Ninety-days of service is required for part-time, interns, temporary, and fixed-term employees to become eligible to participate in the Plan.

The Company, through action of the Compensation Committee of its Board of Directors, has established the 401(k) Advisory Committee (the “Plan Committee”) and has delegated to the Plan Committee (i) the authority for day-to-day oversight and administration of the Plan, (ii) the authority to act as the investment fiduciary with respect to the Plan, and (iii) certain amendment authority with respect to the Plan. The Company’s investment advisor determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan Committee. Fidelity Management Trust Company (“Fidelity”) serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions**—Each year participants may contribute up to 90% of eligible compensation as defined in the Plan instrument. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants are also allowed to make after-tax contributions limited to 90% of compensation.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at a deferral rate of 5% of eligible compensation approximately 30 days after their hire date.

The Plan provides discretionary matching employer contributions. For the years ended December 31, 2024 and 2023, the Company matched participant contributions at a rate of 50% of up to 2% of eligible compensation. A true-up is calculated at the end of the calendar year to provide employees with the full match amount for the year and is recorded in the statements of net assets available for benefits as employer contributions receivable as of December 31, 2024 and 2023.

Contributions are subject to certain Internal Revenue Code (IRC) limitations.

**Participant Accounts**—Individual accounts are maintained for each participant of the Plan. Each participant’s account is credited with the participant’s and related matching contributions as well as plan earnings. Participant accounts are charged with withdrawals, and an allocation of plan losses

administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**—Employee and employer matching contributions are fully vested upon contribution plus actual earnings thereon.

**Investments**—Participants may direct the investment of their contributions and matching contributions into various mutual funds and a participant-directed brokerage account ("SDBA") offered by the Plan and may change investments and transfer amounts between funds daily.

**Notes Receivable from Participants**—Participants may borrow from their plan accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and a participant may not have more than one loan outstanding at any time. The interest rate shall be determined by the Plan administrator at the time of the loan application and shall be based on prevailing interest rates. Principal and interest is paid ratably through semi-monthly payroll deductions. As of December 31, 2024 and 2023, participant loans have maturities through 2034 at interest rates ranging from 4.25% to 9.50%.

If a participant with an outstanding loan balance terminates in conjunction with a transfer of employees and assets to an unrelated entity, the participants have 90 days to elect rollover to an eligible retirement plan. If a participant is terminated and does not transfer, the loan will be payable based on the original loan note and is no longer immediately due. Upon death, the outstanding loan is immediately due.

**Payment of Benefits**—Upon termination of employment, retirement, death or disability, the balance in the participant's account will be paid to the participant or his or her beneficiaries in a lump sum. In addition, participants may elect in-service withdrawals of their elective deferral account balances after reaching age 59 1/2 or for hardship purposes.

**Forfeited Accounts**—The plan document permits forfeited amounts to be used first to pay reasonable expenses relating to the administration of the Plan. The Plan used forfeited amounts to pay expenses totaling \$8,233 and \$23,626 during the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$30,872 and \$76,821, respectively.

## 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of Accounting**—The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**—The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties**—The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

As of December 31, 2024 and 2023, the concentration of risk associated with Vanguard investments was 86% and 91%, respectively.

**Investment Valuation and Income Recognition**—The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

For the SDBA, participants may direct the investments through a trustee-sponsored brokerage account that offers the option to invest in securities including common stocks, mutual funds, and cash equivalents.

**Notes Receivable from Participants**—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the plan document.

**Payment of Benefits**—Benefit payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan, but had not yet been paid, as of December 31, 2024 or December 31, 2023.

**Administrative Expenses**—Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from the Plan's financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Subsequent Events**—Subsequent events were evaluated through October 13, 2025, the date the financial statements were available to be issued. Effective 1/1/2025, Plan Committee approved the change in matching contribution formula from 50% up to 2% to 50% up to 6% and change in automatic enrollment rate from 5% to 6%. No other events occurred that require additional disclosure or adjustments to the Plan's financial statements.

### 3. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the certified investment information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedules, that were prepared by or derived from information prepared by Fidelity Management Trust Company, the trustee of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustee that such information is complete and accurate:

- Total investments at fair value and notes receivable from participants, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Note 4: All investment balance and investment information, excluding the level of investments.
- Schedule H, Line 4(i)—Schedule of Assets (Held at End of Year) at December 31, 2024.

### 4. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

**Mutual Funds**—Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Participant-Directed Brokerage Accounts**—includes a variety of common stocks and mutual funds. Common stock is valued at the closing price reported on the active market on which the individual securities are traded. Mutual funds are valued as described above.

**5. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

**6. EXEMPT PARTIES-IN-INTEREST TRANSACTIONS**

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. Certain plan investments offered through the participant directed brokerage accounts are owned and managed by Fidelity. The Plan also issues loans to participants, which are secured by the balances in the participants' accounts.

**7. VOLUNTARY COMPLIANCE RESOLUTION**

During 2024, the Company failed to remit certain participant contributions in a timely manner. One instance was identified for a total of \$1,789. The Company computed lost earnings on the late deposit and has made a corrective payment to the Plan.

**8. INCOME TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. The Plan has been amended since receiving the determination letter effective October 20, 2021. The Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
