Opinion

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Forensic Medical 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan which was originally adopted on February 1, 1998 to provide retirement benefits for employees of Forensic Medical Management Services, PLC (the "Plan Sponsor"). The plan was most recently restated effective January 1, 2024. The Plan covers substantially all full-time employees of the Plan Sponsor and its participating subsidiaries, affiliates and locations (collectively, the "Company" or the "Employer"), who are age 21 or older and have completed 30 days of service ("participants"). Participants are eligible to receive employer contributions after completing one year of service and 1,000 hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions: Participants may voluntarily make qualified retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC"). Participant contributions can also be made as Roth contributions, and participants who are age 50 or older in the plan year can make additional catch-up contributions up to the amount allowed under the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participant contributions are permitted up to 100% of eligible compensation, subject to certain IRC limitations.

The Plan Sponsor makes safe harbor contributions each year. During the year ended December 31, 2024, the Plan Sponsor made safe harbor contributions equal to 3.0% of eligible compensation for each participant actively employed during the year.

Additional discretionary profit-sharing amounts are contributed to the Plan as determined by Plan management. The Company did not make additional profit-sharing contributions for the 2024 plan year. A participant's qualification to receive the additional discretionary profit-sharing contribution is based upon each participant's job classification group, as defined in the Plan agreement. To receive the discretionary profit-sharing contribution, a participant must work 1,000 hours in the plan year and be employed on the last day of the plan year.

Plan Sponsor and participant contributions may not exceed the maximum amount deductible for federal income tax purposes.

Participant Accounts: Each participant's account is credited (charged) with the participant's contributions, Plan Sponsor contributions and an allocation of investment earnings (losses). Allocations are based on participant compensation or account balances as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: Participants are immediately vested in their elective salary deferrals plus actual earnings (losses) thereon. Participants also immediately vest in the Plan Sponsor's safe harbor contributions plus actual earnings (losses) thereon. Vesting in any additional discretionary Plan Sponsor profit sharing contributions plus actual earnings (losses) thereon is based on years of continuous service. A participant is 20% vested in the Plan Sponsor's additional profit-sharing discretionary contributions after the first year of service, with the vesting increasing an additional 20% each year thereafter, until 100% vesting is achieved after the fifth year of service. One year of service is defined in the Plan agreement as a minimum of 1,000 hours earned in a calendar year.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Payment of Benefits: On termination of service due to death, permanent disability, or retirement, a participant may elect to receive either a lump sum payment or installments over a specified period equal to his or her entire account balance. For termination of service due to other reasons, a participant will be entitled to receive only the vested interest in his or her account as a lump sum distribution. In-service withdrawals are available to a participant if they have attained the later of age 65 or 5 years of participation.

Forfeited Accounts: Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor's additional discretionary contribution portion of their accounts. Such forfeitures are used to reduce the Plan Sponsor's future contributions to the Plan.

Hardship Withdrawals: The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals may be taken from the participant's elective account, rollover contributions, transfer contributions, fully vested Plan Sponsor contributions, and earnings (losses) thereon.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees incurred by the Plan for investment management services or recordkeeping are netted within net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment from the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Payment of Benefits: Benefits are recorded when paid.

Excess Contributions: Refunds of excess participant deferral contributions may be required to satisfy the relevant nondiscrimination provisions of the Plan. Such refunds are accrued as a liability and a reduction in contributions in the Plan year in which the excess deferrals were made to the Plan.

Risks and Uncertainties: The Plan holds various investments. In general, investment securities are exposed to various risks, such as interest rate, credit, liquidity, and overall market volatility as well as the risks associated with global events. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels in the fair value Hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments:

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust: The fair values of participation units held in the collective trust are based on the net asset values per unit as reported by the fund manager. The collective trust provides for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

NOTE 4 - INCOME TAX STATUS

The Plan adopted a prototype 401(k) profit-sharing plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the prototype plan was designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is, therefore, qualified and exempt from taxation.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Therefore, these transactions and the Plan's payment of fees to The Vanguard Group, Inc. and its affiliates qualify as party-in-interest transactions.
