## INDEPENDENT AUDITOR'S REPORT

To the Best Egg 401(k) Plan Administrator

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Best Egg 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Best Egg 401(K) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more detailed and complete description of the Plan’s provisions.

#### ***GENERAL***

The Plan is a defined contribution plan covering all eligible employees of Best Egg, Inc. (the “Company”) and Best Egg Services, LLC (the “Plan Sponsor”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Effective September 1, 2024, the Marlette Funding, LLC 401(K) Plan changed its name to the Best Egg 401(K) Plan. No changes were made to benefits or provisions. The Plan was established on January 1, 2014 as a prototype plan. Reliance Trust Company (“Reliance”) serves as the trustee of the Plan, and the Plan uses Automatic Data Processing, Inc. (“ADP”) as the recordkeeper. The Investment Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

#### ***ELIGIBILITY***

Employees are eligible to participate in the Plan after attainment of age 21. There is no service requirement for participation in the Plan. Employees who are interns with the Plan Sponsor are excluded from participation in the Plan.

#### ***CONTRIBUTIONS***

Each year, participants may contribute any combination of pre-tax elective deferrals and Roth elective deferrals from 1% to 90% of the participants’ eligible compensation, up to the annual maximum allowed by the Internal Revenue Code (the “Code” or “IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as allowed by the Internal Revenue Service (“IRS”). Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

In the event participant contributions exceed contribution limitations of the Plan, excess contributions are refunded to participants after year-end to comply with Code contribution limitations, and are reflected as corrective distributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible

compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company makes safe harbor matching contributions to the Plan equal to 100% of the first 3% of a participant's contribution and an additional 50% of the following 2% of a participant's contribution. The Company provides a true-up contribution in the amount equal to the contributions proportionate to the top tier of personnel and the rest of the employees. This true-up contribution occurs in mid-year of the subsequent year and is presented as employer contribution receivable. Additional discretionary profit-sharing amounts may be contributed at the option of the Company. In order to be eligible for a profit-sharing contribution, a participant must be employed by the Plan Sponsor on December 31 and have completed at least 1,000 hours of service. If a participant's employment by the Plan Sponsor terminates prior to December 31 due to death, disability, or retirement, the participant is eligible to receive a profit-sharing contribution for the year in which the participant was terminated. The Company did not make any profit-sharing contributions during the year ended December 31, 2024.

#### ***INVESTMENT OPTIONS***

Participants may direct the investment of their contributions to the Plan into various investment options offered by the Plan. The Plan currently offers a common collective trust that invests in guaranteed investment contracts and various mutual funds as investment options for participants.

The Pension Protection Act created the Qualified Default Investment Alternative (the "QDIA") which provides employers a safe harbor from fiduciary risk when selecting an investment for a participant or beneficiary who fails to elect his or her own investment. The Plan has selected the Vanguard Target Retirement date fund series as its QDIA.

#### ***PARTICIPANT ACCOUNTS***

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution, if applicable, and appreciation (depreciation) in the fair value of Plan assets and income earned by the Plan.

Each participant's account is charged with withdrawals, plan losses, and an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *NOTES RECEIVABLE FROM PARTICIPANTS*

Participants may borrow from their individual account balances a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of the vested interest of the participant in the Plan, reduced by the excess of the participant's highest outstanding loan balance in the previous twelve months over the existing loan balance as of the date of the new loan. A participant may only have two loans outstanding at a time and may only have one primary residence loan outstanding at a time. The loans are secured by the balance in the participant's account and must bear a defined interest rate.

The rate is based on the prime rate of interest published by the Wall Street Journal on the 14th of the month in which the loan application is processed, plus 2%. The interest rate is effective for any loan processed as of the 16th day of the month. The term of the loan may not exceed five years, except in cases where the participant is acquiring a principal residence and a longer period is agreed to by the participant and Plan management, not to exceed 30 years. Principal and interest are paid ratably through payroll deductions. The interest rate on loans outstanding at December 31, 2024 ranges from 5.25% to 10.50%, and loans mature through April 2054.

##### *VESTING*

Participants are immediately vested in their contributions plus actual earnings thereon and are also 100% vested in the Company's safe harbor contributions plus earnings thereon. Vesting in profit sharing contributions is based on years of service. A participant is fully vested in the Company's profit sharing contributions after six years of credited service, as defined in the Plan's graded vesting schedule. On termination of service due to death, disability or retirement, participants will become fully vested in their accounts. The normal retirement date is the date the participant attains age 65 or the sixth anniversary of the date of the participant's original participation in the Plan, whichever occurs later.

##### *FORFEITURES*

The portion of a participant's account balance attributed to the Company's profit-sharing contributions that is not vested upon termination of employment will be forfeited and used in future periods to reduce the Company's contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$13,963 and \$11,413, respectively. In 2024, \$2,245 of forfeitures were used to reduce employer contributions.

##### *PAYMENT OF BENEFITS*

On termination of service for any reason (including death, disability, and retirement), a participant will receive an amount equal to the value of the participant's vested interest in his or her account, either as a lump sum distribution or as a rollover into another eligible retirement plan. If the participant is cash out-eligible and fails to make a distribution election, the portion of the participant's account balance attributable to Roth elective deferrals and Roth rollover contributions, if any, will be automatically rolled over to a Roth IRA if that portion of the participant's account exceeds \$1,000.

If a participant has an account balance exceeding \$5,000, the participant may elect to receive installments, request a partial withdrawal, or defer receiving payments until age 72. Early withdrawals are permitted at the participant's request after the age of 59-1/2.

If a participant has less than \$5,000 in their account at their termination date, the Plan may elect to make a lump sum distribution of the balance if no other form of payment is elected.

##### *HARDSHIP WITHDRAWALS*

Prior to termination of employment, a participant may withdraw, subject to the Plan's notice requirements, all or a portion of the value of his or her participant account and the vested value of his or her Company contribution account if he or she has attained age 59-1/2 or becomes totally and permanently disabled, or all or a portion of the value of his or her participant account in the event of demonstrated financial hardship, subject to the Plan's provisions. Withdrawals to which a participant is entitled are the amounts that can be provided by the contributions and income thereon (including net realized and unrealized investment gains and losses) allocated to each participant's account, less allocated expenses.

#### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### *BASIS OF ACCOUNTING*

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

##### *USE OF ESTIMATES*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of the Plan assets,

liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***INVESTMENT VALUATION AND INCOME RECOGNITION***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee.

Net appreciation (depreciation) in the fair value of investments includes both realized and unrealized gains and losses, bought and sold as well as held during the year, based on the value of assets at the beginning of the year or at the time of purchase during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are allocated based upon participant account holdings on the record date and are recorded on the ex-dividend date.

Included in investments is an interest in Vanguard Target Retire 2045, which accounts for 16% and 15% of the total investments as of December 31, 2024 and 2023, respectively. Also included in investments is an interest in iShares S&P 500 Index K, which accounts for 11% and 9% of the total investments as of December 31, 2024 and 2023, respectively.

#### ***CONTRIBUTIONS***

Participant and Company matching contributions are made in accordance with the Plan and IRC guidelines, as noted above. Participant contributions are processed through payroll deductions and recorded to the Plan when withheld. Company matching contributions are recorded and earned as participants make their corresponding contributions.

#### ***NOTES RECEIVABLE FROM PARTICIPANTS***

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant's loan balance is reduced and a deemed distribution is recorded. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

***PAYMENT OF BENEFITS***

Benefit payments to participants are recorded when paid.

***MANAGEMENT FEES AND OPERATING EXPENSES***

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected in the net appreciation in fair value of investments.

***ADMINISTRATIVE EXPENSES***

Expenses of maintaining the Plan are paid by the Plan and recorded through administrative expenses, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

***SUBSEQUENT EVENTS***

These financial statements were approved by management and available for issuance on October 14, 2025. Management has evaluated subsequent events through this date. Effective January 1, 2025, the plan trustee was changed from Reliance Trust Company to ADP Retirement Trust Services, LLC. No other events occurred that require additional disclosure or adjustments to the Plan's financial statements.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the investment assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***MUTUAL FUNDS***

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### ***COMMON COLLECTIVE TRUST***

The common collective trust is valued at NAV of shares held by the Plan at year-end. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the common collective trust will sell the investment for an amount different than the reported NAV. The NAV practical expedient is adjusted periodically, usually each business day, to reflect investment results under the common collective trust.

##### **NOTE 5 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain officers and employees of the Company (who may also be participants in the Plan) perform administrative services related to the operation, recordkeeping and financial reporting of the Plan. The Company pays these individuals' salaries and other administrative expenses on behalf of the Plan. Additionally, the Plan extends loans to participants, who are considered parties-in-interest. The Company uses Automatic Data Processing, Inc. as its recordkeeper, and Global Retirement Partners and HUB International Limited as investment advisors for the Plan, who are considered parties-in-interest. Certain fees, to the extent not paid by the Company, are paid by the Plan. During the year ended December 31, 2024, the Plan paid approximately \$100,000 and \$53,000, respectively, to Automatic Data Processing, Inc. and Global Retirement Partners.

These transactions are not deemed prohibited party-in-interest transactions because they are covered by statutory and administrative exemptions from the IRC and ERISA rules on prohibited transactions.

##### **NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, participants will become 100% vested in their account balances.

##### **NOTE 7 - TAX STATUS**

The Company adopted a pre-approved prototype plan offered by the Plan's recordkeeper. The IRS has determined that the prototype plan, by letter dated October 6, 2020, is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

##### **NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes

in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### NOTE 9 - PROHIBITED OR NON-EXEMPT TRANSACTIONS

During 2023 and 2022, the Company failed to timely remit participant contributions of \$1,158,193 and \$574,040, respectively, to the Plan pursuant to 29 CFR 2510.3-102 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Under the regulations, amounts paid by a Plan participant or withheld by an employer from a participant's wages for contribution to the Plan are Plan assets on the earliest date they can reasonably be segregated from the Company's general assets, but in no event later than the 15th business day of the month following the month in which the participant contributions are withheld or received by the Company. As a result, the Company has engaged in a non-exempt prohibited transaction under the ERISA Section 406. The 2022 and 2023 delinquent contributions will be corrected.
