### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of the Proterial Cable America, Inc. 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits – modified cash basis as of December 31, 2024 and 2023 and the related statement of changes in net assets available for plan benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Proterial Cable America, Inc. 401(k) Savings Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 1; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financials are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, on the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

## **Other Matters**

### *Basis of Accounting*

We draw attention to Note 1 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### *Note 1. Significant Accounting Policies*

**Valuation of investments:** Proterial Cable America, Inc. 401(k) Savings Plan (the "Plan") investments in registered investments and guaranteed investment contracts. The shares of registered investments are valued at quoted market prices, which represent the net asset values ("NAVs") of shares held by the Plan at year end. See Note 3 for discussion of fair value measurements.

The Plan also offers a guaranteed investment contract account which, is considered fully benefit responsive and measured at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The changes in the difference between current value and the cost of investments and realized gains and losses are reflected in the statement of changes in net assets available for plan benefits – modified cash basis as an increase or decrease in realized and unrealized appreciation or depreciation in the value of investments.

**Accounting method:** The Plan prepares its financial statements on the modified cash basis of accounting. Under this method, contributions, interest and dividends and other amounts are recognized only when actually received by the Plan. The modified cash basis of accounting is a basis of accounting other than generally accepted accounting principles.

**Estimates and assumptions:** Management uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported revenues and expenses. Accordingly, actual results may differ from these expectations.

**Payment of benefits:** Benefits are recorded when paid.

### *Note 2. Description of the Plan*

The following brief description of the Plan is provided for general information purposes only. Further information about the Plan Document and benefit provisions is available from the Plan Administrator.

**General:** The Plan is a defined contribution plan covering all full-time employees of Proterial Cable America, Inc. (the "Company") who have met thirty days of service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees excluded from the Plan include employees who are considered independent contractors, leased employees, work-study, intern, temporary, or seasonal employees who are scheduled to work less than 1,000 hours in their first twelve months of employment and employees who are employed by the parent or a related company on a temporary assignment in the United States.

Plan management is currently evaluating the provisions of the SECURE Act to determine which amendments will be made, if any, and how the Plan will adopt controls for mandatory provisions as applicable.

**Contributions:** Participants may elect to make pre-tax contributions ("deferrals") as well as after-tax Roth contributions to their employee accounts; participants may contribute up to 100% of eligible compensation, subject to certain limitations under Sections 415(c), 402(g) and 401(k) of the Internal Revenue Code (IRC).

All eligible employees will automatically be enrolled in the Plan with a salary deferral of 3%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company contributes a matching contribution equal to 100% of employee salary deferrals up to 3%, which amounted to \$772,489 for the year ended December 31, 2024. The Employer also has the option to provide discretionary contributions; however, in 2024, the Employer did not provide any such discretionary contribution.

**Vesting:** Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's contribution is based on years of services. For employer matching contributions, a participant is 100% vested after four or more years of credited service in accordance with the following schedule:

Matching Contribution

One year	40%
Two years	60%
Three years	80%
Four or more years	100%

**Investment options:** Upon enrollment in the Plan, a participant may choose to direct contributions to any combination of various registered investment companies, and guaranteed income funds. Participants may change their investment options and transfer funds between investment options daily.

**Taxes:** Participants are not taxed on their pre-tax deferrals, on the employer contributions allocated to their accounts, or on earnings thereon until these amounts are distributed. Roth contributions are made with after-tax amounts. Roth contributions and earnings thereon are withdrawn tax-free provided all required of IRC Section 402A are met.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants can have two loans outstanding at a time. Note transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Note terms range from one to five years or up to twenty years for the purchase of a primary residence. The notes are collateralized by the balance in the participant's account. Notes bear interest rates that are currently being charged by commercial lenders for loans of comparable risks and similar terms and durations. Principal and interest are paid ratably through payroll deductions.

**Forfeitures:** At December 31, 2024 and 2023, there were \$104,297 and \$118,320, respectively of unused forfeitures. Forfeiture accounts can be used to first pay administrative expenses then to reduce future employer contributions. For the year ended December 31, 2024, \$123,725 of forfeitures were used to reduce employer contributions and \$16,245 of forfeitures were used to pay plan expenses.

**Payment of benefits:** On termination of service due to death, disability or retirement (normal retirement age is 65), a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount, installments over a period not more than the assumed life expectancy of the participant or participant's beneficiary or Ad-Hoc distributions for partial or full value of the participant's account, subject to reasonable limits set by the Plan Administrator regarding time and amounts. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution.

In-service distributions are allowed upon attainment of age 59 ½ or for financial hardship. A participant is also able to take distributions on amounts that have been rolled over into the Plan upon request.

**Funding policy:** Deferrals are withheld from eligible participant's wages and are remitted each pay period to the Plan along with the employer matching contributions. These deferrals and the employer contributions are invested based on the instructions provided by the participant.

**Income tax status:** The Plan has adopted the Principal Financial Group Non Standardize Pre-Approved Profit Sharing Plan. The Plan received an option letter from the IRS dated June 30, 2020, stating that the written form of the underlying plan document is qualified under Section 401(a) of the Internal Revenue Code ("IRC"), and that any employer adopting this form of the Plan will be considered to have a Plan qualified under Section 401(a) of the IRC. Once qualified, The Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since the date of the letter, the Plan administrator believes the Plan is designated and currently being operated in compliance with the applicable requirements of the IRC and that the Plan continues to be tax-exempt.

The Plan adopted the provisions of FASB ASC 740, Accounting for Uncertainty in Income Taxes. Accordingly, management has evaluated the Plan's tax positions and concluded the Plan had maintained its tax-exempt status, does not have any significant unrelated business income and had taken no uncertain tax positions that require adjustment or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the Federal authorities for years before 2021.

**Note 3. Investments**

The Fair-Value Measurements topic of the FASB Accounting Standards Codification (FASB ASC 820-10) defines fair value, establishes a framework for measuring fair value in generally accepted accounting principles and expands disclosures about fair-value measurements. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs are other than quoted prices that are observable for the asset or liability. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. The Plan has no Level 2 investments for the years ended December 31, 2024 and 2023.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The Plan has no Level 3 investments for the years ended December 31, 2024 and 2023.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Registered investments:* The fair value of registered investment funds are based on quoted net asset values of the shares held by the Plan at year-end. The fair values of these mutual funds are based on the closing price reported on the active market where the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used at December 31, 2024 and 2023.

**Note 4. Guaranteed Investment Contract**

The Principal Guaranteed Option are guaranteed interest account backed group annuity contract that has been issued by Principal Life Insurance Company. This fund is considered a fully benefit-responsive investment contract and are measured at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expense. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value. A rate of interest contractually guaranteed by Principal Life is credited to participant account balances. No redemption fees, early withdrawal charges, or market value adjustments are charged on participant transfers of assets into or out of the contract however, some restrictions may apply. The Principal Guaranteed Option's net crediting rate as of December 31, 2024 and 2023, were 2.55% and 1.90%, respectively, and resets semi-annually.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: (1) amendments to The Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to The Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that would also limit the ability of the Plan to transact at contract value with the participants.

**Note 5. Information Certified by Principal**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.1038 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company and Principal Trust Company has certified that the following data included in the accompanying financial statements and supplement schedule is complete and accurate.

### *Note 6. Plan Termination*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their employer contributions.

### *Note 7. Transactions with Parties-in-Interest*

The Company provides to the Plan certain accounting and administrative services for which no fees are charged. These transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions. However, under the provisions of ERISA these transactions meet the criteria for exemption, are not considered prohibited transactions, and do not need to be reported in the supplementary schedules of Form 5500.

The Plan invests in shares of guaranteed investment contracts managed by Principal. Principal acts as Custodian for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

### *Note 8. Risk and Uncertainties*

The Plan provides various registered investments, and a guaranteed income account. Investments are exposed to various risks such as interest rate, credit and market. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amount reported in the statements of net assets available for plan benefits - modified cash basis and the statement of changes in net assets available for plan benefits - modified cash basis.
