We have performed an audit of the accompanying financial statements of the Nichols Portland, Inc. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

### 1. Description of Plan

Effective January 1, 2024, the Alpha Precision Group 401(k) Plan was amended and restated to, among other things, rename the Plan to the Nichols Portland, Inc. 401(k) Savings Plan (the Plan). The Plan provides retirement benefits to eligible employees of Nichols Portland, Inc. and its wholly-owned subsidiaries (collectively, the Company or employer). The following description presents only general information about the Plan. Participants should refer to the official Plan document for a complete statement of provisions.

On December 29, 2021, Nichols Portland, Inc., acquired certain assets of Alpha Precision Group, LLC, including the outstanding equity interests of certain of its wholly-owned subsidiaries. In connection with the acquisition, effective December 29, 2023, the Nichols Portland, LLC 401(k) Plan was merged into the Plan, with the Plan being the surviving plan. The Nichols Portland, LLC 401(k) Plan assets were received by the Plan in January 2024.

#### General

The Plan is a defined contribution plan covering substantially all full-time employees of the Company who attained the age of eighteen. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Participants may contribute up to 100% of their eligible compensation, as defined, to the Plan, subject to certain limitations established by the Internal Revenue Code (IRC). In addition, participant contributions may consist of rollovers from other qualified retirement plans.

Effective January 1, 2024, the Company started to provide safe harbor matching contributions equal to 100% of the first 3% and 50% of the next 2% of eligible compensation that a participant contributes to the Plan. Prior to January 1, 2024 no safe harbor matching contributions were provided.

The Company may also provide a discretionary profit sharing contribution to participants. There was no discretionary profit sharing contribution in 2024 and a \$395,000 discretionary profit sharing contribution in 2023.

#### Participant Accounts

All contributions to the Plan are participant-directed among investment options offered by the Plan. Each participant's account is credited or charged with the participant's and Company's contributions, earnings, withdrawals, and an allocation of administrative expenses as outlined in the Plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their contributions and safe harbor matching contributions, plus actual earnings thereon.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear a fixed interest rate of prime plus 1%. Principal and interest are paid ratably through monthly payroll deductions.

### **Distributions**

Generally, no amounts may be distributed to participants from their accounts prior to their termination of employment or their attainment of age 59½ unless the participant has incurred a hardship, as defined.

### **Expenses of the Plan**

Plan audit, fiduciary, and legal fees are paid by the Company. Certain administrative expenses and service fees are paid by the Plan to John Hancock Trust Company LLC (John Hancock), the trustee of the Plan. These payments are considered party-in-interest transactions, although not prohibited under ERISA.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with U.S generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

The Plan invests in the John Hancock Stable Value Fund (the Trust), which invests in certain John Hancock Group Annuity Contracts. This investment is stated at Net Asset Value (NAV), which is the amount participants would receive if they were to initiate permitted transactions under the Plan. Certain employer-initiated events may limit the Trust's ability to transact at NAV; however, such events are not probable to occur.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

### **Payment of Benefits**

Payments to participants are recorded when paid.

### **Subsequent Events**

Management has considered transactions or events occurring through October 15, 2025, which is the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

### **3. Fair Value Measurement**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

**Level 2:** Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued based on the market prices of the underlying assets.

*Common/collective trust:* Valued at the underlying NAV of units held by the Plan at year-end. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 4. **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### 6. **Tax Status**

The Plan was originally established, and all subsequent amendments have been made, under the provisions of the third-party administrator prototype plan. The Internal Revenue Service has determined and informed the third-party administrator by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 7. **Party-in-Interest Transactions**

In addition to the party-in-interest transactions previously disclosed, the Trust is managed by an affiliate of John Hancock and certain distributions are in the form of loans to the Plan's participants. These transactions are considered to be party-in-interest transactions, although not prohibited under ERISA.

### 8. **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
