### NOTE A – DESCRIPTION OF PLAN

The following description of B&R Industrial Automation Corporation (the Company) 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

1. **General**

The Plan is a defined contribution plan covering all employees of the Company who have completed one month of service and are age twenty-one or older, except those who are union or nonresident aliens as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

2. **Contributions**

Each year, participants may contribute up to the maximum amount allowable not to exceed the limits provided for by the Internal Revenue Service (IRS) Code. Participants may also contribute amounts representing distributions from other eligible retirement plans. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. The maximum catch-up contribution was \$7,500 for the four months ended April 30, 2024. The Company will make matching contributions equal to a discretionary percentage determined by the Company. Additional profit sharing contributions are discretionary and determined by the Company. The Company did not make any profit sharing contributions for the four months ended April 30, 2024. Participants may direct the investment of their employee and employer contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common/collective trust as investment options for the participants. Rollover contributions are accepted by the Plan.

3. **Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. **Vesting**

Participants are immediately vested in their deferral and employer matching and profit sharing contributions plus actual earnings thereon. A participant is 100 percent vested upon entering the plan.

5. **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the rate of 3.75 percent to 10.50 percent, which commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are repaid through payroll deductions.

**6. Forfeited Accounts**

There were no forfeited nonvested accounts at April 30, 2024. At December 31, 2023, forfeited nonvested accounts totaled \$1,098. Forfeitures may be used to reduce any employer contributions or to pay administrative expenses of the Plan. For the four months ended April 30, 2024, forfeitures were not used to reduce employer contributions or pay administrative expenses.

**7. Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over their life expectancy. The dollar threshold of \$5,000 is used in determining if a lump sum distribution will be made to participants who have vested account balances. For termination of services for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Hardship withdrawals shall be allowed in accordance with provisions of the Plan.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements are as follows:

**1. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

**2. Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**3. Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of April 30, 2024 and December 31, 2023.

**4. Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**5. Administration of Plan Assets**

Retirement Plan Administrators, LLC is designated as the third-party administrator for the Plan.

**6. Payment of Benefits**

Benefits are recorded when paid.

**7. Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. The expenses charged to the Plan may be charged pro rata to each participant in relation to the size of each participant's account balance or may be charged equally to each participant. In addition, some types of expenses may be charged only to some participants based upon their use of a Plan feature or receipt of a Plan distribution or loan.

**8. Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

**NOTE C – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2024 and December 31, 2023.

*Common/Collective Trust* – Valued by the fund’s trustee based on the fair value of underlying securities within the fund, which represent net asset value (NAV) of shares held by the Plan at year-end.

*Mutual funds* – Valued at net asset value (NAV) of shares held by the Plan at year-end.

**NOTE D – PLAN TERMINATION**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

Effective April 1, 2024, the Plan was merged with and into the ABB Inc. Retirement Savings Plan, which shall be the surviving plan. See Note J for discussion of the merged plan.

**NOTE E – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan invests in shares of mutual funds and a common/collective trust managed by Empower Retirement, LLC. Empower Retirement, LLC is the trustee and recordkeeper for the Plan. Therefore, these transactions qualify as party-in-interest transactions.

Certain other administrative expenses of the Plan are absorbed by the Plan's sponsor; therefore, these administrative expenses are not fully reflected in these financial statements.

**NOTE F – TAX STATUS**

The Plan has adopted the volume submitter 401(k) profit sharing plan with CODA from the Retirement Plan Administrators, LLC. The IRS has determined and informed Retirement Plan Administrators, LLC by letter dated March 31, 2014 that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS and Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE H – INFORMATION CERTIFIED BY TRUSTEE**

The following is a summary of the Plan's financial information, as of April 30, 2024 and December 31, 2023, and for the four months ended April 30, 2024, that is included in the financial statements based on information certified by Empower Retirement, LLC as complete and accurate in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA):


