INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the Manhattan West LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTES TO FINANCIAL STATEMENTS AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the Manhattan West LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s information.

General—The Plan is a defined contribution plan covering eligible employees of Manhattan West LLC (the “Company”). The Board of Managers of the Company has appointed the Manhattan West LLC 401(k) Plan Administrative Committee to control and manage the operation and administration of the Plan. Reliance Trust Company serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

As a result of a change in ownership of the Company, the Plan was established on January 1, 2022, and eligible participant account balances and notes receivable from participants were transferred into the Plan from the Bloomberg L.P. 401(k) Plan.

Contributions—Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) matching contributions made by the Company, and (iii) participant rollovers from another qualified plan. Participants have the option to make Roth elective salary reduction contributions to the Plan.

Participants may elect to contribute a percentage of their compensation to the Plan each year, subject to the limitations defined in the Plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions; catch-up contributions are ineligible for a Company matching contribution. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

The Company makes a matching contribution to each participant’s account equal to 50% of the amount of the participant’s salary reduction contribution, up to 15% of eligible compensation as defined by the Plan. The maximum matching contribution is equal to \$7,750.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans which represent rollovers into the Plan.

Participant Accounts—Individual accounts are maintained for each participant of the Plan. Each participant’s account is credited with the participant’s contribution and related matching Company contributions and Plan earnings. Participant accounts are also charged with withdrawals, Plan losses, and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Eligibility—There are no age or minimum service requirement for employees to participate and make contributions to the Plan. There is no service requirement for the Company matching contributions.

Union employees, nonresident aliens, leased employees, and employees who are contingent, piecework or any other basis other than salaried are excluded from participating in the Plan.

Investments—Participants may direct the investment of their contributions, Company matching contributions, and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily.

Vesting—Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company’s matching contribution portion of their accounts is based on years of credited service. For vesting purposes, certain eligible participants that transferred into the Plan retain their service hours from their previous employer. A participant is 100% vested after three years of credited service.

Notes Receivable from Participants—Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of one-half of the vested account balance or \$50,000. The loans are secured by an assignment of a participant’s vested interest in the Plan and bear an interest rate equal to the prime rate, as published, plus 1% at the time funds are borrowed. Principal and interest are paid ratably through payroll deductions or as a lump sum for the outstanding loan balance. Loan terms range from 1 to 5 years; however, terms may exceed 5 years for the purchase of a primary residence. As of December 31, 2024 and 2023, participant loans have maturities through 2054 and 2028, respectively, at interest rates ranging from 4.25% to 9.50%.

Payment of Benefits—On termination of service with the Company (including termination of service due to death, disability, or retirement), a participant whose account balance exceeds \$5,000 may generally elect to receive either a lump-sum distribution equal to the value of the participant’s vested interest in his or her account or annual installments. If a participant balance is less than \$5,000, a lump-sum distribution to the participant or an automatic rollover, will be made as soon as administratively feasible.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships or an in-service distribution upon age 59 1/2.

Forfeited Accounts—When certain terminations of participation in the Plan occur, the nonvested portion of the participant’s account, as defined by the Plan, represents a forfeiture. The Plan document permits the use of forfeitures to either reduce future Company matching contributions or pay Plan administrative expenses for the plan year. However, if a participant is reemployed and fulfills certain requirements, as defined in the Plan document, the account will be reinstated. The total of forfeited nonvested accounts was \$10 as of December 31, 2024 and 2023. During 2024, Company matching contributions were reduced by \$34,712 from forfeited nonvested accounts.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition—The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions—Employee contributions and Company matching contributions are recorded when withheld or earned, respectively.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Administrative Expenses—Administrative expenses of the Plan are paid by the Plan sponsor. Participants pay administrative costs for loans, distributions, and qualified domestic relation orders.

Plan expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investment.

Payment of Benefits—Benefit payments to participants are recorded upon distribution. There were no participants, who elected to withdraw from the Plan, but had not yet been paid at December 31, 2024 or 2023.

3. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedules, that was prepared by or derived from information prepared by Reliance Trust Company, the trustee of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustee that such information is complete and accurate.

4. FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

Registered Investment Companies ("RICs")—Valued at the daily closing price as reported by the fund. RICs held by the Plan are open-ended RICs that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The RICs held by the Plan are deemed to be actively traded.

Stable Value Fund—A collective trust fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value ("NAV") per unit of the collective trust. The NAV value is used as a practical expedient to estimate fair value. This practical expedient would not be

used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to confirm that securities liquidations will be carried out in an orderly business.

6. RELATED-PARTY TRANSACTIONS AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Plan transacts with certain parties who may perform services for the Plan, including the Company and its employees. These transactions qualify as exempt party-in-interest transactions. The Plan also issues loans to participants, which are secured by the vested balances in the participants' accounts.

7. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

8. FEDERAL INCOME TAX STATUS

The Plan uses a prototype plan document sponsored by ADP, LLC. ADP, LLC received an opinion letter from the Internal Revenue Service (IRS), dated October 6, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

9. NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Company remitted the January 1, 2022, participant contributions of \$163,153 and loan repayments of \$6,475 to the trustee on January 14, 2022, which was later than required by Department of Labor (DOL) Regulation 2510.3 102. The Company filed Form 5330 with the IRS in April 2024 and paid the required excise tax on the transaction. In addition, participant accounts were credited with lost earnings in May 2024.

10. SUBSEQUENT EVENTS

Subsequent events were evaluated through October 14, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, participants may elect to make after-tax voluntary employee contributions of up to 90% of eligible compensation. Company matching contributions will also apply to these after-tax voluntary contributions. Effective January 1, 2025, there will be a change in the Plan's trustee. ADP Retirement Trust Services, LLC will be appointed as the new trustee, replacing Reliance Trust Company. No other such events occurred that require additional disclosures in or adjustments to the Plan's financial statements.
