## INDEPENDENT AUDITORS' REPORT

The Plan Administrator  
Orleans Community Health Retirement Savings 403(b) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Orleans Community Health Retirement Savings 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a period of one year after the date the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.



## Notes to Financial Statements

---

### 1. Description of Plan:

The following description of Orleans Community Health Retirement Savings 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### A. General:

The Plan is a 403(b) defined contribution plan covering essentially all employees of Orleans Community Health (Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### B. Contributions:

Employees may defer a percentage of compensation to the Plan, subject to Internal Revenue Code limitations. There are no service or age requirements for participant eligibility. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan was amended in 2024, concurrent with the termination of the Orleans Community Health Pension Plan (see below). The amendment allows for employer discretionary contributions as a percentage of an employee's annual salary beginning July 2024, provided the employee has worked at least 500 hours during the period July 1, 2024 through December 31, 2024 (1,000 hours annually thereafter) and is an active employee on December 31<sup>st</sup>. For the year ended December 31, 2024, the discretionary contribution was 3% of the employee's qualified compensation earned from July 1, 2024 through December 31, 2024.

On August 1, 2024, the Plan Sponsor terminated the Orleans Community Health Pension Plan. All participants in the Orleans Community Health Pension Plan became 100% vested in that plan upon termination and were provided the option to have their account balance rolled into the Plan or an individual retirement arrangement (IRA), or receive a lump sum distribution. Approximately \$4,660,000 was rolled into the Plan during the year ended December 31, 2024, and is included in rollovers on the statement of changes in net assets available for benefits.

### C. Participant Accounts:

Each participant's account is credited with an allocation of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### D. Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants are fully vested after the completion of 3 years of service.

### E. Investment Options:

A participant may direct contributions into a variety of mutual funds and similar accounts offered by Lincoln Financial Group Trust Company, Inc. (Lincoln Financial Group), Lincoln Life and Annuity Company of New York (Lincoln Life and Annuity Company), and Newport Trust Company (an affiliate of Vanguard Fiduciary Trust Company).

### F. Participant Notes Receivable:

Participants may borrow from their fund accounts amounts equal to the lesser of \$50,000 or 50% of their account balance. Note terms range from one to five years (except certain residential loans which can extend up to fifteen years). The notes are secured by the balance in the participant's account and bear interest at the prevailing commercial rate for notes of similar types at date of issuance. Principal and interest is paid ratably.

### G. Payment of Benefits:

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or defer the commencement of benefits until normal retirement age. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

## **2. Summary of Significant Accounting Policies:**

### **Basis of Accounting:**

The financial statements of the Plan are prepared under the accrual method of accounting.

### **Payment of Benefits:**

Benefits are recorded when paid.

### **Investment Valuation and Income Recognition:**

The Plan's mutual fund investments are stated at fair value based on quoted prices in active markets. The fully benefit responsive investment contracts are stated at contract value as described below.

The Plan maintains benefit-responsive investment contracts (Lincoln NY Fixed Annuity and Lincoln NY Stable Value Account), which are stated at contract value. Contract value, as reported to the Plan by Lincoln Financial Group and Lincoln Life and Annuity Company without further adjustment, represents contributions made, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Lincoln Financial Group and Lincoln Life and Annuity may not terminate the contracts at any amount less than contract value and is contractually obligated to pay the principal and specified guaranteed interest rates. The minimum guaranteed interest rate under the contracts is 1.0%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code, (2) complete or partial termination of the Plan, (3) any change in law, regulation, or administrative ruling applicable to the Plan that could have a material adverse effect on a portfolio's cash flow, (4) any communication given to participants not to invest in a portfolio or to transfer assets out of a portfolio. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Unrealized appreciation or depreciation on investments is charged or credited to the net assets of the Plan.

### **Participant Notes Receivable:**

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon terms of the plan document.

### **Use of Estimates:**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

### **Subsequent Events:**

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 13, 2025 (the date the financial statements were available to be issued).

### **Tax Status:**

The Plan Administrator believes the Plan was designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, no provision has been made for income taxes.

## **3. Financial Information Certified by Lincoln Financial Group and Lincoln Life and Annuity Company:**

The following information included in the accompanying financial statements and supplemental schedule of assets held for investment purposes as of December 31, 2024 and 2023 and for the year ended December 31, 2024 was obtained from data that has been prepared and certified to as complete and accurate by Lincoln Financial Group and Lincoln Life and Annuity Company, custodians of the Plan.

Statements of Net Assets Available for Benefits – Investments and participant notes receivable, except 2024 and 2023 Vanguard mutual fund investments held by Newport Trust Company.

Statement of Changes in Net Assets Available for Benefits – Net appreciation in fair value of investments, interest and dividends, and interest on participant notes receivable, except appreciation in fair value of investments of \$156,878, and interest and dividends of \$71,961 on Vanguard mutual fund investments held by Newport Trust Company.

Schedule of Assets Held for Investment Purposes – all items and amounts except Vanguard mutual fund investments held by Newport Trust Company.

#### **4. Plan Termination:**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **5. Administrative Expenses:**

At the discretion of the Plan Administrator, the majority of administrative expenses have been borne by the Plan Sponsor.

#### **6. Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
