We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with DOL’s Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1—Description of the Plan**

The following description of the Ideal Deals, LLC 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

*General* – The Plan is a defined contribution profit sharing plan established on January 1, 2015 and restated on July 1, 2021 by Ideal Deals, LLC (the “Company” or “Employer” or “Plan Sponsor”) covering substantially all members and full-time employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Administrative Committee, appointed by the Company, has the responsibility for administration of the Plan. The assets of the Plan are held by John Hancock Life Insurance Company (the “Trustee”).

*Eligibility* – All employees excluding collective bargaining (union) employees and Non-Resident Alien employees as defined by the Plan of the Employer are eligible to participate in the Plan on the first day of the calendar month, coincident with or next following the date after attaining age of 21 years and completion of 30 days of service.

*Contributions* – The Plan allows for employee contributions under Section 401(k) of the Internal Revenue Code (“IRC”). Employees can contribute up to 100% of eligible compensation, not to exceed IRC limits, which is \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also elect to defer Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation. The Company contributes 100% of the first 3% of deferred compensation plus 50% of the next 2% up to 5% of eligible compensation that a participant contributes to the plan as a safe harbor matching contribution. In addition, the Plan allows for a discretionary nonelective contribution by the Employer. Participants must be employed on the last day of the Plan year to receive their allocated share of the nonelective contribution. For the year ended December 31, 2024, the Plan did not elect to provide a discretionary nonelective contribution.

*Participant Accounts* – Each participant’s account is credited with participant contributions and Employer matching, if applicable, and Plan earnings and charged with payment of benefits and an allocation of Plan losses, and expenses based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Investment Options* – Participants may direct their accounts into various mutual funds and a money market fund that have been provided as investment options.

*Vesting* – Participants are immediately vested in their salary deferral contributions, rollover contributions, and employer safe harbor matching contributions, plus actual earnings (losses) thereon. A participant also becomes 100% vested upon death, becoming disabled, or reaching retirement age, as defined by the Plan. The employer discretionary nonelective contribution vests according to the following schedule which assumes a minimum of 1,000 hours of service to constitute a year for vesting purposes:

**Note 1—Description of the Plan (continued)**

*Notes Receivable from Participants* – Participants may borrow from their accounts a minimum of \$1,000 up to the Internal Revenue Service (“IRS”) maximum loan amount equal to the lesser of \$50,000 minus the difference between the highest outstanding balance of loans in the past 12 months and the outstanding balance of loans from the Plan on the date the loan is made or 50% of their vested account balance. Participants may have up to two loans outstanding at one time and the notes are secured by the balance in the participant’s account. The notes bear fixed interest rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Loan terms range from 1 to 5 years or up to 10 years for the purchase of a primary residence.

*Payment of Benefits* – Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum distribution or installment payments equal to the value of the participant’s vested account balance. If the participant’s vested balance does not exceed \$5,000, the Plan requires a lump-sum distribution. Upon termination of service for other reasons, distribution of the value of the participant’s vested interest in his or her account will begin as soon as possible after the participant’s request. Withdrawals prior to attaining age 59½ are not permitted, except in the event of disability. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½.

*Forfeitures* – Amounts forfeited from a participant’s account shall be used to restore forfeitures, reduce Company contributions, or to pay reasonable Plan expenses. There was no forfeiture balance as of December 31, 2024 and 2023.

**Note 2—Summary of significant accounting policies**

*Basis of Presentation* – The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could vary from the estimates that were used.

*Notes Receivable from Participants* – Notes receivable from participants is measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan is reduced, and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

*Investment Valuation and Income Recognition* – The Plan’s investments are stated at fair value. The net appreciation in the fair value of investments, as reflected in the statement of changes in net assets available for benefits, consists of the gains and losses of those investments.

Purchases and sales of securities are recorded on a trade-date basis. Unrealized gains and losses are recognized in the period in which they occur. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

*Administrative Expenses* – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

*Payment of Benefits* – Benefit payments to participants are recorded upon distribution.

*Risks and Uncertainties* – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the financial statements.

*Fair Value Measurements* – U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

U.S. GAAP describes three levels of inputs that may be used to measure fair value:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

*Mutual Funds* – These investments are public investment vehicles valued using NAV provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

*Money Market Fund* – This investment is a public investment vehicle valued using NAV provided by the administrator of the fund. The underlying assets are generally comprised of short-term securities representing high quality, liquid debt, and monetary assets. The qualified institution establishes the market and quotes the price, on a daily basis, that is available to market participants, which is a market approach to valuation. The money market fund is classified within Level 2 of the valuation hierarchy.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 3—Information certified by the qualified institution (unaudited)**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company, the qualified institution, has certified the following data included in the accompanying financial statements and supplemental schedule as complete and accurate:

- Investments at fair value, non-interest bearing cash, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 (Audited) and 2023 (Compiled).
- Net appreciation in fair value of investments and interest income on notes receivable as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i, as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note 5—Party-in-interest transactions**

Certain Plan investments are held by John Hancock Life Insurance Company, the qualified institution, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. However, these transactions are exempt from the prohibited transaction rules under ERISA. Notes receivable from participants also qualify as party-in-interest transactions. Fees paid to parties-in-interest totaled \$13,258 for the year ended December 31, 2024.

**Note 6—Plan termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become fully vested in their accounts and the accounts shall be distributed to the participants or their beneficiaries under the terms of the Plan document.

**Note 7—Tax status**

The Company has adopted a non-standardized form for a pre-approved plan sponsored by the qualified institution. The IRS informed the pre-approved plan by a letter dated June 30, 2020, that the pre-approved plan and related trust constitutes a qualified plan and trust under the applicable sections of the IRC. The pre-approved plan has been amended since receiving the opinion letter. However, the Plan Sponsor believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and, therefore, the Plan and related trust continue to be tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 (Audited) and 2023 (Compiled), there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8—Prohibited transactions**

During the year ended December 31, 2024, the Plan failed to remit in a timely manner certain participant contributions from its assets within the required time period as specified by DOL Reg 2510.3012. Failure to segregate and remit contributions within the specified time period is a prohibited transaction according to the provisions of ERISA and the IRC.

**Note 9—Subsequent events**

The Plan has evaluated subsequent events through October 15, 2024 in connection with the preparation of these financial statements, which is the date the financial statements were available to be issued.


