Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Great Bay Distributors, Inc. Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of changes in net assets available for benefits for the year ended December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Notes to Financial Statements

December 31, 2024 and 2023

(1) **Description of Plan**

The following description of the Great Bay Distributors, Inc. Profit Sharing Plan (the “Plan”), is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

(a) **General**

The Plan is a defined contribution plan covering all employees of Great Bay Distributors, Inc. (the “Company”) who have completed at least one year of service and are at least 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. Effective January 1, 2023 the plan added an additional requirement of 1000 hours of service must be met within the one year of service requirement previously adopted.

The Plan is administered and investments are directed by a committee consisting of employees appointed by the Company’s Board of Directors. The Plan has a trust agreement with a financial institution to maintain the Plan’s investments.

(b) **Contributions and Funding Policy**

All employees of the Company who have completed at least one year of employment, 1,000 hours of service, and have attained the age of eighteen are eligible to participate. The Plan provides for entry dates on the first day of the 1st and 7th month of the Plan year with the satisfaction of the entry requirements. An employee must also be employed with the employer on the last day of the plan year to receive a company contribution.

The Company makes a contribution to the Plan at the discretion of the Company’s Board of Directors. For the year ended December 31, 2024, the Company’s Board of Directors elected to make a profit-sharing contribution of \$500,000 to eligible employees. The Company contributions are allocated to participants using a safe harbor points system based on years of service and participant earnings.

The Plan also accepts rollovers and direct transfers from other tax-qualified plans.

(c) **Participant Accounts**

Each participant’s account is credited with an allocation of the Company’s contribution and plan earnings thereon. Allocations are based on participant earnings and years of service or account balances, as defined. Forfeited balances of terminated participants’ non-vested accounts are reallocated to remaining participants based on participant earnings and years of service. There were no forfeitures reallocated for the year ended December 31, 2024. There were no remaining forfeiture balances at December 31, 2024 or December 31, 2023.

Participants do not have ability to direct their own investments in the Plan, which includes contributions and allocations of plan earnings thereon.

(d) Vesting

Participants become vested in Company contributions in accordance with the following schedule:

Less than 2 years of service	0%
More than 2 years, but less than 3 years	20%
More than 3 years, but less than 4 years	40%
More than 4 years, but less than 5 years	60%
More than 5 years, but less than 6 years	80%
6 years or more	100%

Participants also become fully vested upon reaching their normal retirement age (age 65), early retirement age, death, or retirement due to disability.

(e) Payment of Benefits

Upon termination of service or upon death, disability, or retirement from the Company, a participant receives an amount equal to the value of his or her vested account balance in either a lump sum or regular installment payments. Benefits are recorded when paid.

The Plan does not allow for hardship distributions or in-service distributions.

(f) Participant Loans

The Plan does not allow for participant loans.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting and present the net assets available for benefits and changes in net assets available for benefits.

(b) Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The shares of registered investment companies are valued at quoted market prices. Corporate bonds are based on the shares purchased multiplied by the exchange rate or local market price. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

(2) Summary of Significant Accounting Policies - Continued

(c) Contributions

Profit sharing contributions from the Company are recorded in the year in which participant compensation is earned.

(d) Administrative Expenses

Administrative expenses are paid by the Company.

(e) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates that affect the amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Risks and Uncertainties

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate or market and credit risk.

(g) Payment of Benefits

Benefits payments are recorded when paid.

(3) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

(4) Information Certified by the Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Northern Trust Company ("Northern Trust"), the trustee, has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate:

- Investments at fair value;
- Net investment income;
- Schedule of assets (held at end of year);
- Reportable transactions, as shown in the supplemental schedule.

(4) **Information Certified by the Trustee - Continued**

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

(5) **Income Tax Status**

The Plan has adopted a pre-approved plan document, which has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the adopted plan document is qualified under Section 401(a) of the Internal Revenue Code, and therefore, that the related trust is exempt from taxation.

Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code to maintain its qualification. The Plan has been amended however the plan administrator and the Plan's tax counsel believe the Plan is being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) **Party-in-Interest Transactions**

The Plan invests in investment accounts managed by Northern Trust. Northern Trust acts as investment trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions. The Plan paid Northern Trust approximately \$28,000 in administrative fees during 2024.

(7) **Fair Value Measurements**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

(7) Fair Value Measurements - Continued

The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- (a) Quoted prices for similar assets or liabilities in active markets;
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- (c) Inputs other than quoted prices that are observable for the asset or liability;
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Registered Investment Companies

Fair value is based on quoted market prices in an exchange or active market which represents the net asset values of shares held by the Plan at year-end.

Corporate Bonds

Fair value is based on the shares purchased multiplied by the exchange rate or local market price. Rates are readily available, however are not considered an active market, therefore are classified as Level 2 investments.
