## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator  
Caddo Community Action Agency, Inc. 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Caddo Community Action Agency, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Caddo Community Action Agency, Inc. 401(k) Plan Notes to the Financial Statements**

### **Note 1: DESCRIPTION OF PLAN**

The following description of the Caddo Community Action Agency, Inc. 401(k) Plan (“the Plan”) provides only general information. Refer to the Plan documents for a more complete description of Plan provisions.

#### ***General***

The Plan is a defined contribution plan covering eligible employees of Caddo Community Action Agency, Inc. (the “Company”, “Sponsor”, “Employer”, or “Plan Administrator”). The Plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Company’s Board of Directors is responsible for oversight of the Plan. The Plan’s Investment Committee (Investment Committee) determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Company’s Board of Directors.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Principal Life Insurance Company, the trustee and the qualified institution for the Plan, which invests contributions and Plan earnings, makes investment transactions as directed by the Plan participants and provides certain recordkeeping services. Principal Life Insurance Company also acts as the third-party administrator for the plan, which performs certain plan-administration and annual ERISA compliance testing.

#### ***Eligibility***

Employees may become a participant of the Plan when they have reached three months of service and are age eighteen or older. An employee will enter the Plan on the next quarterly entry date after all entry requirements have been met.

#### ***Contributions***

Each year, participants may contribute up to 100% of the participant’s eligible compensation, as defined by the Plan, subject to certain limitations under the IRC. Plan participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an enrollment provision whereby all newly eligible employees are enrolled in the Plan at a 0% deferral rate upon meeting eligibility requirements. The Company may provide a discretionary contribution to each participant set by the Company prior to the end of each plan year.

## Caddo Community Action Agency, Inc. 401(k) Plan Notes to the Financial Statements

### Note 1: DESCRIPTION OF PLAN (Continued)

#### *Contributions (Continued)*

The discretionary contribution provided by the Company was 2% of participants' eligible wages for 2024 and 2023. During the years ended December 31, 2024 and 2023, the Company made discretionary contributions of \$204,641 and \$186,085, respectively.

#### *Qualified Non-Elective Contributions (QNEC)*

The Plan recorded QNEC during the years ended December 31, 2024 and 2023 totaling \$4,036 and \$8,385, respectively, to provide for certain participants who were not given the opportunity to contribute their elected amounts due to certain administrative errors. The QNEC is immediately 100% vested to the employees. The contributions were made in accordance with IRS regulations and do not affect the tax status of the Plan and are reflected as other contributions on the statements of changes in net assets available for benefits.

#### *Participant Accounts*

Individual accounts are maintained for each of the Plan's participants to reflect the participants' contributions and employer discretionary contributions, as well as the participants' share of the Plan's investment earnings and losses, and appreciation (depreciation) in the value of investments and any related administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are fully vested in their contributions and the earnings thereon. Vesting in employer discretionary contributions and the earnings thereon is based on years of continuous service. A participant vests according to the following schedule:

0%	vesting after	1 year of service
20%	vesting after	2 years of service
40%	vesting after	3 years of service
60%	vesting after	4 years of service
80%	vesting after	5 years of service
100%	vesting after	6 years of service

### **Note 1: DESCRIPTION OF PLAN (Continued)**

#### ***Notes Receivable from Participants***

A participant may borrow from his or her account, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Interest rates will be based on the rates available for similar loans from commercial lending institutions ranging from 5.25% to 10.50%. Principal and interest is paid ratably through payroll deductions. Participant notes receivable mature variably through 2029.

#### ***Benefit Payments***

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account. In addition, hardship distributions are permitted if certain criteria are met.

#### ***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$485, respectively. Forfeitures are first used toward Plan expenses, then to reduce employer discretionary contributions. During the years ended December 31, 2024 and 2023, \$9,946 and \$24,396, respectively, were used to offset the Sponsor's portion of Plan expenses.

#### ***Hardship Withdrawals***

As permitted by the Internal Revenue Code (IRC) and in accordance with the plan agreement, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

### **Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

#### ***Use of Estimates***

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

#### ***Investment Valuation and Income Recognition***

Investments generally are reported at fair value, but may also be reported at contract value or net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements and NAV. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Note Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### ***Excess Contribution Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were excess contributions payable of \$0 and \$5,269 as of December 31, 2024 and 2023, respectively.

#### ***Payment of Benefits***

Distributions to participants are recorded when paid.

#### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

## **Caddo Community Action Agency, Inc. 401(k) Plan Notes to the Financial Statements**

### **Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

#### ***Subsequent Events***

Management has evaluated subsequent events through the date that the financial statements were available to be issued, October 14, 2025, and determined there were events that occurred that require disclosure. See Note 10 for relevant disclosure.

### **Note 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION**

The Plan Administrator has elected the method compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company, the qualified institution.

- a) Total investments, at fair value, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b) Investment income information (including net appreciation in value of investments) included in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- c) All amounts included in Note 4, Fair Value Measurements.
- d) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024.

### **Note 4: FAIR VALUE MEASUREMENTS**

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
  - observable; or
  - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts invested in mutual funds:* Valued based on Net Asset Value (NAV) per share as a practical expedient as reported by the fund manager based on the market value of the underlying investments. The underlying investments consist of equity and debt mutual funds. Accordingly, these NAV based investments have been excluded from the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

### **Note 5: TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020 stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). [Although, the Plan has been amended since adopting the pre-approved plan document,] The [the] plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Principal Life Insurance Company. Principal Life Insurance Company is the trustee and record-keeper as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.

The Plan and the Plan Sponsor share administrative expenses based on an agreed-upon allocation. During the 2024 and 2023 Plan years, the Plan was responsible for 80% of total administrative costs, and the Plan Sponsor was responsible for the remaining 20%. For the years ended December 31, 2024 and 2023, the Plan paid administrative fees to Principal totaling \$54,893 and \$48,222, respectively.

As discussed in Note 1, forfeitures are used to offset the Plan Sponsor's share of administrative expenses charged to the Plan. Any remaining administrative expenses are absorbed directly by the Plan Sponsor and are not reflected in these financial statements.

### **Note 7: PLAN COMPLIANCE**

During the year ended December 31, 2023, certain participants were not given the opportunity to participate in the Plan upon reaching eligibility in accordance with the Plan adoption agreement. Management has fully corrected these missed opportunities through the Self-Correction Program. Corrections were not significant to the financial statements.

### **Note 8: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 10: SUBSEQUENT EVENTS**

Management of the Plan evaluated all events or transactions that occurred after December 31, 2024 through October 14, 2025, the date the Plan's financial statements were available to be issued. The following items occurred.

Effective February 2, 2025 Plan Management engaged Momenta Inc. as a Third Party Administrator for the plan and adopted a new Plan Document, which was effective January 1, 2025.

Effective June 16, 2025, Plan Management terminated the services of Principal Life Insurance Company as Third-Party Administrator, Trustee, and Recordkeeper. Effective April 10, 2025, Plan Management engaged Empower Trust Company, LLC as Custodian, Empower Retirement, LLC as Recordkeeper, and Empower Advisory Group, LLC as Investment Advisor and Manager. Substantially all of the assets were transferred to Empower on June 17, 2025 excluding immaterial funds held in real estate pooled separate accounts, which will be transferred at a later date, in accordance with Plan agreements.
