### **1. Description of Plan**

The following description of George Sink, P.A. Injury Lawyers 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of George Sink, P.A. Injury Lawyers (the "Company") who are not represented by a collective bargaining agreement, leased employees or nonresident aliens who do not receive any United States source earned income. The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Plan assets are held and managed by Fidelity Management Trust Company (Fidelity), the trustee and qualified institution for the Plan, which invests contributions and Plan earnings, makes investment transactions as directed by Plan management and provides certain recordkeeping services. FuturePlans acts as the third-party administrator for the Plan and performs certain plan administration functions and annual ERISA compliance testing.

#### **Eligibility**

All employees who have completed one year of service and have obtained the age of twenty-one years old are eligible to participate in the Plan. Employees may enroll in the Plan on the first day of each calendar quarter following satisfaction of the eligibility requirements.

#### **Contributions**

Each year, participants may contribute up to 100% of their eligible compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company matches 100% of the first 3% and 50% of the next 2% of base compensation that a participant contributes to the Plan. In addition, for participants who are employed on the last day of the Plan year, the Company may make a discretionary, additional matching contribution to participants up to 4% of eligible compensation. For the year ended December 31, 2024, the Company elected to make an additional contribution to retroactively true-up all participants to a 3% match based on annual compensation. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Investment Options**

Upon enrollment in the Plan, a participant may direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common collective trust fund as investment options for participants. Participants may change their investment options as often as permitted under the investment vehicles chosen by the participant.

### **Vesting**

Participants are immediately vested in their elective deferral contributions and qualified employer contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions plus actual earnings thereon is based on years of credited service. A participant vests according to the following schedule:

### **Notes Receivable from Participants**

A participant may borrow up to the lesser of \$50,000 or 50% of the vested portion of his/her account balance, repayable within five years (unless the proceeds are used to purchase the participant's principal residence), bearing interest at a reasonable rate of interest as determined by the Plan Administrator. The loan interest rate is equal to the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions. Interest rates on outstanding loans at December 31, 2024 ranged from 4.25% to 9.5%.

### **Payment of Benefits**

Upon retirement, death, disability or termination of employment, participants may receive a lump sum amount equal to the value of his or her vested balance. Upon a participant's retirement, death, disability or termination of employment, the Company may elect to automatically distribute vested balances less than \$5,000. In the event the Company elects to do so, vested balances between \$1,000 and \$5,000 are rolled over to an individual retirement account on behalf of the participant, unless they elect a lump sum distribution, and vested account balances less than \$1,000 are distributed in a lump sum.

### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$11,707, respectively. During the year ended December 31, 2024, forfeitures of approximately \$12,361 were used to reduce employer contributions.

### **Hardship Withdrawals**

As permitted by the Internal Revenue Code (IRC) and in accordance with the plan agreement, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less. Hardship withdrawals are available to participants who have participated in the Plan for at least 180 months.

## **2. Summary of Significant Account Policies**

### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

### **Change in Presentation of 2023 Financial Statements**

The 2023 financial statements have been modified to conform to the 2024 financial statement presentation. These reclassifications had no effect on the reported net assets available for benefits.

### Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

### New Accounting Pronouncements

On December 29, 2022, the SECURE 2.0 Act of 2022 was signed into law. This act contains provisions that go into effect at various times starting in the 2023 year and ending in 2033. The deadline for adopting any required plan amendments pursuant to the SECURE 2.0 Act is December 31, 2026; however, plans must be operated in accordance with the effect date of each new provision. Management has reviewed the provisions effective for the 2024 year and continues to monitor and adjust operations in accordance with provisions as they become effective. As of December 31, 2024, no formal Plan amendments have been made to adopt SECURE 2.0 Act provisions. Management has determined that the Plan was in compliance with all applicable provisions for the year ended December 31, 2024.

### **4. Fair Value Measurements**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

### Basis of Fair Value Measurement

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Common Collective Trust Funds

The Plan holds an investment in a common collective trust fund (the "Fidelity Managed Income Portfolio Class 1" or "MIP"). The investment in the MIP is considered fully-benefit responsive and is presented at contract value, which reflects the NAV of the fund. The NAV of the MIP is based on the fair value of the underlying securities which the Plan transacts within the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

A participant's ownership of the MIP is represented by units. Units are issued and redeemed daily at the MIP's constant NAV of \$1.00 per unit. Although it is the policy of the MIP to use its best efforts to maintain a stable NAV of \$1.00 per unit, there is no guarantee that the MIP will be able to maintain that value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The MIP imposes certain restrictions on the Plan. The following employer-initiated events may limit the MIP's ability to transact at NAV:

- The Plan's failure to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.
- Any communication given to Plan participants designed to influence participants to transfer assets out of the MIP or not to invest in the MIP.
- Any change in law, regulation, or administrative ruling applicable to the Plan that could have a material adverse effect on the MIP's cash flow.
- The establishment of a defined contribution plan that competes with the Plan for employee contributions.
- Complete or partial termination of the Plan or its merger with another plan.

- Any substantive modifications of the MIP or the administration of the MIP that is not consented to by the wrap issuer.
- Any change in law, regulation, or administrative ruling applicable to a plan that could have a material adverse effect on the MIP's cash flow.

The MIP is unlikely to maintain a stable NAV if, for any reason, it cannot obtain or maintain wrap contracts covering all of its underlying assets that are not otherwise invested in money market funds. In the event that an issuer or a wrap contract fails to perform as intended, the MIP's NAV may decline if the market value of its assets declines. Plan management believes the occurrence of events and circumstances that would cause the MIP to transact at less than NAV is not probable.

### 6. Related Party Transactions and Party-in-Interest Transactions

The Company performs certain administrative functions for the Plan for which no fees are charged. Additionally, the Company pays directly any administrative fees not paid from Plan assets.

Certain Plan investments are shares of mutual funds and a common collective trust fund managed by Fidelity Management Trust Company (Fidelity). Fidelity is the custodian and third-party plan administrator as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. The Plan entered into an agreement with Fidelity for which Fidelity would charge the Plan for recordkeeping services performed. These fees would be offset by credits for mutual fund fees paid directly to Fidelity by various mutual funds. Mutual fund fees received by Fidelity in excess of the negotiated fee arrangement for record keeping services will be refunded to the Plan and used to pay investment advisory expenses incurred by the Plan.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to discontinue its contributions at any time and to terminate the Plan, subject to Plan provisions and ERISA. In the event of Plan termination, participants will become 100% vested in the company contributions portion of their account.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the individual participant account statements and the Statement of Net Assets Available for Benefits.

### 9. Income Tax Status

The Plan has adopted a volume submitter 401(k)/profit sharing plan offered by Fidelity. The prototype plan obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the plan is qualified and tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the notes to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject income tax examinations for years prior to 2021.

### 10. Reconciliation of Form 5500 to Financial Statements

The Form 5500 is prepared on the cash basis of accounting and does not include accruals for contributions receivable at year end that are reflected within the financial statements.
