- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Rochester Management, Inc. Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Rochester Management, Inc. Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution plan established to provide retirement benefits for substantially all employees of Rochester Management, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company is the sponsor and the administrator of the Plan. Empower Trust Company, LLC (Empower) serves as the custodian and trustee of the Plan and also provides recordkeeping and administrative services for the Plan.

Eligibility

Employees become eligible to participate in the Plan after attainment of age 21 and completion of six months of service as defined in the Plan document. Participation commences on the first day of the quarter coinciding with, or next following, attainment of eligibility requirements.

Contributions

Participants may make voluntary pre-tax and Roth contributions in the form of salary reductions based on a percentage of their annual compensation, subject to certain limitations of the Plan and the Internal Revenue Code (IRC). Upon attainment of age 50, participants are allowed to make catch-up contributions. The Company makes matching contributions on behalf of the Plan's participants. The Company matches 100% of employee contributions on the first 2% of their eligible compensation, 50% of employee contributions on the next 1% of their eligible compensation, and 25% of employee contributions on the next 2% of their eligible compensation, for a maximum of 3% of eligible compensation. Participants with ten or more years of service, if deferring at least 5% of eligible compensation, will receive an additional 1% match.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Employees enrolled as a result of this provision must defer 2% of their compensation to the Plan, unless they affirmatively elect not to participate. Participants can change their contribution amount at any time.

Additionally, the Company may make discretionary profit-sharing contributions as determined by its Board of Directors. Employees must be credited with 1,000 hours of service during a Plan year and be employed on the last day of the Plan year to be eligible to receive discretionary profit-sharing contributions. There were no discretionary profit-sharing contributions made in 2024 or 2023.

Participant Accounts

Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan.

1. DESCRIPTION OF PLAN (Continued)

Participant Accounts (Continued)

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions (b) actual earnings/losses thereon and (c) charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant compensation or account balances, as defined. Plan expenses are allocated based on participant account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their elective deferrals, rollover contributions, and any earnings (losses) thereon. Company matching and discretionary profit-sharing contributions become 100% vested after three years of service. Participants are considered to have completed one year of service for vesting purposes upon completion of 1,000 hours of service at any time during the plan year.

Forfeitures

Forfeitures of non-vested account balances are used to offset Plan expenses or reduce Company contributions. The Company did not apply any forfeitures to reduce Company contributions or offset Plan expenses during the years ended December 31, 2024 and 2023. At December 31, 2024 and 2023, forfeited non-vested account balances available to offset future Plan expenses or Company contributions totaled \$11,978 and \$6,932, respectively.

Notes Receivable from Participants

Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Notes receivable are payable over a period not to exceed 5 years, except when used to acquire a principal residence. The notes receivable are secured by the remaining vested account balance and bear interest at 1% above the prime rate at the time of loan issuance, which remains fixed for the duration of the loan. Principal and interest are paid ratably through biweekly payroll deductions over the term of the loan. Participants may have two loans outstanding at any time.

Benefit Payments

Upon termination of service due to death, disability, or retirement, participants receive a distribution of their vested account balances. Participants may elect disbursement of their vested account balance in either a lump-sum amount, in installments, or direct rollover into an individual retirement account or another qualified plan. The normal retirement age is the date a participant reaches the age of 65. Actively employed participants that have reached the age of 59 ½ may elect to receive in-service distributions.

Hardship Withdrawals

Hardship withdrawals are permitted from the Plan from the participant's pre-tax and Roth elective deferral accounts. All hardship withdrawals must comply with rules related to hardships, which are uniformly applicable to all participants.

Administrative Expenses

The Plan's administrative expenses are paid by both the Plan and the Company.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, each participant's account will become fully vested.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Investments and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Fair Value Measurements

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board Accounting Standards Codification 820 (ASC 820) establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available.

The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

A description of where the Plan's investments fall within the hierarchy is presented in Note 4.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Benefit paid to participants are recorded when paid.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying financial statements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Mutual funds: valued at fair value based on quoted market prices in active markets.

4. FAIR VALUE MEASUREMENTS (Continued)

Fixed annuity contract: valued based on observable inputs of existing contracts and readily available financial information of the issuing financial institutions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

Empower served as the custodian and trustee of the Plan's investment assets for the years ended December 31, 2024 and 2023. As such, transactions between the custodian and the Plan qualify as party-in-interest transactions. Additionally, Plan assets consist of notes receivable from participants, which qualify as party-in-interest transactions.

6. TAX STATUS

The Plan adopted a pre-approved plan offered by Empower Retirement LLC. The pre-approved plan received an IRS Opinion Letter dated November 14, 2022, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RECONCILIATION TO FORM 5500

Certain classifications may differ between the financial statements and Form 5500. Net assets available for benefits agree between the financial statements and the Form 5500 as of and for the year ended December 31, 2024.
