Independent auditors' report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Select Security Retirement Option of Indiana Hospital, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Select Security Retirement Option of Indiana Hospital's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for opinion

Management is responsible for the preparation and fair presentation of these financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Select Security Retirement Option of Indiana Hospital's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's responsibilities for the audit of the financial statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements of Select Security Retirement Option of Indiana Hospital (the Plan) have been prepared in conformity with U.S. generally accepted accounting principles as applied to pension trusts. A summary of significant accounting policies follows.

Method of accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Investments

In compliance with the Plan document, the Plan assets are invested in either shares of registered investment companies or interest-bearing cash accounts. Investments are reported at their fair market values except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates

The preparation of financial statements, in conformity with U.S. generally accepted accounting principles, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of Plan additions and deductions during the reporting period. Actual results could differ from those estimates.

Subsequent events

Management has evaluated subsequent events through October 14, 2025, the date financial statements were available to be issued.

2. DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of Indiana Regional Medical Center (the Company) who are not members of the Operating Engineers Union. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan incorporates a cash or deferred salary reduction arrangement under Internal Revenue Code (IRC) Section 403(b) and is intended to comply with all requirements for Section 401(a) tax qualified plans.

Contributions - Participants may contribute up to the maximum percentage allowable of their pretax annual compensation into the Plan, not to exceed a dollar limit which is set by law. Participants are also allowed to make after-tax Roth contributions. The Company may make matching contributions up to a maximum of 4% of compensation and an additional contribution based on age and years of service, with a maximum of 5%. For the years ended December 31, 2024 and 2023, the Plan had \$1,684,986 and \$1,627,360, respectively of matching contributions and discretionary contributions of \$1,888,013 and \$1,866,328 during 2024 and 2023, respectively. The Plan was amended June 1, 2017. The amendment creates a new discretionary matching contribution level for employees hired or rehired after June 1, 2017, who are non-collective bargained registered nurses belonging to Indiana Registered Nurses Association. This new matching level is to be referred to as Tier 2 and the existing matching contribution referred to as Tier 1. The Tier 2 employer matching contribution is 50% of the employee's contribution up to 6% of compensation. The amendment also allows for the participation of physicians and eliminates employer nonelective contributions.

2. DESCRIPTION OF THE PLAN (CONTINUED)

Participant accounts - Each participant account is credited with the participant's contributions, the Company's matching contributions and allocations of the Company's discretionary contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined.

Vesting - Participants are immediately 100% vested in their account balances.

Loans to participants - Participants may borrow from their fund accounts in amounts no less than \$1,000. The loans are secured by the balance in the participant's account and bear interest at rates comparable to rates charged by local banks. Principal and interest is paid ratably through monthly payroll deductions, except for loans prior to 2007, participants made quarterly payments on their own. Participants are allowed no more than two outstanding loans.

Payment of benefits - On termination of service, the participant may receive distributions equal to the value of the participant's vested accounts as a lump sum in cash.

Investment administration - The Plan has engaged the services of Metropolitan Life Insurance Company, Transamerica Life Insurance Company, Brighthouse Financial and State Street Bank and Trust as trustees to provide investing, administration, and accounting services for the Plan.

Forfeitures - Participants are immediately 100% vested in their account balances, therefore there are no forfeitures.

3. INVESTMENTS

All investment information disclosed in the accompanying financial statements and supplemental schedule in total and by fund, including investments held at December 31, 2024 and 2023, realized and unrealized appreciation (depreciation) in fair value of investments, net investment income for the years ended December 31, 2024 and 2023, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the trustees. Investment information certified by the trustees of the Plan has not been audited by independent auditors.

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value in the accompanying statement of net assets available for benefit. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Accounting standards for Fair Value Measurements, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Level 1 Fair Value Measurements

Valuations are based on quoted prices in active markets for identical assets or liabilities.

Level 2 Fair Value Measurements

Pooled separate accounts are valued at the net asset value of the shares held by the Plan at year end and are classified in Level 2 of the fair value hierarchy. These funds are considered open-end mutual funds, meaning that the fund is ready to redeem its shares at any time and offers its shares for sale to the public, either through retail outlets or through institutional investors continuously. For institutional funds, net asset values are received daily from fund managers, and the managers stand ready to transact at these quoted amounts.

Level 3 Fair Value Measurements

Valuations are based on unobservable inputs (assumptions based on the best information available) that are significant to the fair value of the assets or liabilities.

Funds held in insurance company general accounts

The Plan has entered into a traditional fully benefit-responsive strategic annuity contract with Metropolitan Life and Brighthouse Life Insurance Company. The strategic value annuity contracts are credited an interest rate, which varies with each deposit. There is no specific formula used to credit interest rates, and the interest rates are not tied to the performance of a set of assets. The interest rates are credited based upon a number of factors, including, but not limited to, the level of net investment income that the Plan can earn on its newly purchased general account assets, the absolute level of interest rates, the shape of the yield curve, how interest rates have moved since the inception of the contract, the minimum guaranteed interest rate, and interest rate on alternative investments. The contract has a minimum guaranteed interest rate of 1.5%. The contract includes a market value adjustment formula in the event of contract termination. The actual market value adjustment would be calculated upon receipt of a request for contract termination. Plan participants have the option of receiving contract value upon separation of service, retirement, minimum distribution, annuitization, death, and transfer to other investment options. If the contract holder were to request a liquidation, a five-year payout option is also available.

The plan has entered into a fully benefit-responsive annuity contract with Transamerica Life Insurance Company which is credited an interest rate that varies with each deposit. The plan also entered into a guaranteed investment option with Transamerica Life Insurance Company. The guaranteed investment option under the plan, is provided under a group annuity contract issued by Transamerica Life Insurance Company. The contract is a traditional investment contract (guaranteed investment contract), and it does not have a maturity date. The contract value equals deposits made to the guaranteed investment option, plus interest credited under the terms of the contract, less any withdrawals.

The average yield for the Plan for the years ended December 31, 2024 and 2023, was 1.5%.

4. INCOME TAX STATUS

The Company received a ruling from the Internal Revenue Service that the Plan is a qualified plan under IRC Section 401(a); that the trust is exempt for taxation under IRC Section 501(a); and that the Company’s contributions are tax deductible to the extent permitted under IRC Section 404. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its tax-exempt status. The Plan has been amended since receiving the ruling from the Internal Revenue Service. However, the plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. TRANSACTIONS WITH PARTIES-IN-INTEREST

Indiana Regional Medical Center provides certain administrative and accounting services to the Plan at no cost and also pays the cost of the services provided to the Plan by the Plan's independent auditors and trustees. The cost of such services was approximately \$9,900 and \$9,200 for the years ended December 31, 2024 and 2023, respectively. The Plan also has investments with the trustees totaling \$29,666,519 and \$30,632,473 for the years ended December 31, 2024 and 2023, respectively.
