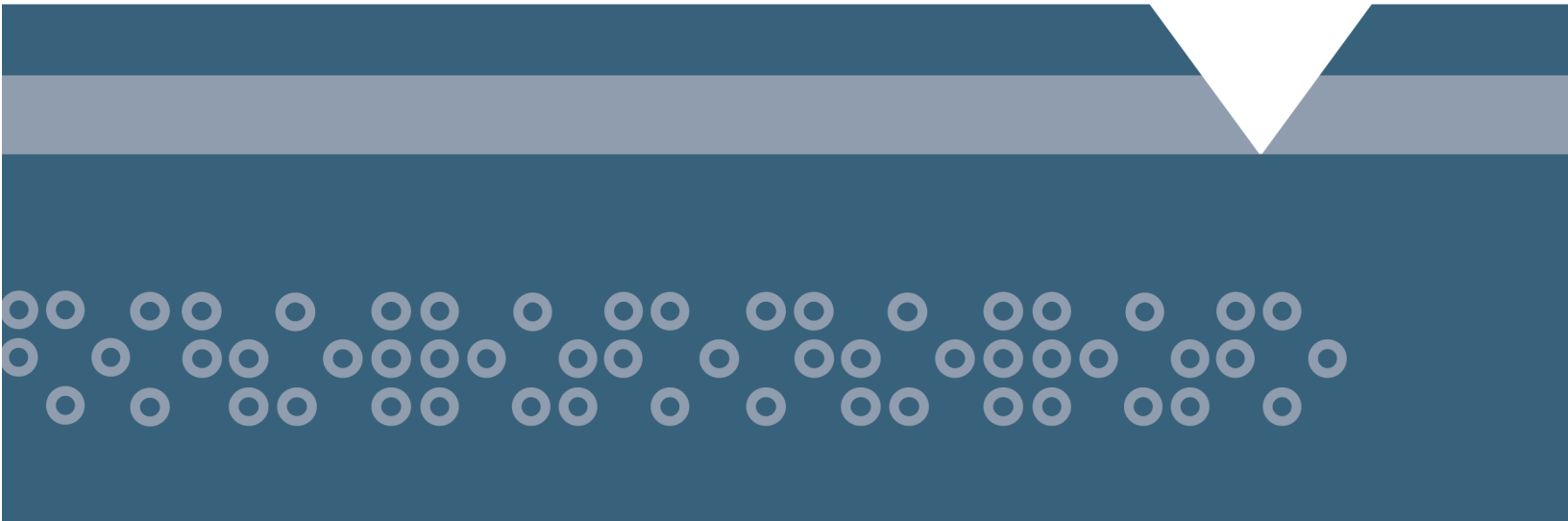

Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the financial statements of Builders Supply Company, Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise of the statement of net assets (liquidation basis) as of December 31, 2024 and the statement of net assets available for benefits as of December 31, 2023, and the related statement of changes in net assets available for benefits (liquidation basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan by a bank, or similar institution, or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

We have audited the accompanying financial statements of Builders Supply Company, Inc. Profit Sharing Plan (the Plan), which comprise the statement of net assets (liquidation basis) as of December 31, 2024, and the related statement of changes in net available for benefits (liquidation basis) for the year then ended, and the related notes to the financial statements. In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Emphasis of Matter — Change in Basis of Accounting

As discussed in Note 1 to the financial statements, the Plan Sponsor, Builders Supply Company, Inc., approved the termination of the Plan in 2024 in connection with the sale of the Company's operations. As a result, the Plan adopted the liquidation basis of accounting as of October 2024. The financial statements as of and for the year ended December 31, 2024, have been prepared on that basis of accounting, which differs from the going-concern basis used in prior year. Our opinion is not modified with respect to this matter.

Prior-Year Financial Statements Audited by Other Auditors

The financial statements of the Plan as of December 31, 2023, were audited by other auditors, whose report dated December 6, 2024, expressed an unmodified opinion on those statements.

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Builders Supply Company, Inc., Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. This includes the adoption and application of the liquidation basis of accounting as of October 2024. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether conditions exist that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued, except when liquidation is imminent and the liquidation basis of accounting is applied.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and

to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Other Matters

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing

procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of Plan

The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General. The Plan is a defined contribution plan covering substantially all full-time employees of the plan sponsor who have three months of service and are age 21 or older as determined by the provisions of the plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

(b) Contributions. Each year, participants may elect to defer up to 100% of pre-tax or after-tax annual compensation, as defined in the Plan document. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). In addition, the Company matches up to 3% of the participant pre-tax and after-tax contributions, as defined by the Plan. There was no profit-sharing contribution for the years ended December 31, 2024 and 2023.

(c) Participant Accounts. Each participant's account is credited with the employee's voluntary contribution, plus the corresponding employer matching contributions, and an allocation of Plan earnings or losses, which are allocated proportionately among all participants based upon their investment in each fund. Participant accounts are also assessed contractually established fees for certain participant-initiated transactions such as distributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting. Participants are immediately vested in their employee contributions and employer matching contributions, plus actual earnings thereon. Discretionary profit-sharing contributions made by the Plan sponsor, plus actual earnings thereon, is as follows:

0 - 1 year	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

Participants are fully vested in all discretionary profit-sharing contributions made prior to January 1, 2022. Participants became 100% vested in discretionary profit-sharing contributions effective October 2024, when the Plan was terminated.

(e) Payment of Benefits. On termination of service due to death, disability, retirement, or separation from service, a participant may elect to receive either a lump-sum or installment payments in an amount equal to the value of the participant's vested interest in his or her account. Hardship withdrawals are permitted by the Plan if the participant can demonstrate financial hardship as defined in the Plan document. In service withdrawals are also permitted for participants who have attained the age of 59 ½.

(f) Forfeitures. Forfeited nonvested accounts may be used to reduce future Company contributions. Since forfeitures are only applicable to discretionary profit-sharing contributions beginning January 1, 2022, and there were no discretionary profit-sharing contributions during the years ended December 31, 2024 or 2023, there was no forfeiture activity during the year ended December 31, 2024.

(g) Plan Termination. In October 2024, the Plan sponsor, Builders Supply Company, Inc., was acquired by Texas Materials Group, Inc. In connection with the acquisition, the Plan Administrator approved the termination of the Plan, effective October 31, 2024.

As of December 31, 2024, the Plan had begun liquidating its assets and distributing benefits to participants. All remaining assets were distributed to participants by February 2025, and the Plan was fully liquidated.

Accordingly, the accompanying financial statements have been prepared using the liquidation basis of accounting in accordance with Accounting Standards Codification (“ASC”) 205-30, Presentation of Financial Statements—Liquidation Basis of Accounting.

2. Significant Accounting Policies

(a) Basis of Accounting. Under the liquidation basis of accounting, the Plan’s assets are carried at their estimated net realizable value, which represents the amount expected to be collected during liquidation. Liabilities include estimated amounts required to settle the Plan’s obligations as of the reporting date, including costs directly associated with the termination and liquidation of the Plan.

(b) Investment Valuation and Income Recognition. Investments are reported at fair value. Because the Plan is in liquidation, unrealized gains or losses are reflected in the statement of changes in net assets in liquidation. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and shares of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments purchased and sold as well as held during the year.

(c) Use of Estimates. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial. Actual results could differ from those estimates.

(d) Payment of Benefits. Benefits are recorded when paid.

(e) Administrative Expenses. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in the net appreciation in fair value of investments.

(f) Risks and Uncertainties. The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and

that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

3. Information Certified by the Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2024 and 2023, and investment income for the year ended December 31, 2024, that is disclosed in the accompanying financial statements, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Ascensus Trust Company, the trustee of the Plan.

4. Fair Value Measurements

FASB ASC Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. See Note 2 for more information.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market: Funds intend to keep a constant \$1 net asset value (NAV) and are valued using the amortized cost method.

The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

5. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by Ascensus LLC. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC") and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

6. Participant-Directed Investments

The Plan provides that contributions to the Plan will be invested in certain individual investments as directed by each participant.

7. Related Parties and Parties-in-interest

The Plan Sponsor is party to an agreement with Ascensus. Under this agreement, these parties provide investment management services to the Plan. These transactions qualify as party-in-interest transactions.

8. Subsequent Events

Management has evaluated subsequent events through the date the financial statements were available to be issued and determined that no events, other than those described in the “Plan Termination” note above, require adjustment to or additional disclosure in these financial statements. Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
