## Independent Auditor's Report

To the Trustees and Participants of  
California Association of Golf and Private Clubs Welfare Benefit Trust:

### Opinion

We have audited the financial statements of California Association of Golf and Private Clubs Welfare Benefit Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits as of December 31, 2024 and 2023 and the changes in net assets available for benefits for the years then ended, of California Association of Golf and Private Clubs Welfare Benefit Trust in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ## Notes to Financial Statements

### December 31, 2024 and 2023

#### 1. Summary of Accounting Policies

##### **Basis of Accounting**

The financial statements of California Association of Golf and Private Clubs Welfare Benefit Trust (the "Plan") are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

##### **Cash**

Cash consists of monies held in a money market savings account and a checking account.

##### **Member Contributions Receivable**

Contributions due and not paid prior to year-end are recorded as contributions receivable. Allowance for uncollectible accounts is considered unnecessary and is not provided.

##### **Member Contributions**

Contributions consist of monies received monthly from member organizations consisting of private country clubs or private clubs participating in the Plan. Contributions are based on rates agreed upon between the Plan and the member organizations.

##### **Participant Contributions**

Contributions consist of monies received monthly from employees of member organizations that are recognized as of the end of the month in which they are due.

##### **Benefit Obligations**

Premiums payables are estimated based on participant eligibility earned as a result of work performed by participants through December 31 and paid by the Plan subsequent to year-end. The Plan has no obligation to provide benefits to retirees; therefore, postretirement benefit obligations are not recorded on the financial statements.

##### **Administrative Fees**

Fees are included within contribution rates paid by member organizations and their qualifying employees into the Plan. These expenses include costs incurred to operate the Plan.

##### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

##### **Risks and Uncertainties**

Estimates made by management in preparation of the financial statements can possibly change, which can have a material effect to the disclosure in the financial statements.

#### 2. Description of Plan

The Plan was established on May 1, 2015, under an agreement and declaration of trust to provide welfare benefits for eligible employees and their dependents. Participants covered under the Plan include employees of member organizations that have executed a participation agreement with the Plan. Participating member organizations are golf and private clubs, and their employees are involved with the maintenance of the respective clubs. The Plan qualifies as a multiple-employer welfare arrangement. Prior to the creation of the Plan, the Plan's sponsor had monies left over from another nonqualified plan, which was rolled into the Plan as sponsor contributions in 2015. Administrative fees for the Plan are built into the contribution rate. These fees are separated upon receipt and used to pay administrative fees of the Plan.

The Plan provides HMO insurance plan coverage through Kaiser, and all other benefits are provided through Anthem Blue Cross, including HMO insurance plan coverage, dental, employee assistance program, long- and short-term disability insurance, vision, and life and accidental death and dismemberment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

## **Notes to Financial Statements**

### **December 31, 2024 and 2023**

Participating member organizations set the eligibility requirements and benefit options for their employees within parameters established by the Plan. Contribution rates are agreed upon between member organizations and the Plan based on type of coverage. For medical coverage, the rates are also dependent on location.

Continuation of health care benefits to participants who would otherwise lose those benefits due to certain events, as mandated by the Consolidated Omnibus Budget Reconciliation Act ("COBRA"), applies to all member organizations and their employees within the Plan.

Participants should refer to the Summary Plan Description for more complete information.

### **3. Priorities Upon Termination**

It is the intent of the trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the trustees. In the event of termination, the trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

### **4. Federal Income Tax**

The Plan is a multiple-employer welfare arrangement and is a taxable trust required to pay taxes as they become due. For the years ended December 31, 2024 and 2023, the Plan incurred approximately \$7,421 and \$7,416, respectively, in taxes. The Plan is an ERISA trust and is also required to file an annual information return with the Department of Labor.

U.S. GAAP requires management to evaluate the tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. Management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **5. Funding Policy**

The Plan is financed by member organizations' contributions and from participants electing COBRA coverage. The monthly contribution rate, including the rate for COBRA coverage, is determined by the coverage type selected by the participant in his or her participation agreement.

### **6. Concentrations of Credit Risk**

The Plan maintains one account at one financial institution, which is insured by the Federal Deposit Insurance Corporation ("FDIC"). At times, the Plan's cash at the financial institution may exceed the FDIC limit. As of December 31, 2024 and 2023, there were \$1,202,481 and \$0, respectively, in excess of the FDIC limit. Any loss incurred or a lack of access to such funds could have a significant adverse impact on the Plan's financial condition, results of operations, and cash flows.

### **7. Subsequent Events**

In preparing these financial statements, management of the Plan has evaluated events and transactions that occurred after December 31, 2024, for potential recognition or disclosure in the financial statements. These events and transactions were evaluated through October 13, 2025, the date that the financial statements were available to be issued, and no items have come to the attention of management that require recognition or disclosure.
