## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the North Memorial Health Care 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from the qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## NOTES TO FINANCIAL STATEMENTS

### 1. DESCRIPTION OF THE PLAN

The following description of the North Memorial Health Care 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**General**—The Plan is a qualified defined contribution profit-sharing plan with elective deferral and employer-matching features. Generally, all eligible employees may enter the Plan on the first day of the month following the date on which the employee has completed 30 days of service. North Memorial Health Care (the “Company”), as Plan administrator, controls and manages the operation and administration of the Plan. The Plan was amended since establishment to allow certain union employees to participate.

The Blaze Health 401(k) Plan merged into the North Memorial Health Care 401(k) Plan effective as of January 1, 2024. Plan amendments were signed on December 20, 2023 to merge the two plans. Administratively, Blaze Health 401(k) Plan assets were transferred to the North Memorial Health Care 401(k) Plan on December 29, 2023, the last business day in 2023, in order to have the assets available to participants in the North Memorial Health Care 401(k) Plan on January 3, 2024, the first business day in 2024.

**Contributions**—Effective January 1, 2012, the Plan adopted certain Safe Harbor provisions. Under the Safe Harbor provisions, the Company matches 100% of certain employee contributions on the first 3% of covered compensation and 50% of the contributions from 3% to 5% of covered compensation, subject to certain Internal Revenue Code (IRC) limitations, as defined in the Plan adoption agreement. The union contract determines the amount of matching contributions for contract employees who participate in the Plan.

The Plan includes discretionary 401(k) contributions made by the Company, subject to approval by the Board of Directors. These contributions are calculated as a percentage of each employee’s annual earnings. As of December 31, 2024, the Company accrued \$2,872 for distribution in 2025.

**Participant Accounts**—Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the Company’s contribution and Plan earnings and charged with withdrawals and an allocation of Plan losses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Payment of Benefits**—Upon termination, death, or disability, participants may elect to receive benefits in the form of a lump-sum distribution, installment payments, or a direct rollover to an individual retirement account or another qualified employee benefit plan. However, if the participant’s vested account balance does not exceed \$5,000, it will automatically be distributed in accordance with the provisions of the Plan.

**Investments**—Participants may direct the investment of their account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily.

**Vesting**—Participants are vested immediately in their contributions plus earnings (losses) thereon. Participants become vested immediately in both their contributions and in the Company’s Safe Harbor matching contributions and earnings for all contributions made after January 1, 2021. Non-Safe Harbor Company matching contributions are vested according to a five-year graded vesting schedule. Participants are vested 10%, 30%, 50%, 70%, and 100%, respectively, at the end of each year of the five years of vesting service. A five-year graded vesting schedule applies to any employer (nonelective) discretionary contribution made to eligible participant accounts.

**Forfeited Accounts**—When certain terminations of participation in the Plan occur, the nonvested portion of the participant’s account, as defined by the Plan, represents a forfeiture. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$299 and \$193, respectively. These accounts will be used to reduce future employer contributions. During the year ended December 31, 2024, \$84 of forfeited amounts were used to reduce employer contributions.

**Plan Termination**—Although it has not expressed any intent to terminate the Plan, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, all of the assets of the Plan will be used to provide benefits according to the Plan. Upon termination of the Plan, a participant’s employer contributions account shall be fully vested.

**Administrative Expenses**—Administrative expenses of the Plan are paid by the Plan, as provided in the Plan document. Participants pay administrative costs for loans, distributions and qualified domestic relation orders. All investment management and transaction fees directly related to the Plan investments are paid by the participants and charged against the Plan’s earnings.

**Notes Receivable from Participants**—Participants may borrow from their individual accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years, but may extend past five years, to a maximum of 10 years, if the loan proceeds are used for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates range from 4.27% to 10.50% as of December 31, 2024, with maturity dates through 2034. Principal and interest are paid ratably through payroll deductions. Participant loans are limited to 401(k) contribution and rollover contribution accounts.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting**—The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties**—The Plan utilizes various investment instruments, including mutual funds and investment contracts. Investment securities, in general, are exposed to various risks, such as interest rate, credit risk, and overall market volatility. Due to the level of risk associated with certain investment

securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**Investment Valuation and Income Recognition**—The Plan’s investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Personal choice retirement account funds are composed of mutual funds, which are valued based on quoted market prices in an active market, and cash and cash equivalents. Common collective trust funds are stated at net asset value (NAV) practical expedient by the issuer of the fund based on the fair value of the underlying investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Notes Receivable from Participants**—Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

**Payable to Blaze Health 401(k) Plan**—The Plan’s payable to the Blaze Health 401(k) Plan is measured at the fair value of the plan assets transferred from the Blaze Health 401(k) Plan to the Plan on December 29, 2023. As the merger described in Note 1 was not effective until January 1, 2024, those assets represent a liability to the Blaze Health 401(k) Plan at December 31, 2023.

**Payment of Benefits**—Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid, as of December 31, 2024 and 2023.

**Excess Contributions Payable**—The Plan is required to return contributions received during the Plan year in excess of the IRC limits.

**Contributions**—Employee contributions and the Company matching contributions are recorded when withheld. Employer discretionary contributions are recorded when earned.

**Subsequent Events**—Subsequent events were evaluated through October 14, 2025, the date the financial statements were available to be issued.

### 3. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by Empower Trust Company LLC in 2023 and 2024, the trustee of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certification from the trustee that such information is complete and accurate.

### 4. FAIR VALUE OF FINANCIAL INSTRUMENTS

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value by creating a hierarchy for observable independent market inputs and unobservable market assumptions and expands disclosures about fair value measurements. The Plan classifies its investments into Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market, but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**Valuation of Investments at Fair Value**—Mutual funds are valued at the closing price reported in the active market in which the individual security is traded. The personal choice retirement account holds mutual funds that are valued at the closing price reported in the active market in which the individual security is traded.

Common collective trust funds are reported at fair value using NAV as a practical expedient. This NAV represents the Plan's fair value since this is the NAV at which the Plan transacts with the fund. This practical expedient is not used when it is determined to be probable that the fund will sell underlying investments for an amount different than the reported NAV.

Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Plan has been amended since receiving the determination letter, however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of IRC and the Plan continues to be tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are notes receivable from participants. These transactions qualify as exempt party-in-interest transactions.
